#### **1. Description of Plan**

The following description of the Orthopedic Associates of SW Ohio Inc. Profit Sharing 401K Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan with a cash or deferred arrangement covering all employees of Orthopedic Associates of SW Ohio Inc. (the Company) who meet the eligibility requirements of age 21 or older and have completed one year of service (500 hours of service within one year). The Plan entry dates after eligibility requirements are met are January 1 and July 1. The Plan's original effective date is July 1, 2008 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

The Plan provides for contributions by participating employees of an amount of compensation (as defined in the Plan) on a pre-tax basis or after-tax basis (roth contributions) through payroll deductions. The contributions may not exceed the maximum amount permitted under the applicable provisions of the Internal Revenue Code of 1986, as amended (the Code). Participants who have attained age 50 before the end of the plan year may elect an additional catch-up contribution.

The Company is required to make safe harbor contributions in an amount not less than 3% of compensation. Safe harbor contributions totaled \$433,485 and \$426,044 during 2024 and 2023, respectively. The Company may also make discretionary profit sharing contributions to the Plan. Employees who were credited with 1,000 hours of service and were employed as of the last day of the plan year are eligible for the profit sharing contributions. Profit sharing contributions are first allocated to those participant's with excess compensation (defined in the Plan as the amount in which compensation exceeds the social security taxable wage base) at a rate of 5.7%, then to all eligible participants based on the ratio of their compensation to total eligible compensation. Profit sharing contributions totaled \$0 and \$1,154,827 during 2024 and 2023, respectively. In addition to the contributions described above, the Company may make additional qualified non-elective contributions for the benefit of such participants determined at the discretion of the Company. The Company did not make any discretionary non-elective contributions to the Plan during 2024 and 2023.

The Company funds employer contributions into a money market account held by the Plan throughout the year. Once all contributions are funded, the amounts are transferred to participant accounts where they can be invested at the participant's discretion. Unallocated assets totaled \$12,373 and \$8,535 as of December 31, 2024 and 2023, respectively.

##### Rollovers

The Plan permits participants to transfer distributions from other qualified plans into the Plan.

##### Vesting

Participants are 100% vested in the employee, Company, and rollover contribution portions of their accounts immediately upon their date of entry into the Plan.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and Company contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Hardship Withdrawals

The Plan allows for hardship withdrawals in the event of immediate and heavy financial need.

##### Payment of Benefits

The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions made and income earned on investments, net of expenses. Upon service or disability retirement, death, or termination, the participant or beneficiary will receive a lump-sum amount, or, if the account exceeds \$1,000, substantially equal annual or more frequent installments over a period not to exceed the joint life expectancy of the participant or beneficiary. The amount will be equal to the value of the fund allocated to the participant's account.

##### Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in various investment options offered by the Plan. Employer contributions follow the same investment options elected. Participants may change their investment options daily. The investment options are diversified in conformity with the ERISA diversification requirement.

#### **2. Summary of Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Payment of Benefits

Benefits are recorded when paid.

##### Payment of Expenses

All expenses of administration may be paid out of the trust fund unless paid by the Company. Such expenses shall include any expenses incident to the functioning of the administrator, including, but not limited to, fees of accountants, counsel, and other specialists and their agents, and other costs of administering the Plan. Until paid, the expenses shall constitute a liability of the trust fund. However, the Company may reimburse the trust fund for any administration expenses incurred. Any administration expenses paid to the trust fund as a reimbursement shall not be considered a Company contribution. The Company elected to pay some administration expenses incurred in 2024 and 2023.

##### Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the Plan Administrator and Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

## **2. Summary of Significant Accounting Policies (Continued)**

### Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3).

The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net investment gain (loss) from registered investment companies, which consists of realized gains or losses and unrealized appreciation (depreciation) on those investments. The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net investment gain (loss) from self-directed investments, which consists of interest, dividends, realized gains or losses and unrealized appreciation (depreciation) on these investments. Capital gain distributions are recorded as dividends. Purchases and sales of securities are reflected on a trade-date basis. Interest and dividends are recorded when earned.

## **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies the Plan used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies, including exchange-traded funds: Valued at the daily closing price as reported by the fund. Mutual funds and exchange-traded funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. Mutual funds and exchange-traded funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at cost which approximates fair value.

Self-directed investments consisting of the following:

- Common stocks, preferred stocks and real estate investment trusts: Valued at quoted market prices.
- Corporate bonds and government securities: Valued using yields currently available on comparable securities of issuers with similar credit ratings.

Certain information related to investments disclosed in the accompanying financial statements and supplementary schedule, including investments in registered investment companies in the amount of \$18,277,319 and \$15,437,914 at December 31, 2024 and 2023, respectively, and the related dividends in the amount of \$671,255 and \$393,424 during 2024 and 2023, respectively and net investment gain from registered investment companies in the amount of \$1,179,349 and \$1,710,665 during 2024 and 2023, respectively, were obtained or derived from unaudited information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC (a custodian of the Plan).

#### **6. Tax Status**

The Company adopted the CCH Incorporated (d/b/a ftwilliam.com) Basic Plan Document #P-01 Prototype under Adoption Agreement No. 001 dated January 1, 2021. CCH Incorporated (d/b/a ftwilliam.com) has received an opinion letter from the Internal Revenue Service (dated June 30, 2020) stating that employers who adopt the plan will be considered to have a plan qualified under section 401 of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Risks and Uncertainties**

The Plan invests in various investment options. These investment options are exposed to risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **8. Party-in-Interest Transactions**

The Plan invested in funds managed by Merrill Lynch, Pierce, Fenner & Smith. Merrill Lynch, Pierce, Fenner & Smith acts as custodian for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rule. Total advisory fees paid to Merrill Lynch, Pierce, Fenner & Smith were \$27,391 and \$22,740 during 2024 and 2023, respectively. The Plan also has various providers for advisory and recordkeeping services. The total administrative expenses paid to other parties in interest was \$221,908 and \$187,205 for the years ended December 31, 2024 and 2023, respectively.

#### **9. Subsequent Events**

Management evaluated the activity of the Plan through September 23, 2025 (the date the financial statements were available to be issued) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
