Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Rausch Coleman Homes Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rausch Coleman Homes Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Summary of Significant Plan Provisions

The following description of the Rausch Coleman Homes Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Rausch Coleman Development Group, Inc. (the “Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is administered by a committee, which serves as the Plan trustee. Minnesota Life Insurance Company (the Custodian) holds the Plan assets. Standard Insurance Company maintains the records of the participant data.

Effective October 18, 2022, the Standard acquired Securian Financial retirement plan recordkeeping business (the Securian). The Plan continued to operate on Securian’s platform until the end of the first quarter of 2024 the recordkeeping was transformed to the Standard.

- b. **Eligibility** – Employees, who are not a nonresident alien, collective bargained, intern, or leased employee, are eligible to participate in the Plan upon two months of service and attaining age 21. Plan entry dates are the first day of the month following the date the eligibility requirements are met. Participants are automatically enrolled into the Plan at 6%.
- c. **Contributions** – Participants may contribute through pre-tax and Roth deferrals, as well as rollover contributions. Participants can defer up to the limits set forth by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan allows a QACA safe-harbor matching contribution at 100% of participant contributions up to 5% of plan compensation. The contributions are made each pay period with a true up at the end of the year. The true up for 2024 net of forfeitures utilized is recorded as a receivable as of December 31, 2024, for \$64,014. Employer contributions are subject to certain limitations by the Internal Revenue Service.

The Plan allows the Employer to make discretionary matching contributions. During the year ended December 31, 2024, no employer matching contributions were made.

Additional amounts may be contributed by the Company under the Plan’s profit sharing contribution provisions at the discretion of the Company’s board of directors. During the year ended December 31, 2024, no profit-sharing contributions were made.

Participants direct the investment of their contributions into various investment options offered by the Plan.

- d. **Participant accounts** – Each participant’s account is credited with the participant’s contributions, employer matching contributions, and allocations of employer profit sharing contributions and Plan earnings. Participant accounts are reduced with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are fully vested in their own contributions, safe-harbor matching contributions, and fixed matching contributions plus actual earnings thereon. Employer discretionary matching and profit-sharing contributions shall be fully vested upon death, disability, or upon reaching normal retirement age of 65. If participants terminate employment for any other reason, they are entitled to the portion of discretionary contributions made by the Employer according to the following schedule:

The Plan allows for safe harbor QACA contributions to be fully vested upon 2 years of service.

- f. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested account balance or \$50,000. Note terms cannot exceed five years unless the note is for the purchase of a primary residence. The note is secured by the participant’s vested account balance and bears interest based on prime rate plus 1% on the date of origination. Principal and interest are paid directly to the provider from the participant.

- g. **Payment of benefits** – Upon retirement, termination of employment, or disability, a participant or beneficiary in the event of death, may elect to receive a payment of benefits in a lump sum amount equal to the value of the participant’s vested interest in his or her account. Additionally, a participant may receive an in-service withdrawal from any portion of their account upon the age of 65. If the participant’s account balance is equal to or less than \$5,000, the balance will be automatically distributed.

The Plan allows participant permissible withdrawal within 90 days of first automatic deferral.

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

- h. **Forfeitures** – The portion of a participant’s account to which they are not entitled, as a result of being less than fully vested, shall be forfeited by the participant upon distribution. Forfeitures shall be used to reinstate previously forfeited account balances of participants, to reduce employer contributions, or pay plan expenses. During the Plan year ended December 31, 2024, forfeitures of \$56,147 were used to pay administrative expenses and \$77,891 was used to reduce the 2023 employer contributions that were paid in 2024. The Plan had \$29,729 and \$77,891 in unallocated forfeitures as of December 31, 2024 and 2023, respectively. The \$29,729 was used to reduce the 2024 QACA safe-harbor true up contribution that were paid in 2025.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

- c. **Investment valuation and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Plan management determines the Plan’s valuation policies utilizing information provided by the Custodian. See Note 4 for discussion on fair value measurements and Note 6 for contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – The Plan allows certain administrative expense to be paid from Plan assets.

3. Investments Certified by the Plan’s Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the Custodian of the Plan as complete and accurate, and was not subject to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule of assets held:

- a. Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- b. Net appreciation in fair value of investments as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c. Interest and dividends from investments and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d. All the investment information included in the footnotes and supplemental schedule of assets held as of December 31, 2024.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There has been no changes in the methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: These investments are stated at fair value as determined by the issuer of the pooled separate accounts based on the fair market value of the underlying investments, which is valued at Net asset value (NAV) of units of the pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Fully Benefit-Responsive Investment Contracts

In 2020, the Plan entered a fully benefit responsive investment contract with Minnesota Life Insurance Company (Minnesota Life). Minnesota Life maintains the contributions in a general account. Minnesota Life is contractually obligated to repay the principal and a specific interest rate that was guaranteed to the Plan.

The investment contract is presented on the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus interest and transfers into the account, less participant withdrawals, administrative expenses, and transfers out of the account. Participants may direct the withdrawal or transfer out all or a portion of their investment at contract value to non-competing fixed funds, without redemption requirements.

The contract has no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The crediting rate will not be lower than 0.25% and is reviewed on a quarterly basis for resetting. As of December 31, 2024, the crediting rate was 2.66%.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer:

- Plan termination
- Discontinuance of the investment option

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value:

- The Plan is no longer deemed to be a qualified plan under the IRS.
- Plan termination
- Discontinuance of the investment option
- Amendments or modifications to the Plan documents
- Change in investment options to a competing fund

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Minnesota Life and that also would limit the ability of the Plan to transact at contract value with the Participants.

Minnesota Life does not allow transfers from the general account to any competing investment option. Also, transfers will not be allowed from any separate account to any competing investment option within 90 days following a transfer out of the general account.

7. Related Party and Party-in-Interest Transactions

Certain administrative expenses, totaling \$13,500, were paid by the Company on behalf of the Plan for the year ended December 31, 2024. The Company does not expect reimbursement from the Plan for these expenses. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

All the Plan's pooled separate and fully benefit-responsive investment contract accounts are issued by the current custodian. These transactions qualify as party-in-interest transactions under ERISA. Certain fees incurred by the Plan are included in net appreciation in fair value of investments. The Plan also made direct payments to service providers that are included in administrative expenses on the statement of changes in net assets available for benefits.

8. Tax Status

The Company adopted a Non-standardized Profit-Sharing prototype Plan (the "Prototype Plan") sponsored by Minnesota Life Insurance Company. The Internal Revenue Service has informed the Prototype Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Prototype Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "Code"). The Prototype Plan's opinion letter is being relied on by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

The Plan is invested in the Securian AM S&P 500 Index that has a concentration of 48% and 47% of total investments at fair value at December 31, 2024 and 2023, respectively.
