Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Koch Companies 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Koch Companies 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 PLAN DESCRIPTION

The following brief description of the Koch Companies 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan established effective February 28, 1994, and has been amended and restated throughout the years to comply with tax legislation. The Plan was last amended and restated effective June 21, 2024 to remove Koch Industries, Inc. as a participating employer, add Koch Nationlease, Inc. as a participating employer as well as changing the Plan Sponsor to Koch Services, Inc. All employees of Stan Koch & Sons Trucking Company (the Company) and Koch Industries, Inc., Distribution Centers of Minnesota, Inc., Hargol Corporation dba: United Trailer Leasing Company, Koch Maritime, JBS Logistics & Warehousing, Inc., and Lehigh Consumer Products, Inc. (Participating Employers) who have attained the age of 21 are eligible to participate in the Plan. An eligible employee will begin participation immediately following the completion of the eligibility requirements. The Plan excludes employees that are residents of Puerto Rico, covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations, leased employees, nonresident aliens with no income from a U.S. source, and independent contractors. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan administrator.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants may elect up to 60% of their eligible compensation as pre-tax or Roth 401(k) contributions to the Plan. The Plan allows participants age 50 and over to make catch-up contributions. The Plan also permits rollover contributions from other qualified plans. The Plan includes an auto enrollment feature, whereby all newly eligible employees will be automatically enrolled at a deferral rate of 4%, unless elected otherwise.

The Company may make a discretionary matching contribution to the Plan each year. During 2024, the Company made discretionary matching contributions to the Plan equal to 1% of each 4% of the participant's contributions up to a maximum 2% match. In addition, the Company may make a discretionary profit sharing contribution to the Plan. Profit sharing contributions are allocated pro rata based on eligible compensation to all eligible employees who are employed at the end of Plan year, unless termination is a result of death, disability, or retirement. There was no Company discretionary profit sharing contributions authorized for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant's Accounts

Each participant's account is credited with the participant's deferral contributions, the Company's matching contributions, the Company's discretionary profit sharing contribution, and investment earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. Participants direct the investment of contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance for purposes as defined in the Plan. Note transactions are treated as a transfer to (from) the investment fund (to) from the participant note. The notes are secured by the vested balance in the participant's account and bear interest at a reasonable rate of interest as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after the completion of five years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age (65), upon death, or upon permanent disability.

Benefit Payments

Upon termination of service, death, disability, or normal retirement, a participant may receive the value of vested interest in their account in the form of a lump-sum distribution. If a participant terminates employment and the participant's account balance was never greater than \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If a participant terminates employment and their account is greater than \$1,000 but less than \$5,000, and the participant does not elect payment in cash, the benefit will be rolled over into an individual retirement account. The Plan also allows for in-service withdrawals at age 59½ and for financial hardship, subject to Plan provisions.

Forfeited Accounts

Forfeitures of nonvested accounts are used to pay Plan expenses and to reduce Company contributions. There were no forfeitures used to pay Plan expenses for the year ended December 31, 2024. Forfeitures used to reduce Company contributions was \$242,429 for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeiture accounts totaled \$14,351 and \$137,519, respectively.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance will be deemed taxable to the participant. The note balance will be reduced and a benefit payment will be recorded at the time the participant incurs a distributable event.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of benefits paid, notes receivable from participants, and other administration are charged directly to the participant accounts and are included in the administrative expenses. Investment related expenses, including any revenue sharing credits, are included in the net appreciation of fair value investments.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the notes receivable from participants and all the investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related activity reflected in the statement of changes in net assets available for benefits for year ended December 31, 2024, and the supplemental schedule of assets held as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Collective Fund: Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 6 TAX STATUS

The volume submitter prototype plan has received an opinion letter dated June 30, 2020, from the IRS indicating that the volume submitter prototype plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under present income tax law. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Fidelity Management Trust Company, the trustee of the Plan, provides investment management and advisory services for the Plan. Therefore, these investment transactions qualify as party-in-interest transactions.
