Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of South Jersey Legal Services Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of South Jersey Legal Services Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about South Jersey Legal Services Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of assets held for investment is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

General

The following description of South Jersey Legal Services, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Eligibility

Each employee of South Jersey Legal Services, Inc. (the “Company”) becomes eligible to participate in the Plan after attaining age 18 and completing 6 months of service. Participation in the plan will begin once the employee has reached the Entry Date. Entry Date will be the first day of the Plan Year or the first day of the seventh month of the Plan Year coinciding with or next following date the employee satisfies the eligibility requirements.

Contributions

The Plan allows employees to defer salary either on a pre-tax or after-tax basis (called a Roth provision). Employees can become eligible once they have reached the age of 18 and have been employed by the employer for 6 months (exclusions may apply). Once eligible, the employee can enter the plan on the next entry date either January 1st or July 1st. The maximum allowable employee contribution is subject to IRS limitations.

The Company committed to a 4% safe-harbor contribution to all employees who are eligible. There is no hour requirement to continue receiving this safe harbor contribution once an employee has met the initial eligibility requirements. Effective January 1, 2024, safe-harbor contributions are immediately 100% vested

The Company may make a nonelective contribution addition to the safe harbor 4% contribution. This contribution is normally decided after the end of the Plan year. To be eligible for this discretionary contribution, an employee must satisfy the same requirements for safe harbor contribution. Allocation of the nonelective contribution is determined by the Company. The 2023 nonelective contribution was approximately \$987,000.

Participant Accounts

Each participant’s account is credited with their elective pre-tax contributions, allocations for any Company contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Benefits

In the event of termination for reasons other than death, disability or normal retirement, balances in participant accounts are payable in lump-sum. Benefits are recorded when paid.

Vesting

Participants are immediately vested in their contributions and safe harbor plus actual earnings.

In any event, a participant shall be 100% vested upon attaining normal retirement age (age 65), retirement due to disability, death and upon termination of the Plan.

Forfeitures

Forfeited nonvested accounts shall be applied to reduce the Employer's contribution at the end of the next Plan year during which the participant has received distribution of his or her vested interest. Forfeitures used by the employer to reduce the employer's contributions for the year ended December 31, 2024 and 2023 was \$0 and \$91,196, respectively. An increase in the forfeiture account during 2024 was a result of voiding old distribution checks that were never cashed in the amount of \$60,502. Forfeitures for the year ended December 31, 2023 were \$54,673. The forfeiture account balance as of December 31, 2024 and 2023 was \$61,529 and \$320, respectively.

Participant Loans

Loans are permitted in accordance with Plan Loan Policy, which can be obtained by contacting the Plan Administrator.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchase and sales of securities are recorded on a trade-date basis. Interest income is required on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative expenses

Administrative and Investment fees charged and deducted from the Plan assets totaled \$9,857 and \$9,927 for the year ended December 31, 2024 and 2023, respectively. Other administrative expenses incurred on behalf of the Plan including those expenses associated with accounting, legal, and other administrative services of the Plan are assumed by the Plan Sponsor.

Subsequent Event

Management has evaluated events and transactions occurring subsequent to December 31, 2024 for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate, amend, modify or suspend the Plan in whole or in part at any time subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

4. INVESTMENT CERTIFICATION

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the financial information included in the Plan financial statements, except for contributions receivable, contributions, and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by Capital Bank and Trust Company, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. An asset's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy under ASC 820 are as follows:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets.
- Level 2: Quoted prices in markets that are not active, or inputs that are observable either directly or indirectly, for substantially the full term of the asset.
- Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e. supported with little or no market activity).

The following is a description of the valuation methodologies used for instruments measured at fair value:

The mutual funds are stated at fair value as reported to the Plan by Capital Bank and Trust Company, based on the quoted market prices of the mutual funds ("Level 1").

(a) This class includes investment in common/collective trust that primarily invests in investment contracts and security backed contracts. The investment contracts are issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security-backed contract has similar characteristics to a traditional investment contract and is comprised of two parts: the first part is a fixed income security or portfolio of fixed income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. The Fund's investment objective is to maintain principal. The fair value of the investments in this class has been estimated using the net asset value per unit of the investments in the trust.

6. PARTY-IN-INTEREST TRANSACTIONS

The South Jersey Legal Services Inc. 401(k) Plan, the participants, and the Trustees have all been identified as related party transactions. The Plan invests in shares of mutual funds managed by the Trustees. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Participant loans also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA. Direct fees paid by the Plan for the investment record keeping and custodial services amounted to \$9,857 and \$9,927 for the year ended December 31, 2024 and 2023, respectively.

Fees paid during the year for legal, accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services and paid directly by the plan sponsor.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. TAX STATUS

The Plan, a prototype plan, received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating its acceptability under Section 401 of the Internal Revenue Code (the "Code"). The Plan has been amended since that date; however, the Company feels the Plan is being operated in compliance with the Code and that the Plan remains qualified and the related trust tax exempt.

8. RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

9. PLAN AMENDMENTS AND MODIFICATIONS

Effective January 1, 2024, the Plan was amended to make employer Safe-Harbor contributions immediately 100% vested.
