### Notes to Financial Statements December 31, 2024

#### (1) Description of Plan

The following brief description of the Inari Medical Inc. 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

##### *General*

The Plan is a defined contribution plan covering substantially all employees of Inari Medical, Inc. (the “Company”), except for residents of Puerto Rico hired after October 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s original effective date is January 1, 2017. On October 1, 2024, the Plan restated its plan document. There were no material changes to the terms of the Plan.

##### *Eligibility*

Employees are eligible to participate in the Plan after one month of service and when they are age twenty-one or older.

##### *Contributions*

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also make contributions to the Plan on an after-tax basis by designating deferrals as Roth deferrals. The Plan includes an automatic enrollment provision whereby, eligible employees automatically have 5% of their compensation withheld as an employee contribution unless they complete a salary reduction agreement and elect a different percentage or elect not to participate at all.

The Company will provide a dollar for dollar matching contribution up to 5% of the employee contributions, not to exceed \$15,000. Employer contributions are made each payroll period. After the end of the calendar year, a matching true up contribution will be made. This true up is made as soon as administratively feasible after the end of the Plan year. The Plan recorded an employer contribution receivable amounting to \$1,065,662 related to the true up of the employer match for the plan year ended December 31, 2024.

### Notes to Financial Statements (continued) December 31, 2024

#### (1) Description of Plan (continued)

##### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately 100% vested in the amount of their contributions and employer matching safe harbor contributions and earnings thereon.

##### *Investment Options*

Participants direct the investment of their contributions and Company matching contributions to diverse investment options offered by the Plan. Investments of the Plan consist primarily of interests in mutual funds.

##### *Notes Receivable from Participants*

A participant may borrow from their account to the extent that such loan, when added to the outstanding balance of all other loans to the participant, would not exceed the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in their account during the previous twelve months, if any. Participants may only have one loan outstanding at any given time. Loans are secured by the balance in the participant's account and bear interest at 2.0% above the prime rate (9.5% and 10.5% as of December 31, 2024, and 2023, respectively). Periodic principal and interest payments are required to be made via payroll deductions.

##### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service withdrawals due to attaining the age of 59 ½.

##### *Forfeited accounts*

At December 31, 2024 and 2023, there were no forfeited nonvested account balances.

**(2) Summary of Significant Accounting Policies**

*Basis of Accounting*

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the trust company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as distributions based upon the terms of the Plan document.

*Payment of Benefits*

Benefit payments to participants are recorded when paid.

#### (2) Summary of Significant Accounting Policies (continued)

##### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included as a component of net appreciation in fair value of investments.

#### (3) Fair Value of Investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the accounting guidance are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**(3) Fair Value of Investments (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market fund:* The money market fund is valued based on the NAV of underlying securities that have observable inputs, including quoted prices for similar assets in active or inactive markets. The Plan uses a practical expedient permitting a reporting entity to measure the fair value of certain investments using the net asset value per share (or its equivalent) of the investment.

The methodologies described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(4) Certified Investment Information**

Plan management has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.
- Investment information included in Schedule H, Line 4i schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of Plan management, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

#### (5) **Related-Party Transactions and Party in Interest Transactions**

Certain administrative functions are performed by employees of the Company and no such officer or employee receives compensation from the Plan. A portion of the administrative expenses of the Plan are paid by the Company. Certain Plan investments are mutual funds managed by Vanguard and Vanguard is the recordkeeper of the Plan and, therefore, these transactions qualify as party-in interest transactions as defined by ERISA. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Management believes these are permitted party-in-interest transactions under applicable ERISA and Department of Labor guidelines.

#### (6) **Tax Status**

The Plan has adopted a Non-Standardized Pre-approved Profit Sharing Plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020 stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has since been amended; however, the Company and Plan Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been recorded.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any periods in progress.

#### (7) **Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants remain fully vested in their accounts. See Note 10 for further discussion.

#### (8) **Risks and Uncertainties**

The Plan invests in various investment securities (Notes 3 and 4). Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

**(9) Prohibited Transactions and Contingencies**

During the year ended December 31, 2024, the Plan received employee contributions of \$887,540 after what was considered to be a reasonable period of time (29 CFR 2510.3-102). The estimated lost earnings associated with these late remittances were \$2,204 for the year ended December 31, 2024. These delinquent contributions are considered non-exempt prohibited transactions under the regulations of the Department of Labor and therefore the Plan and/or the Company may be subject to fines, penalties, and interest. The accompanying financial statements do not include any accruals or provisions related to the outcome of these uncertainties. The estimated lost earnings related to the late remittances for the year ended December 31, 2022 were remitted to the affected participants' accounts in August 2024.

**(10) Subsequent Events**

The Plan has evaluated subsequent events from the date of the Statement of Net Assets Available for Benefits through September 22, 2025, the date the financial statements were available to be issued.

In connection with the acquisition of the Company by Stryker Corporation, the Plan completed its merger on July 31, 2025, and transferred all remaining net assets available for benefits into the Stryker Corporation 401(k) Savings and Retirement Plan, an existing plan sponsored by Stryker Corporation.
