### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Alko Distributors, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Opinion

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alko Distributors, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE A**      **Description of Plan and Significant Accounting Policies**

**Description of the Plan** - The following description of the Alko Distributors, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of the Company are eligible to participate after one year of service and 1,000 hours worked. Employees are eligible to enroll the first day of each month on or following the date the employee meets the eligibility requirements.

**Basis of Accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Administration** - A third-party administrator processes and maintains the records of participant data. The Company has contracted with Mutual of America to act as the trustee and custodian. Substantially all the third-party fees incurred for administering the Plan are paid via Plan assets. Other Plan expenses, such as annual audit fees, are paid by the Company.

**Contributions** - Each calendar year, participants may authorize the employer to withhold from their compensation up to the maximum dollar amounts permissible under Code Section 402(g), not to exceed the limits of Code Sections 401(k), 404 and 415. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers a family of diversified mutual funds. Participants may change their investment allocations daily. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has automatic enrollment feature that allows the Company to make a salary reduction contribution on behalf of the participant at a fixed rate of 1%. The Plan allows the employer to make a discretionary matching contribution as well as non-elective employer contributions. The Company has elected not to make discretionary matching contributions or non-elective employer contributions for the Plan year ended December 31, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the loan is limited to five years except where a loan is taken for the purchase of a participant's principal residence. The number of outstanding loans for a participant is limited to one. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate determined by the administrator based on prevailing market rates. The specific terms and conditions of such loans are established by the Plan administrator. Interest rates range from 4.25% to 9.50% for loans outstanding. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as a note receivable from participants and measured at their unpaid principal balances plus any accrued interest. Notes receivable due from participants on the Statements of Net Assets Available for Benefits, were \$106,564 and \$48,337 as of December 31, 2024 and 2023, respectively. Periodically, the Plan administrator reviews its

**Notes Receivable from Participants (continued)** - receivables and at December 31, 2024, management had determined that all receivables are fully collectable; accordingly, no allowance for credit loss is considered necessary. Delinquent loans are treated as distributions based upon the terms of the plan document regarding defaults.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company's contributions portion of their accounts as follows:

**Payment of Benefits** - The Plan permits withdrawals when a participant terminates employment, retires, becomes disabled or deceased. In service withdrawals are also permitted for certain financial hardships or when a participant attains age 59 ½. Benefits are payable in lump-sum payments with certain exceptions allowed. Benefits are recorded when paid.

**Forfeitures** - Forfeitures of non-vested employer matching contributions are used to reduce administrative fees and the Company matching contributions. There were no non-vested forfeiture account balances as of December 31, 2024 and 2023, respectively.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value except for the guaranteed investment contract account which is stated at contract value (see Note C). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Participant loans are valued at their outstanding principle balances plus accrued but unpaid interest, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year.

**Risks and Uncertainties** - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits. Plan assets may have changed in value since December 31, 2024 due to normal market fluctuations.

**NOTE C**      **Investments at Contract Value**

The Plan maintains a General Interest Accumulation Account with Mutual of America. Amounts in the General Interest Account are credited with a current interest at a rate determined by Mutual of America. Mutual of America reserves the right to change the interest rates applicable to amounts held at their discretion. The General Account is carried and valued at amortized cost, or contract value. If funds are transferred to another funding vehicle or investment, they may be subject to mark value adjustment. Requests for withdrawal can be made at any time, are processed daily, and are not dependent on the Plan having to liquidate securities in order to generate payment.

**NOTE D**      **Fair Value Measurement of Investments**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are as follows:

- Level 1: Quoted market prices in active markets for identical assets and liabilities.
- Level 2: Observable market based inputs or unobservable inputs that are corroborated by market data.
- Level 3: Unobservable inputs that are not corroborated by market data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the quoted market price of the fund which represents the net asset value of the shares held by the fund at year-end.

**NOTE E**      **Tax Status**

The Plan obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. The Plan Administrator does not believe that the Plan has any uncertain tax positions.

**NOTE F**      **Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. Subsequently to year end, in July 2025, the Plan Administrator signed the amendment to terminate the Plan. Participants were 100% vested in their accounts on that date.

**NOTE G**      **Related Party Transactions**

Certain Plan investments are managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management services amounted to \$706 for the year ended December 31, 2024.

**NOTE H**      **Subsequent Events**

In July 2025, the Plan was terminated (See Note F).

Subsequent events have been evaluated through September 9, 2025, the date the audited financial statements were available to be issued. Except as noted above, the Plan administrator is not aware of any additional subsequent events, which would require recognition or disclosure in the financial statements.
