### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Capital Accumulation Plan for the Employees of Southern Bank and Trust Company (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### 1. Description of Plan

The following description of The Capital Accumulation Plan for the Employees of Southern Bank and Trust Company (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Beginning on January 1, 2012, employees of Southern Bank and Trust Company (the "Company") who have not completed one year of service for eligibility purposes on or before June 30, 2012, or who are hired or rehired after June 30, 2012 are not eligible to participate in this Plan after June 30, 2012. These employees are eligible to participate in The Enhanced Capital Accumulation Plan for the Employees of Southern Bank and Trust Company (the "Enhanced Plan") effective July 1, 2012.

#### **General**

The Plan is a defined contribution Plan covering employees of the Company who meet certain qualifications. The Administrative Personnel and Retirement Committee of the Company controls and manages the operation and administration of the Plan. First-Citizens Bank & Trust Company serves as the trustee of the Plan (the "Trustee"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On July 1, 2013, the Company completed the merger of The Heritage Bank ("Heritage"). As a result of the transaction, the merger and assignment of account balances in The Capital Accumulation Plan for the Employees of The Heritage Bank ("Heritage CAP Plan") was effective July 1, 2013. All employees of Heritage prior to the merger who were participants in the Heritage CAP Plan became a participant in the Plan. Each Heritage employee who had not satisfied the conditions for participation in the Heritage CAP Plan prior to merger became a participant on the first day of the month subsequent to the employee completing the eligibility requirements. All Heritage CAP Plan participants were credited with service while employed by Heritage prior to the merger.

#### **Contributions**

Each year participants may contribute compensation from 1% to 16%, up to the Internal Revenue Service ("IRS") maximum limits, as defined in the Plan. Participant salary deferrals may be traditional pretax and Roth after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Participants are automatically enrolled to have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan allows the automatic deferral rate to increase by 1% up to a maximum of 6% in each subsequent Plan year.

The Company contributes 100% of the first 3% of base compensation that a participant contributes to the Plan and 50% of the next 3% of base compensation that a participant contributes. The Company matches the participant's contribution after six months of service. Additional amounts may be contributed at the discretion of the Company. No discretionary contributions were made in 2024.

### ***Investment options***

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common collective trust funds, and a money market fund as investment options for participants.

### ***Participant accounts***

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings. Accounts may be charged with benefit payments and allocations of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions, the Company's matching contributions, and any discretionary contributions, plus actual earnings thereon.

### ***Notes receivable from participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions. Loan terms are not to exceed five years, with the exception of principal residence home loans which may be fixed for a period exceeding five years. At December 31, 2024, outstanding loans bore interest at rates ranging from 5.25% to 10.50%.

### ***Payment of benefits***

On termination of service due to death, disability or retirement, a participant may elect, with the spouse's consent, if required, to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum or annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participant reaches the age of 59.5 years.

## **2. Summary of Significant Accounting Policies**

### ***Basis of accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### ***Investment valuation and income recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### ***Payment of benefits***

Benefits are recorded upon distribution.

### ***Administrative expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No employee receives compensation from the Plan for administrative functions.

### ***Subsequent events***

The Plan has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

## **3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

#### **Money market fund**

The money market fund is a public investment vehicle for which quoted prices are available, however they are not in active markets for identical instruments. The fund seeks to maintain stable value instruments regardless of market conditions. There are no unfunded commitments, redemption frequency restrictions, or other redemption restrictions.

#### **Mutual funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

#### **Common collective trust funds**

These funds are valued at the net asset value ("NAV") of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer does not reserve the right to require advanced notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 5. Related Party Transactions

The Company is related through common ownership with the Trustee, as significant shareholders of the Company are also significant shareholders of the Trustee. For the year ended December 31, 2024, the Company paid the Trustee \$25,000 as Trustee fees for the administration of the Plan and the Plan paid \$34,089 in administrative expenses to the Trustee. These transactions qualify as exempt party-in-interest transactions under ERISA.

#### 6. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets will be distributed to participants and beneficiaries in accordance with the Plan provisions and ERISA.

### **7. Tax Status**

The IRS has determined and informed the Company by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan and its underlying trust are designed and are currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
