INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of

Opinion

We have audited the accompanying financial statements of U.A. Local Union No. 5 Vacation Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the U.A. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the U.A. Local Union No. 5 Vacation Fund (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan is maintained pursuant to the provisions of the collective bargaining agreement between Plumbers Local Union No. 5 of the United Association of Journeyman and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada, AFL-CIO (the Union) and the Mechanical Contractors Association of Metropolitan Washington, D.C., Inc. (MCAMW), to provide vacation benefits to eligible employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is operated and administered by a joint Board of Trustees (Trustees) consisting of three representatives appointed by MCAMW and three representatives appointed by the Union.

Contributions - Contributions to the Plan shall consist of monies withheld by the employer from the hourly wage rate of covered employees and forwarded by the employer to the Plan as provided by the collective bargaining agreement.

Benefits - Vacation benefits are recognized when paid and shall be distributed automatically once each year to all participants at the same time. This distribution shall be made as soon after April 1st as is administratively possible. Vacation benefits paid yearly to each participant shall consist of the contributions actually attributed to each participant during the twelve-month period ending December 31st, less administrative expenses.

If a participant dies, upon submission of proof of death to the Trustees, the total contributions actually deposited in the participant's account shall be paid to the beneficiary listed by the participant, or if no beneficiary has been designated, the contributions will be deposited into the deceased's estate upon demand of the executor, administrator, or personal representative.

If a benefit check has not been cashed after two years, the participant forfeits that benefit amount, and it will be used to pay the Plan's administrative expenses.

Investment Income - Investment income in the Plan may be used to pay the Plan's administrative expenses. Excess of investment income over administrative expenses may be carried forward to later years or distributed to participants on a pro rata basis at the discretion of the Trustees.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, additions are recognized when earned and deductions are recognized when incurred.

Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recognized on a trade date basis. Interest income is reported on the accrual basis. Dividends are recognized on the ex-dividend date.

Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the use of estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses - Administrative expenses are paid by the Plan.

Reclassifications - When applicable, certain reclassifications may have been made to conform to current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits.

NOTE 3. PLAN TERMINATION

The Trustees have complete discretion to amend or modify the Plan and any of its provisions, in whole or in part, at any time. The Trustees have the right under the plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, the Trustees shall use any remaining funds to satisfy existing and arising claims for benefits under the terms of this Plan and to pay reasonable administrative expenses until such funds are exhausted. Under no circumstances will any portion of the Plan revert or inure to the benefit of any contributing employer.

NOTE 4. INCOME TAX STATUS

The Internal Revenue Service (IRS) has advised that the Plan qualifies under Section 501(c)(9) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.



NOTE 5. LITIGATION

Based on advice of the Union's counsel, there is no litigation either threatened or pending which would have a material adverse effect on the Plan's financial position.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

As described in Note 2, the Plan paid certain expenses related to Plan operations to various service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.



