NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the DataLab USA, LLC 401(k) Profit Sharing Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a participant-directed defined contribution plan covering all eligible employees of the Company. The Plan was established on January 1, 2004 and amended on November 3, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). To be eligible to participate in the Plan, the employee must be 21 years of age and completed three months of service with the Plan Sponsor. The Plan entry date is the first day of the Plan year after employees meet the applicable age and service requirements. Participant loans are not allowed per the Plan Agreement.

Administration Expenses – The Plan is administered by DataLab USA, LLC (the “Plan Sponsor” or “Company”). Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly from Plan assets; however, the Plan administrator may elect to pay these expenses under its sole discretion.

Participant Contributions – Participants may elect to defer a portion of their annual compensation to the Plan, subject to Internal Revenue Code (“IRC”) limitations, up to the maximum percentage of pre-tax compensation, not to exceed the amount allowable by law for income tax purposes as defined by the Plan. Participants may also make Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. Participants direct the investment of their contributions into various investment options offered by the Plan.

Automatic Enrollment – Newly-hired eligible employees are automatically enrolled to contribute salary deferrals equal to 6% of compensation. A participant may specifically request to opt out of the automatic enrollment or may elect to contribute a different amount.

Employer Contributions –The Company may make discretionary matching contributions and/or profit sharing contributions in the amount determined by the Plan Sponsor each year. To be eligible to receive these contributions, the employee must work at least 6 months of service during the Plan year and be employed on the last day of the Plan year. For the year ended December 31, 2024, the Company made profit sharing contributions in the amount of \$858,291 of which \$31,822 was applied from forfeited funds. The Company did not make discretionary matching contributions during the year ended December 31, 2024. The Company may also make qualified nonelective contributions and matching contributions, as determined necessary. No such qualified nonelective or matching contributions were made during the year ended December 31, 2024. All contributions are subject to certain IRC limitations.

Investment Options – Participants may direct Ascensus, LLC, the “qualified institution”, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections daily. Transfers of account balances between elected investment options may be made at the beginning of each quarter. There has been no change in valuation methodologies for the years ended December 31, 2024 and 2023.

Note 1—Description of the Plan (continued)

Vesting – Participants are immediately vested in their salary deferral contributions, rollover contributions, qualified nonelective, and matching contributions, plus actual earnings (losses) thereon. A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan. The employer discretionary matching and profit sharing contributions vest as follows:

Participant Accounts – Individual accounts are maintained for each participant and include participants' salary deferral contributions, rollover contributions, plus an allocation of the Plan Sponsor's qualified nonelective and matching, if any, profit sharing contribution, if any, and Plan earnings (losses), including realized and unrealized gains and losses on investments, and charged with the participant's distributions and the allocation of Plan expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits – A participant may make a withdrawal, at termination of the Plan, becoming disabled, for certain in-service withdrawals upon attainment of 59½, or attaining normal retirement age. Upon termination of service due to retirement, death, or disability, a participant or beneficiary may elect to receive the value of the vested interest in his or her account either by a lump-sum distribution or in monthly, quarterly, or annual installments over a period not to exceed the participant's or beneficiary's life expectancy at the time of distribution.

The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw from their account balances while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties.

Forfeitures – Terminating participants forfeit nonvested Plan Sponsor discretionary matching and profit sharing contributions. Remaining forfeitures can be applied against Plan Sponsor contributions or administrative expenses in accordance with specific Plan provisions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$163 and \$30,797, respectively. For the year ended December 31, 2024, forfeitures in the amount of \$31,822 were used to reduce the 2024 employer profit sharing contributions and no forfeitures were used to pay Plan expenses.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Note 2—Summary of significant accounting policies (continued)

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Benefits Paid to Participants – Benefits paid to participants are recorded when paid.

Risk and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Fair Value Measurements – U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual and Money Market Funds – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6—Plan termination

Although, it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

Note 7—Tax status

The Plan utilized a prototype plan document sponsored by Ascensus, LLC. The prototype plan sponsor has obtained a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through September 24, 2025, the date these financial statements were available to be issued.
