Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Thieman Quality Metal Fab Inc. 401(k) Retirement Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. December 31, 2024 and 2023

1. Description of Plan

The following description of the Thieman Quality Metal Fab Inc. 401(k) Retirement Savings Plan and Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, as amended, is a defined contribution plan with a cash or deferred arrangement covering substantially all employees who have completed 1,000 hours of service within twelve (12) months and have attained the age eighteen (18). The Plan was adopted on May 1, 1990 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for contributions by participating employees of an amount not to exceed the maximum amount permitted under the applicable provisions of the Internal Revenue Code of 1986, as amended (the Code). Thieman Quality Metal Fab Inc. (the Employer) is permitted to make matching contributions equal to a discretionary percentage of the participants’ Compensation, as defined in the Plan agreement. The Employer elected to match twenty-five percent (25%) of the first four percent (4%) of employee Compensation deferred into the Plan for the years ended December 31, 2024 and 2023. In addition, all participants that have met the eligibility requirements of the Plan receive an Employer contribution equal to one percent (1%) of Compensation, whether the participant contributes or not.

Rollovers

The Plan permits participants to transfer distributions from other qualified plans into the Plan.

Participant Accounts

Each participant’s account is made up of an employee contribution subaccount and an Employer contribution subaccount. Each account is credited with (a) contributions, (b) an allocation of Plan earnings and losses, and (c) Plan expenses. The participants direct the investment of their account balances among certain investment options. The Employer contributions are invested in accordance with the participants' investment selection.

Vesting

Each participant has a fully vested, nonforfeitable right to all amounts credited to the employee contribution portion of their account. Each participant’s right in the Employer contribution portion of their account vests based on the following schedule:

2	50%

Forfeitures

Forfeitures are created when participants terminate employment before becoming fully vested in the Employer contributions. These accounts may be used to reduce future Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$209 and \$0, respectively. Also, in 2024 and 2023, Employer contributions or Plan expenses were reduced by \$1,961 and \$1,281, respectively, from forfeited nonvested accounts.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions in various investment options offered by the Plan. Except for the Principal Stable Value Fund, there is no guarantee of principal or earnings when participating in these funds.

Payment of Benefits

The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions made and income earned on investments, net of expenses. Upon service or disability retirement, death, or termination, the participant or beneficiary will receive a lump-sum amount equal to the value of the fund allocated to their account. If the participant's account balance exceeds \$5,000, the participant may elect to receive periodic payments as set forth by the Plan.

Hardship Withdrawals

The Plan allows for hardship withdrawals in the event of immediate and heavy financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 5).

The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net investment gain from pooled separate accounts, which consists of interest, dividends, realized gains or losses and unrealized appreciation (depreciation) on those investments. The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net investment gain from common/collective trust, which consists of interest, dividends, realized gains or losses and unrealized appreciation (depreciation) on that investment. The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net investment gain (loss) from registered investment companies, which consists of realized gains or losses and unrealized appreciation (depreciation) on that investment. Purchases and sales of securities are reflected on a trade-date basis. Interest and dividends are recorded when earned. Capital gain distributions are included in dividend income.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the Plan Administrator and Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Expenses

All expenses of administration may be paid out of the trust fund unless paid by the Employer. Such expenses shall include any expenses incident to the functioning of the administrator, including, but not limited to, fees of accountants, counsel, and other specialists and their agents, and other costs of administering the Plan. Until paid, the expenses shall constitute a liability of the Plan. However, the Employer may reimburse the Plan for any administration expenses incurred. Any administration expenses paid to the Plan as a reimbursement shall not be considered an Employer contribution. The Employer elected to pay some administration expenses incurred in 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

3. Plan Termination

While the Employer has not expressed any intent to terminate the Plan, it is free to do so at any time. Upon termination of the Plan by the Employer, the accounts of the affected participants shall become fully vested, and assets remaining in the Plan after payment of appropriate expenses shall be distributed to participants in proportion to their respective account balances.

4. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including all investments held at December 31, 2024 and 2023, and the related dividends from registered investment companies, net investment gain from pooled separate accounts, net investment gain from common/collective trust, and net investment gain (loss) from registered investment company, was obtained or derived from unaudited information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the Trustee of the Plan).

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and lowest priority to unobservable inputs (level 3). The three levels of inputs used to measure fair value under this accounting standard are described as follows:

- Level 1 - Quoted prices in active markets that are accessible at the measurement date for identical assets or liabilities.
- Level 2 - Observable inputs other than quoted prices included within Level 1. Inputs that are principally derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value measurement of the assets or liabilities. These include certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies the Plan used for assets measured at fair value:

Registered investment company (mutual fund): Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-end mutual fund that is registered with the U.S. Securities and Exchange Commission. Mutual funds are required to publish their daily net asset value and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

Common/collective trust (stable value fund) and pooled separate accounts: Valued at the net asset value (NAV) of units of the common/collective trust or pooled separate account. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the investments will be sold for an amount different from the reported NAV. Transactions (purchases and sales) may occur daily. There are no unfunded commitments or significant redemption restrictions at December 31, 2024 and 2023.

6. Party-In-Interest Transactions

The Plan invests in pooled separate accounts and a common/collective trust managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal). Principal acts as Trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rule. Fees paid by the Plan to Principal Life Insurance Company for administrative and recordkeeping services amounted to \$106,781 and \$87,985 for the years ended December 31, 2024 and 2023, respectively.

7. Tax Status

The Plan adopted the Principal Financial Group (Principal) Basic Savings Plan No. 2, a pre-approved defined contribution plan. Principal has received an opinion letter from the Internal Revenue Service (dated June 30, 2020) stating that employers who adopt the plan will be considered to have a plan qualified under section 401 of the Internal Revenue Code. Accordingly, the Plan's net investment income is exempt from tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment options. These investment options are exposed to risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan's management evaluated the activity of the Plan through September 22, 2025 (the date the financial statements were available to be issued) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
