Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community 1st Credit Union 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community 1st Credit Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Community 1st Credit Union 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Community 1st Credit Union 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Community 1st Credit Union 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Community 1st Credit Union 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. NOTES TO FINANCIAL STATEMENTS

1. Plan description:

The following brief description of the Community 1st Credit Union 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information.

a) General:

The Community 1st Credit Union 401(k) Plan (the Plan) was established January 1, 1997 and is a defined contribution plan covering all employees of Community 1st Credit Union (the Company or Plan Sponsor) who have three months of service. In addition, the Plan also provides for a profit-sharing portion, however, the employee must complete 1,000 hours of service in the Plan year and be employed by the Company on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b) Contributions:

Participants may elect to defer contributions up to the maximum dollar amount set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The Plan requires employer safe harbor contributions of up to 3% of compensation, which were \$515,458 and \$467,409 for December 31, 2024 and 2023, respectively. Additional profit-sharing amounts may be contributed at the option of the Employer's board of directors, which were \$1,057,453 and \$967,562 for December 31, 2024 and 2023, respectively. Roth contributions are allowed by the plan. Contributions are subject to certain limitations.

c) Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings, and is charged with an allocation of administrative fees and investment management fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d) Vesting:

Participants are immediately vested in their voluntary, elective deferral contributions, as well as any employer matching safe harbor contributions or rollover contributions. Vesting in the remainder of their accounts is based on continuous years of service. A participant with three or more years of service as of December 31, 2006 is 100% vested after 5 years of credited service. All other participants are vested based on a 6-year graded schedule.

1. Plan description, continued:

e) Notes Receivable from Participants:

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates available for similar loans from commercial lending institutions. Participants are only allowed to have one outstanding loan at any one time. Principal and interest must be paid at least quarterly through payroll deduction, ACH payment or check.

f) Payment of Benefits:

On termination of service due to death, disability, retirement, or employment termination, a participant or beneficiary will receive a lump-sum amount equal to the value of his or her vested account balance, if that balance is less than \$5,000. When balances exceed \$5,000, the participant or beneficiary must elect how to receive the benefit. Participants may also receive an in-service withdrawal after age 59 ½. Benefit payments to participants are recorded upon distribution.

g) SECURE 2.0:

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect. No additional provisions were elected for 2024 or 2023.

h) Forfeited Accounts:

Forfeited non-vested accounts for the year ended December 31, 2024 were \$61,580, all of which will be applied to the 2024 employer contributions.

Forfeited non-vested accounts for the year ended December 31, 2023 were \$48,850, all of which was applied to the 2023 employer contributions.

i) Merger:

On December 1, 2024 the authorized representative of Town and Country Credit Union and the officers of Community 1st Credit Union approved the merger of the Town and Country Credit Union 401(k) Plan and Trust into the Community 1st Credit Union 401(k) Plan. As a result, all investments were transferred into the Community 1st Credit Union 401(k) from the Town and Country Credit Union 401(k) Plan and trust.

2. Summary of accounting policies:

a) **Basis of Accounting:**

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting.

b) **Notes Receivable from Participants:**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

c) **Payment of Benefits:**

Payments are recorded when paid. There were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

d) **Estimates:**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

e) **Administrative expenses:**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The amount of such expenses and cost of such services have not been determined.

Certain other administrative expenses, including audit fees, are paid directly by the Plan sponsor.

Third party, administrator fees and certain other plan related expenses are paid by the Plan and are charged to participants' accounts on a pro rata basis.

f) **Fair value measurements:**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. Summary of accounting policies, continued:

f) Fair value measurements, continued:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs use quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

g) Income recognition:

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

h) Subsequent events:

Subsequent events were evaluated by management through September 23, 2025 which is the date the financial statements were available to be issued.

3. Guaranteed interest account:

Guaranteed interest accounts are an investment option offered under the John Hancock group annuity contract. The guaranteed interest accounts are part of the general assets of John Hancock Life Insurance Company and are covered by the audit of the parent company Manulife Financial. By definition the guaranteed interest accounts are not guaranteed investment contracts.

4. Cash:

Cash includes forfeitures not allocated to participants' account balances. The cash account is a part of the general assets of John Hancock Life Insurance Company and is covered by the audit of the parent company Manulife Financial.

5. Fair value measurements:

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts – Pooled separate accounts invest primarily in domestic and international long-term bonds, domestic and international stocks, or single mutual funds. The net asset value (NAV) is used as a practical expedient to determine fair value for these accounts and is based on the market value of its underlying investments which represents the NAV of the units held by the Plan at the end of the year. The NAV is not a publicly-quoted price in an active market.

Guaranteed interest accounts – The Plan has investment options with John Hancock USA (John Hancock). John Hancock maintains the Plan’s deposits in an unallocated fund, to which it adds interest at the contract rate. Deposits into these contracts are guaranteed the contract rate of return. The contract has been determined not to be fully benefit-responsive; therefore, the investment is stated at fair value, determined to be the contract value minus early withdrawal charges, adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits.

6. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

7. Tax status:

The Plan uses a prototype plan document sponsored by Newport Group, Inc. Newport Group, Inc. received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document, as then designed, satisfied the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

8. Related party and party in interest transactions:

Certain Plan investments are pooled separate accounts and guaranteed interest accounts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan for the investment management services, third party administration and investment management fees amounted to \$148,140 and \$126,379 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
