INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 – Description of Plan

The following description of the OPKO Health, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is designed to qualify as a Safe Harbor 401(k) Plan established by the plan sponsor, OPKO Health, Inc. (the “Company”). The Plan is a defined contribution plan covering certain employees that meet the eligibility requirements. The Plan also covers the employees of affiliated employers, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan became effective on January 1, 2005.

The Company serves as the plan administrator. Fidelity Management Trust Company, a qualified institution, serves as the Plan’s record keeper and trustee (the "trustee" or “Fidelity”) during the years ended December 31, 2024 and 2023. The trustee has the responsibility under the Plan for the management and control of the assets of the Plan.

Eligibility

Employees are eligible to participate in the Plan immediately upon the date of hire. There is no minimum age or service requirement for participation in the Plan.

Contributions

Eligible employees can contribute up to the maximum percentage allowable of their compensation, as defined, subject to certain limitations under the Internal Revenue Code (“Code”). In accordance with the Code, the total maximum allowable contribution to the Plan directly from the participant was \$23,000 for 2024, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500. Participants are allowed to designate contributions to both pre-tax and Roth (after-tax) 401(k) classifications. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Contributions from participants are recorded when payroll deductions are made. Participants are always 100% vested in any amounts contributed to the Plan as a rollover from another qualified plan or an IRA.

The Company can elect to make safe harbor matching contributions as well as discretionary non-elective matching contributions to the Plan. During 2024, the Company elected to make safe harbor matching contributions equal to 100% of the amount contributed by participants to the Plan up to the first 4.00% of participant compensation. During 2024, the safe harbor matching contribution was funded on a pay period basis. Participants are subject to the following conditions in order to be allocated any discretionary non-elective matching contributions: a) participants must be employed on the last day of the Plan year or b) participants must complete at least 501 hours during the Plan year.

OPKO Health, Inc. 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan, continued

Investment Options

Participants are allowed to invest their elective 401(k) contributions, rollovers, if any, as well as Company matching contributions to the Plan in a variety of investment options as more fully described in the Plan document. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant's account is credited with the participant's deferral contribution, the Company's matching contributions, if any, and an allocation of the investment earnings, based upon each participant's election and charged with an allocation of administrative expenses not paid by the Company. The benefit to which a participant is entitled is the vested benefit amount in the participant's account.

Vesting

Participants are always 100% vested in their contributions, the Company's safe-harbor contributions and any other special contributions made to the Plan as specified by the Plan document.

Payment of Benefits

The Plan provides for distribution of accumulated benefits upon death, disability, or retirement of participants. Payment options include installment payments and lump-sum distributions. Upon termination of service, participants are entitled to the value of their accumulated vested balance, subject to the vesting limitations as described above.

The Plan also allows participants that qualify for financial hardship, as defined, to withdraw funds accumulated from their own contributions while still employed. A participant may withdraw vested amounts attributable to all vested contributions while still employed if the participant is at least age 59 ½ at the time of the distribution. The Plan also allows participants to receive qualified reservist distributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (a) 50 percent of their vested account balance, or (b) \$50,000 (as defined in the Plan document). The Plan does not allow participants to have more than one loan outstanding at any time. Loans must have a definite repayment period not to exceed five years, unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest commensurate with the interest rates charged by persons in the business of lending money for loans under similar circumstances at the time the loan is made. The interest rate remains fixed over the loan term. Principal and interest are paid ratably through payroll deductions. Upon termination of employment, all loans will immediately become due and payable. If a loan is not repaid within a reasonable time following termination, it will be offset against the participant's vested balance and recorded as a benefit payment.

Note 1 – Description of Plan, continued

Forfeited Accounts

Pursuant to the Plan, forfeited non-vested accounts may be used to offset expenses or reduce future employer contributions. Approximately \$7,000 in forfeitures were utilized to pay Plan expenses during the year ended December 31, 2024. No forfeitures were utilized to offset the Company's Safe Harbor matching contribution for the year ended December 31, 2024. On December 31, 2024 and 2023, there was a remaining forfeiture balance of approximately \$4,000 and \$9,000, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, and those differences may be material.

Investment Valuation and Income Recognition

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee, Fidelity, determines the Plan's valuation policies. The Plan utilizes the Net Asset Value ("NAV") practical expedient for its investments in common collective trusts ("CCT"). See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest is recorded in the period earned. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 – Summary of Significant Accounting Policies, continued

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments through revenue sharing arrangements. During the year ended December 31, 2024, administrative and investment advisory expenses incurred by the Plan totaled approximately \$443,000. The Plan utilized revenue credits received from Fidelity to pay for some of these expenses (See Note 7).

Recent Accounting Pronouncements

The Company evaluates new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

Note 3 – Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) on December 31, 2024 and 2023, including investments totaling \$221,599,955 and \$204,220,423, respectively, and notes receivable from participants totaling \$3,505,567 and \$3,416,829, respectively, and for the year ended December 31, 2024, net appreciation in fair value of investments totaling \$22,152,742, interest and dividends totaling \$8,177,181, and interest income on notes receivable from participants totaling \$256,998, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, the trustee of the Plan. This information has not been audited by the Plan's independent auditors.

Note 4 – Risks and Uncertainties

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits. The plan administrator, through its investment committee, monitors the Plan's investments and the risks associated therewith on a regular basis, which the plan administrator believes minimizes these risks.

Note 5 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date. Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 inputs were available and therefore used. No level 2 and 3 inputs were used by the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily NAV of shares held by the Plan at year end. The NAV is based upon quoted prices.

Common Collective Trusts - The collective trust funds are valued at the NAV of the units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Note 6 – Common Collective Trusts

The Plan has investments in stable value common trust funds at December 31, 2024 and 2023. The Plan has estimated the investments' fair value utilizing the NAV practical expedient. The estimated fair value at December 31, 2024 and 2023 was approximately \$15,853,000 and \$9,927,000, respectively. The objective of the investments is to preserve capital while earning a level of interest income that is consistent with principal preservation. Units in the trust may be redeemed on a daily basis to meet benefit payments and other participant- initiated withdrawals permitted by the Plan. For a plan level liquidation, the Plan is required to provide notice to the trustee prior to redemption and may delay the redemption period if necessary in order to ensure that securities liquidations will be carried out in an orderly business manner. On December 31, 2024 and 2023, there were no unfunded commitments.

Note 7 – Related Party and Party In Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity, the appointed trustee of the Plan's assets as of December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions. Fidelity provides certain administrative services to the Plan pursuant to the agreement between the Company and Fidelity. Fidelity receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services. Additionally, administrative expenses include other professional fees paid by the plan; therefore, these transactions also qualify as party-in-interest transactions. As disclosed in Note 2, the Company pays a portion of administrative expenses on behalf of the Plan. Expenses paid to Fidelity and its affiliates by the Plan totaled approximately \$443,000 during the year ended December 31, 2024.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the agreement, Fidelity remits the excess to the Plan's trust. During the year ended December 31, 2024, the Plan received approximately \$36,000 in revenue credits from Fidelity, all of which were used to pay Plan administrative expenses.

The Plan or plan sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 – Tax Status

The Plan is based on a "volume submitter" plan document. The sponsor of the volume submitter document has received a favorable determination letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Code. The Company has chosen to rely on the IRS determination letter issued to the sponsor of the volume submitter document as evidence that the form of the Plan is tax-qualified. The Plan is also required to be operated in conformity with the Code to maintain its tax-qualified status. The plan administrator believes that the Plan, which has been amended since the date of the determination letter, continues to be tax-qualified in both form and operation.

Note 8 – Tax Status, continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
