Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following description of Nexus Pharmaceuticals, LLC 401(k) and Profit Sharing Plan (the Plan) provides only general information. The Plan name was changed from Nexus Pharmaceuticals Inc. 401(k) and Profit Sharing Plan to Nexus Pharmaceuticals, LLC 401(k) and Profit Sharing Plan pursuant to a plan amendment effective June 1, 2023. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Nexus Pharmaceuticals, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees, with the exception of certain excluded groups, of the Company are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective January 1, 2023, the Plan was amended to allow for automatic employee salary deferral provision of 3% with an annual employee deferral increase of 1% up to a maximum deferral of 10%. The new provision applies to all plan participants, except those who had a salary deferral agreement in effect as of the effective date.

Contributions: Eligible employees can contribute an amount up to 100% of compensation and elect to have pretax and/or Roth elective deferrals, as defined by the Plan, subject to certain limitations under the IRC. The Company's compensation committee determines the Company's matching contributions, as well as any discretionary profit sharing contributions. Plan participants must have one year of service to take part in the profit sharing contributions. The Company did not make any profit sharing contributions during the year ended December 31, 2024. Contributions are recognized when earned.

Vesting: Participants are immediately vested in their contributions (including roll-over contribution) and safe harbor and profit sharing matching contributions. For the remaining portions of the participants accounts, 100% vesting occurs following two years of service, as defined. Full vesting also occurs upon death of a participant.

Payment of benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The forms of payment are lump-sum or installment payment distribution. In addition, participants who have attained the age of 59½ have the right to an in-service withdrawal for all or a portion of their vested interest in his or her account. If the value of a participant's account balance is less than \$1,000, the Plan shall distribute the participant's entire balance through a lump-sum distribution.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's matching contribution and receives an allocation of the Company's profit sharing contribution, if any and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Note 1. Plan Description (Continued)

Notes receivable from participants: Plan participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, subject to other restrictions provided by the Plan agreement. A participant may not have more than two notes outstanding at any given time. Notes receivable from participants are made in accordance with the Plan's provisions and ERISA regulations whereby interest is calculated and allocated to the individual participant. Notes are repayable over a period ranging from one to five years through employee payroll deductions. The Plan Administrator will treat a loan as a default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. The notes are secured by the balance in the participant's account and bear interest at a rate of interest as determined by the Plan Administrator, based on the prevailing interest rates at the time the note was funded. The interest rates on the notes outstanding as of December 31, 2024, and 2023, were 7.25% to 9.50%, and 4.25% to 9.50%, respectively

Investment options: Upon enrollment in the Plan, participants may direct their account balances into investment options as more fully described in the Plan's literature.

Forfeitures: Forfeitures of nonvested portions of terminated participants' accounts are to be used to offset any employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. During the year ended December 31, 2024, \$8,950 was used to offset employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Accounting estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditor not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Shares of registered investment companies: Valued at the daily closing price, as reported by the fund. Shares of registered investment companies held by the Plan are open-end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Units of common collective trust: Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Note 5. Related-Party and Party-in-Interest Transactions

The Plan’s investments are held, invested and maintained by Reliance Trust Company, the trustee. The trustee and Transamerica Financial Life Insurance Company (custodian) perform administration and recordkeeping services for the Plan. The trustee and custodian perform administration and recordkeeping services for the Plan. These transactions qualify as party-in-interest transactions. Total administrative expenses paid by the Plan to its service providers was \$66,446 for the year ended December 31, 2024.

Certain employees of the Company perform administrative services for the Plan. These employees are not compensated by the Plan for their services. Certain other administrative expenses are paid by the Company on behalf of the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company may discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

In 2024, the Company downsized its operations which resulted in a partial plan termination. This affected 87 participants, 47 of whom have taken distributions from the plan of approximately \$1,369,00 in the current year. All participants affected by the partial plan termination were fully vested in their accounts prior to the partial plan termination.

Note 7. Income Tax Status

Effective April 8, 2022, the Plan adopted a non-standardized form of a prototype plan sponsored by Transamerica Financial Life Insurance Company. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan’s qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provision of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Note 7. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
