### NOTES TO FINANCIAL STATEMENTS

---

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Diamond Growth Partners, LLC 401(k) Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - On January 1, 2006, Qbase LLC (the "Company" or "Plan Sponsor") adopted a Section 401(k) profit-sharing plan. As a result of a restructuring, effective August 5, 2021, Qbase Holdings, LLC became the Plan Sponsor and Finch Computing, LLC, Qbase Partners, LLC, and Qbase, LLC became participating employers in the Plan. On September 30, 2021, the membership interest in Qbase, LLC was sold and Qbase, LLC is no longer a participating employer in the Plan after this date. Effective November 29, 2021, the Plan changed its name from Qbase 401(k) Plan to Qbase Holdings, LLC 401(k) Plan. Effective October 1, 2023, Qbase Holdings, LLC changed its name to Diamond Growth Partners, LLC and the Plan changed its name from Qbase Holdings, LLC 401(k) Plan to Diamond Growth Partners, LLC 401(k) Plan. In addition, the participating employers changed their names from Finch Computing, LLC to Finch Computing Corp. and from Qbase Partners, LLC to DG Admin Services, LLC. The Plan allows all eligible employees of the Company who have completed three months of service and have attained age 18 to participate. Union employees, leased employees, and non-resident aliens are not eligible to participate. Employees may enter the Plan on the first day of the pay period following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. In addition, the Plan allows Roth 401(k) contributions and voluntary after-tax contributions.

The Plan provides for a safe harbor matching contribution. The Company matches 100% of elective deferrals up to 3% of compensation and 50% of elective deferrals on the next 2% of compensation. This contribution is based on the Plan year and will be made annually. The Plan also allows discretionary matching contributions. For the years 2024 and 2023, the Company did not make a discretionary matching contribution to the Plan. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

**Participant Accounts** - Voya Retirement Insurance and Annuity Company (the "Trustee") is the Trustee and Custodian of Plan investments. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution and employer match are to be invested.

#### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Vesting** - Participants are immediately vested in their voluntary contributions, rollovers, and corresponding earnings. Beginning January 1, 2011, participants are fully vested in all employer matching contributions and related earnings under the safe harbor rules. For discretionary matching contributions and matching contributions made prior to January 1, 2011, excluding those matching contributions to participants terminated in connection with the events on April 16, 2015, September 30, 2021, and August 16, 2024 resulting in partial plan terminations, the following schedule will be used to determine vesting in the Plan match and its earnings:

**Notes Receivable from Participants** - Participants may borrow from their account balance in any amount between \$1,000 and \$50,000, but not more than 50% of their vested account balance. Effective April 1, 2024, the Plan was amended to increase the maximum loan limit to \$100,000 for federally declared disasters. Participants may only have one loan outstanding at any given time. Loans may not be made from Roth amounts. Loans bear interest at the prime rate on the date of the loan plus 1%. Loan terms are for a period not exceeding five years, but may be delayed up to one year for a federally declared disaster. A term up to 15 years may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions.

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. The Plan allows in-service withdrawals at any time from the participant's rollover contribution account balance. If the participant's account balance is \$5,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. In addition, participants may receive distributions of elective and Roth deferrals for qualified financial hardships. Effective April 1, 2024, the Plan was amended to allow for distributions up to \$22,000 due to a federal disaster declaration and to allow distributions equal to the lesser of \$10,000, indexed for inflation, or 50% of the participant's account for domestic abuse.

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts may be used in any permissible manner, including to restore forfeitures, to reduce employer matching contributions, to pay Plan expenses, or to reallocate to participants. Forfeitures of \$400 were used to pay Plan expenses during 2024. Forfeitures of \$15,300 were used to reduce the employer matching contributions during 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$314 and \$705.

**Investment Options** - Upon enrollment in the Plan, a participant may direct contributions in any available investment option in increments of one percent. Participants may change their investment options and deferral percentages at any time via phone or the Internet.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was deemed necessary as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Certain administrative fees of the Plan are paid by the Company if Plan forfeitures are not used to cover these expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for specific transactions, such as loan and distribution withdrawals, are paid by the individual participant.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 24, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in value of investments, and interest and dividends for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the Trustee of the Plan).

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Registered investment companies and common collective trust:* Valued at the daily closing price reported by the fund as registered with the Securities and Exchange Commission. The funds held by the Plan are deemed to be actively traded and are required to publish their NAV and to transact at that price.

#### NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company referred to as the Voya Fixed Account. The Trustee maintains the contributions in a general account. The account is credited with earnings of the underlying investments and is charged for participant withdrawals and administrative expenses. The crediting interest rate is based on an agreed-upon formula with the issuer. The interest rate is reviewed on a monthly basis for resetting, but there is a floor in place that is determined in advance.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with the Trustee. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

#### **NOTE 6 - RELATED PARTY TRANSACTIONS**

Certain Plan assets are invested with Voya Retirement Insurance and Annuity Company. In addition, this organization provides recordkeeping and third party administration services for the Plan. Thus, Voya Retirement Insurance and Annuity Company, as Trustee defined by the Plan, qualifies as a party-in-interest. For the years 2024 and 2023, fees paid for these services totaled \$6,871 and \$5,308.

The Plan's investment advisor is Creative Planning Hold Co, LLC, which qualifies them as a party-in-interest. The fees for these advisory services are indirect fees paid by the Plan. For the years 2024 and 2023, these fees totaled \$42,658 and \$43,057.

The Plan sponsor provides certain accounting, record keeping, and administrative services to the Plan for which it receives no compensation.

#### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer portion of contributions.

#### **NOTE 8 - TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

#### NOTE 10 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS

At December 31, 2024 and 2023, there was \$0 and \$8,306 due to participants who had withdrawn from the Plan and requested benefit payment prior to year-end.
