NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the Standard Solar, Inc. 401(k) Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan was established on January 1, 2010 and is a defined contribution plan covering all full-time employees of Standard Solar, Inc. (the Company or Plan Sponsor) who elect to participate and are age 21 or older. Participants are eligible to participate immediately upon the date the age requirement is met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's administrator, investment advisory, and 401(k) committee oversee governance of the Plan. They also determine the appropriateness of the Plan's investments and monitor investment performance.

Participant Contributions and Investment Options:

Participants may contribute up to the maximum deferral allowed by the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investments of their accounts into various investment options offered by the Plan with various objectives and degrees of financial risk. The Plan currently offers various mutual funds and a fully benefit-responsive investment contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Effective June 15, 2024, the default rate was increased from 3% to 5%.

Employer Contributions:

Each year, the Plan Sponsor makes a discretionary matching contribution of the participants, elective deferral up to a maximum of 5% of the participant's compensation. Additionally, the Company may make a discretionary employer contribution to the Plan which is approved by the Board of Directors. For the year ended December 31, 2024, discretionary matching contributions and employer contributions totaled \$662,831 and \$788,807, respectively, which are included in employer contributions in the accompanying statement of changes in net assets available for benefits.

Participant Accounts:

Each participant's account is credited with the participant's contribution, Company matching contribution, and an allocation of the Company's discretionary employer contribution. Participant accounts are also credited with investment earnings or losses, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued):

Vesting:

Participants are fully vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions and employer discretionary contribution are based on years of continuous service. A participant is 100% vested after four years of service, with partial vesting of 25% per year between years one through three.

Notes Receivable from Participants:

A participant may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, unless such loan is for the purchase of a participant's primary residence, in which case the repayment period may not extend beyond ten years from the date of the loan. The loans are secured by the balance in the participant's account and bear interest at a rate of 2% over the prime interest rate. Principal and interest is paid ratably through payroll deductions. These loans are subject to certain restrictions as defined by the Plan and applicable restrictions under the Code. Each participant may not have more than two loans outstanding at any time.

Forfeitures:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,844 and \$12,187, respectively. These accounts are to be used to reduce future employer contributions first, and then pay administrative expenses of the Plan. No forfeitures were used to reduce employer contributions or administrative expenses during the year ended December 31, 2024.

Payment of Benefits:

Upon termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account and/or an annuity equal to the value of the vested interest in their account. For termination of employment due to other reasons, participants may receive the value of the vested interest in their account as a lump-sum distribution. A partial withdrawal is permitted upon termination of service due to disability or retirement for participants or their beneficiaries who must receive required minimum distributions as defined by the Code. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age 59 ½ or due to hardship, as defined by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates:

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of the assets and liabilities and changes therein at the date of the financial statements, and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 6).

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued):

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 – CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held (at fair value), the fully benefit-responsive investment contract (at contract value), and notes receivable from participants held at December 31, 2024, and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (Lincoln) (the trustee of the Plan), a qualified institution.

NOTE 5 – FAIR VALUE MEASUREMENTS:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date.

Authoritative guidance establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

NOTE 5 – FAIR VALUE MEASUREMENTS (Continued):

The following summarizes the fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and therefore Level 1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments that are measured at fair value are classified as Level 1 as of December 31, 2024 and 2023 totaled \$10,911,616 and \$7,813,799, respectively.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3, respectively.

NOTE 6 – FULLY BENEFIT-RESPONSIVE CONTRACTS:

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company (Lincoln Insurance) totaling \$56,949 and \$12,572 at December 31 2024 and 2023, respectively. Lincoln Insurance maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting interest rate for these contracts is reviewed on a quarterly basis for resetting by the issuer. The contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the agreement without the consent of the issuer, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain plan investments are participation units held in a fully benefit-responsive investment contract managed by Lincoln Insurance. Lincoln provides services to the Plan as the recordkeeper and trustee; therefore, these investments and transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, including any matching contributions and discretionary employer contributions.

NOTE 9 – TAX STATUS:

The Plan is being operated under a prototype non-standardized profit-sharing/401(k) plan agreement, which received an Internal Revenue Service opinion letter most recently amended June 30, 2020, stating that the form of the prototype is acceptable under Section 401(a) of the Code. Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 11 – DELINQUENT PARTICIPANT CONTRIBUTIONS:

During the year ended December 31, 2024, the Company failed to deposit participant deferrals in the amount of \$931 within the required timeframe as stated by the United States Department of Labor (DOL). DOL regulations require that employee contributions be transferred to the trustee as of the earliest date on which such contributions can be reasonably segregated from the employer's general assets. The Company has taken corrective action to ensure future compliance with timely transmission of participant contributions to the trustee. The lost earnings are included in employer contributions receivable in the statements of net assets available for benefits and employer contributions in the statement of changes in net assets available for benefits.

NOTE 12 – CORRECTION OF DISTRIBUTION ERROR:

During the years ended December 31, 2024 and 2023, certain participant distributions were not calculated in accordance with vesting provisions outlined in the Plan document (see Note 1). This resulted in the under payment of benefits to participants for the years ended December 31, 2024 and 2023, in the amount of \$9,113 and \$1,266, respectively, which are included in benefits paid to participants in the statement of changes in net assets available for benefits. Management has taken corrective action to correct these errors during the 2025 Plan year.

NOTE 13 – SUBSEQUENT EVENTS:

Effective January 1, 2025, the Plan was amended to modify the timing of employer matching contributions. Previously employer matches were made on an annual basis, under the amended provision, employer matching contributions will now be made on a pay period basis.

Subsequent to year end, the Plan identified \$5,337 of additional distribution that were incorrectly calculated for the 2025 Plan year. The Company has taken corrective action to ensure future compliance with the calculation and processing of payments.

Management has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.
