**NOTE 1 – DESCRIPTION OF PLAN**

Meridian Adhesives Group Retirement Savings Plan (the Plan) is a qualified retirement plan adopted by Meridian Adhesives Group, Inc. effective January 1, 2020, to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was amended effective April 1, 2024. The Plan allows for affiliate employers to adopt its provisions. Affiliate employers who have adopted the provisions of the Plan are W.F. Taylor LLC, Adhesives Technology Corporation, Epoxies LLC, Epoxies Technology, Inc., and Evans Adhesive Corporation. Meridian Adhesives Group, Inc. and the participating employers are hereinafter collectively referred to as the Company. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Significant provisions of the Plan are summarized below. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company are eligible to participate in the Plan once they have completed 90 days of service and have attained age 18. Participants may enter the Plan on the first day of the month coinciding with or next following the date they satisfy the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific dollar amount or by a specific percentage amount and have that amount contributed to the Plan as an elective deferral, not to exceed the dollar limit set by law. There are two types of elective deferrals: pre-tax deferrals and Roth deferrals. In addition, participants who are at least age 50 or will attain age 50 before the end of a calendar year, may elect to defer additional amounts as catch-up contributions to the Plan for that year. Participants may revoke or make modifications to their salary deferral election at any time during the Plan year.

Effective April 1, 2024, the Plan was amended to adopt an automatic enrollment provision. Participants hired on or after the effective date will be automatically enrolled in the Plan and deemed to have made an elective deferral pre-tax contribution election in the amount of 5% of their plan compensation.

The Plan is referred to as a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company makes a safe harbor matching contribution equal to 100% of participant salary deferrals that do not exceed 3% of their compensation plus 50% of participant salary deferrals between 3% and 5% of their compensation. Safe harbor contributions will be allocated to participants' accounts as soon as administratively feasible after the end of the Plan year. This safe harbor matching contribution is 100% vested.

The Company may also make a discretionary nonelective contribution to the Plan. Each year, the Company will determine the amount of the discretionary percentage. A participant will be eligible to receive an allocation if they have completed at least 1,000 hours of service during the applicable period and are employed by the Company on the last day of the applicable period. During 2024, the Company did not make any discretionary nonelective contributions.

Participants may be permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their Plan accounts attributable to elective deferrals including Roth 401(k) deferrals and catch-up contributions, rollover contributions, and safe harbor matching contributions. Vesting for nonelective contributions is based on a five-year vesting schedule, in which participants earn 20% vesting after one year of service and thereafter each subsequent year until they reach 100%.

Payment of Benefits: If a participant terminates employment for reasons other than retirement, disability, or death, and their vested account balance does not exceed \$5,000, a distribution of their vested account balance will be made as soon as administratively feasible in a single lump-sum payment in cash, regardless of their consent to receive it. If a participant's vested account balance does not exceed \$5,000, but the distribution amount exceeds \$1,000 and the participant does not elect to either receive or roll over the distribution, their distribution will be directly rolled over to an IRA. If a participant's vested account balance exceeds \$5,000, they may elect to receive a distribution of their vested account balance in a single lump-sum payment, installments, or ad-hoc distributions. They must consent to any distribution before it may be made.

Participants may be entitled to receive an in-service distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59 ½. In addition, a hardship distribution may be made to satisfy certain immediate and heavy financial needs that a participant has.

Notes Receivable From Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000 reduced by the highest outstanding loan balance in the last 12 months. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through payroll deductions over a five-year period unless it is for the purchase of a principal residence, in which case the loan repayment period may not exceed beyond 10 years from the date of the loan. If the loan is not repaid, it will automatically be treated as a distribution to the participant.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used to pay Plan expenses or to reduce any matching or nonelective contributions. As of December 31, 2024 and 2023, the forfeiture account totaled \$5,000 and \$6,895, respectively.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will continue to be 100% vested. The Company will direct the distribution of participant accounts in a manner permitted by the Plan as soon as practicable.

Administrative Expenses: The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. There are certain other expenses that may be paid just from a participant's account. These are expenses that are specifically incurred by, or attributable to, the participant.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 22, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company (EAIC).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows.

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values (NAV) reported by the fund managers as of the financial statement dates and recent transaction prices. These investments are measured at fair value using NAV as a practical expedient. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit. There are no unfunded commitments or redemption restrictions associated with these investments. Because these investments are measured using NAV as a practical expedient, they are not classified within the fair value hierarchy but are included in the total investments at fair value presented in the financial statements.

**NOTE 5 – GUARANTEED INCOME FUND**

The Plan holds a fully benefit-responsive investment contract with EAIC (formerly Prudential Retirement Insurance and Annuity Company), which was determined to be a fully benefit responsive investment contract and, therefore, is recorded at contract value. The contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is backed by EAIC's general account, which is invested primarily in fixed income securities. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAIC guarantees a minimum rate of interest and will credit interest that exceeds the guaranteed minimum rates. The crediting rate is subject to minimum contractual guarantees. The crediting rate is declared by EAIC semiannually, effective January 1 and July 1 of each year, and is guaranteed not to fall below 1.5% annually. Interest is credited daily using a compounding method consistent with the annual effective rate.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because that is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants can ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to review amounts is dependent on EAIC's ability to meet its financial obligations. EAIC's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Although the contract is fully benefit-responsive, certain events could limit the ability of the Plan to transact at contract value, including Plan termination, Plan merger, or a change in investment options that would remove required equity wash provisions. In accordance with the terms of the contract, transfers from the Guaranteed Income Fund to competing investment options, such as money market or short-term bond funds, may be subject to a 90-day holding requirement in a non-competing fund before the transfer may be completed. In addition, under certain circumstances, such as significant withdrawal activity across all contracts in the insurer's pooled group, EAIC may defer payment of full contract value and instead disburse funds in annual installments over a period of up to five years.

There are no reserves against contract value for credit risk or other factors, and EAIC’s ability to meet its contractual obligations is subject to its financial strength. Plan management has concluded that no events are probable of occurring that would limit the ability of the Plan to transact at contract value with participants. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,045,001 and \$1,430,763, respectively.

**NOTE 6 – PARTY IN INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of pooled separate accounts managed by EAIC and an unallocated investment contract with EAIC. EAIC is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of fees to EAIC qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated December 4, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
