## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Kelley Bros. Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Kelley Bros., LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator and management of the Plan are responsible for oversight of the Plan.

#### **Eligibility**

Employees are eligible to begin contributing to the Plan upon commencement of employment and attaining twenty-one years of age. Eligible employees are automatically enrolled in the Plan with a choice to opt out. Employees receive Company discretionary contributions on the first day of the month following the date when eligibility requirements are met and by completing one year of service, including 1,000 hours of service.

#### **Contributions**

Each year participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. In addition, participants have the option to elect to have Roth contributions made to the Plan. Roth contributions are included in a participant's taxable gross income for the year in which the contribution is made. Participants who have attained the age of 50 before the close of the Plan year may contribute an additional catch-up contribution as defined by the Plan. Participants may also contribute amounts representing distributions from other tax-qualified retirement plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible pretax compensation.

During 2024 and 2023, the Company elected to make discretionary contributions by matching 25% of the first 4% of each participant's elective deferral. The Company may make profit sharing contributions at the option of management. There were no profit-sharing contributions made to the Plan during 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, Plan earnings/losses and charged with an allocation of administrative and investment expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN (Continued)

### Investment Options

Investments are held within various investment options maintained by Hand Benefits & Trust Company, the trustee of the Plan. Contributions are invested, at the discretion of the participant, in one or a combination of available investment options.

### Notes Receivable from Participants

Participants may borrow from their investment accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to certain conditions as defined in the Plan agreement. The loan and interest thereon shall be repaid over a period not to exceed five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate. The interest rates charged on outstanding loans at December 31, 2024 ranged from 3.25% to 8.5% per annum. Principal and interest are paid ratably directly by the participants.

### Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings/losses thereon is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

### Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the vested value of their account or receive a series of payments over a period not to exceed the life expectancy of the participant or the joint life expectancy of the participant and their beneficiary.

Participants with a balance of less than \$5,000 will be rolled into an individual retirement plan designated by the Plan administrator, while participants with a balance of \$200 or less will receive a lump sum payment, unless the participant directs otherwise.

Hardship withdrawals are permitted in the event of immediate and heavy financial need. Participants may elect to receive a hardship withdrawal from the value of their elective deferral contributions including earnings thereon.

In-service withdrawals are permitted from elective contributions, not including Roth contributions, for participants that are age 59 ½ or older. In-service withdrawals are also permitted of Company discretionary contributions if the employee has been a participant in the Plan for at least 60 months, or the portion of the account being withdrawn has been in the Plan for at least two years.

### Forfeited Accounts

Forfeited non-vested accounts totaled \$108 and \$10,873 at December 31, 2024 and 2023, respectively. These amounts may be used to reduce future Company contributions or pay for Plan expenses. For the year ended December 31, 2024, \$13,913 of forfeitures were used to reduce employer contributions. No forfeitures were used during the year ended December 31, 2023.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **Excess Contributions Payable**

Amounts payable to participants totaling \$12,028 at December 31, 2023 for contributions in excess of amounts allowed by the IRS were recorded as a liability and were netted with participant contributions in the statements of changes in net assets available for benefits. The Plan distributed the excess contributions to the applicable participants in following year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative and Investment Expenses**

Expenses incurred in connection with the purchase or sale of securities are charged against the investment funds whose assets are involved in such transactions. Certain administrative costs of the Plan are paid by the Company. All other expenses relating to participant transactions are deducted from those participant accounts as the transactions occur.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement - Definition and Hierarchy

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures* provides the framework for measuring fair value and disclosing fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820, are as follows:

- *Level 1*: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2*: Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3*: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 3.

## 3. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used for assets and liabilities for which fair values are estimated using the net asset value (NAV) practical expedient:

- *Common collective trust fund*: valued at the NAV provided by the manager of the fund. The NAV is calculated as the underlying net assets owned by the fund, divided by the number of units outstanding. The NAV is based on the fair value of the underlying securities within the fund.

### 3. FAIR VALUE MEASUREMENTS (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is partially invested in the Federated Hermes Capital Preservation Fund (the Fund) and as such owns units of beneficial interest in the Fund. The investment philosophy of the Fund is to seek stability of principal and high current income. The Fund invests primarily in stable value products, including guaranteed investment contracts (GICs) and synthetic GICs issued by major insurance companies and money market instruments. Participants may redeem units of the Fund for the purpose of funding a bona fide benefit payment, making a participant loan, honoring an employee-directed transfer of the employee's interest in the Plan to another investment election that is a noncompeting investment, or paying Plan fees. Participants may make withdrawals from the Fund for other purposes generally upon 12 months' advance notice to the Fund holder.

### 4. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has received a certification from Hand Benefits & Trust Company, the trustee of the Plan, that states that the following information is complete and accurate as of and for the years ended December 31, 2024 and 2023.

### 5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Hand Benefits & Trust Company, who acts as the Plan's trustee. Hand Benefits & Trust Company is owned by a holding company that owns Benefit Plan Administration and Recordkeeping Services, the third-party administrator of the Plan. The Plan utilizes an investment advisor representative, James P. Reagan Agency, Inc. for various investment advisory services. Transactions with these companies qualify as party-in-interest transactions.

In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participant's accounts. Therefore, these related transactions qualify as party-in-interest transactions.

## 6. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by Benefit Plans Administrative Services LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

## 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
