INDEPENDENT AUDITORS' REPORT

Retirement Plan Committee and Participants
UWMF Faculty Physicians VEBA and Trust

Opinion

We have audited the accompanying financial statements of UWMF Faculty Physicians VEBA and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of fiduciary net position as of December 31, 2024, and the related statement of changes in fiduciary net position for the year ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the fiduciary net position of UWMF Faculty Physicians VEBA and Trust as of December 31, 2024, and the changes in its fiduciary net position for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of UWMF Faculty Physicians VEBA and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about UWMF Faculty Physicians VEBA and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Required Supplementary Information

Management has omitted management's discussion and analysis that accounting principles generally accepted in the United States of America require to be presented to supplement the plan financial statements. Such missing information, although not a part of the plan financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the plan financial statements in an appropriate operational, economic or historical context. Our opinion on the plan financial statements is not affected by this missing information.

Other Matters

2023 Financial Statements

The financial statements of UWMF Faculty Physicians VEBA and Trust as of December 31, 2023 were audited by other auditors whose report dated October 11, 2024 expressed an unmodified opinion on those statements.

1. Description of the Plan

The following description of UWMF Faculty Physicians VEBA and Trust (“the Plan”) provides only general information. Participants should refer to the Plan and agreements for a more complete description of the Plan’s provisions.

General

The Plan was formed effective January 1, 1997, to fund the cost of life insurance policies for certain eligible employees of the University of Wisconsin Medical Foundation, Inc. (the Organization or Plan Sponsor). All benefits are provided from insurance contracts purchased with the assets of the Plan. The Retirement Plan Committee is responsible for the oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility and benefits

Certain employees of the Organization who have 50% appointment or greater are eligible to participate in the Plan. Employees are eligible the first day of employment and must elect in writing to be a member of the voluntary employee benefit association (VEBA). If new employees do not enroll when hired, open enrollment is offered each year in the fall for coverage effective January 1. Once enrolled, participants cannot opt out. The Plan provides for up to \$450,000 of group term life insurance for all eligible employees who elect to participate in the Plan.

Contributions

Prior to January 1, 2018, the Organization was not permitted to make any contributions to the Plan other than the salary reduction contributions of the participants. The Organization shall forward the salary reduction contributions to the trustees of the Plan promptly as required by the trustees, but in no case later than required by law. The Plan was amended January 1, 2018, to allow the Organization to make discretionary contributions to the Plan to supplement the salary reduction contributions of the participants.

Each participant shall make salary reduction contributions to the Plan in the amounts determined by the trustees to be necessary to offset the costs of all of the benefits provided by the Plan, including premiums for policies, and reasonable expenses incurred by the trustees in connection with the administration of the Plan.

Termination

Although it has not expressed any intention to do so, the Organization has the right under the Plan to modify the benefits provided to active employees and other participants, to discontinue its contributions at any time, and to terminate the Plan, subject to the provisions set forth in ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as applied to governmental units. The Governmental Accounting Standards Board (GASB) is the accepted standard-setting body for establishing governmental accounting and financing reporting principles. The financial statements of the Plan are prepared on an accrual basis of accounting in accordance with the standards of GASB and GAAP. These financial statements present only the Plan and are not intended to present the financial statements of the Plan Sponsor.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash and cash equivalents include demand deposits and short-term, highly liquid investments with original maturities of three months or less. The Plan maintains a money market deposit account, which earns interest at market rates. This account is considered a cash equivalent and is recorded at cost, which approximates fair value.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis.

Life Insurance Premiums

Life insurance premiums are deducted from net position in the period when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Organization and are excluded from these financial statements.

Subsequent Events

Management has evaluated subsequent events for the Plan through September 22, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

To the extent available, the Plan's investments are recorded at fair value as of December 31, 2023. GASB Statement No. 72, *Fair Value Measurements and Application*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. This statement establishes a hierarchy of valuation inputs based on the extent to which the inputs are observable in the marketplace. Inputs are used in applying the various valuation techniques and take into account the assumptions that market participants use to make valuation decisions. Inputs may include price information, credit data, interest and yield curve data, and other factors specific to the financial instrument. Observable inputs reflect market data obtained from independent sources. In contrast, unobservable inputs reflect the entity's assumptions about how market participants would value the financial instrument. Valuation techniques should maximize the use of observable inputs to the extent available.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following describes the hierarchy of inputs used to measure fair value and the primary valuation methodologies used for financial instruments measured at fair value on a recurring basis:

Level 1: Investments have values based on quoted prices (unadjusted) for identical assets in active markets that a government can access at the measurement date.

Level 2: Investments have inputs, other than quoted prices included within Level 1, that are observable for an asset, either directly or indirectly.

Level 3: Investments have unobservable inputs for an asset and may require a degree of professional judgment.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Money market account

The money market account in 2023 represents units of participation rather than ownership of specific assets. The fair value of a unit of participation is the total value of the fund divided by the number of units outstanding and approximates cost, which is 1 per unit.

4. Tax Status

The VEBA established under the Plan to hold the Plan's assets applied for tax-exempt status pursuant to section 501(c)(9) of the Internal Revenue Code (IRC). The Internal Revenue Service has determined and informed the Organization by a letter dated May 16, 1997, that the Plan, as then designed, was in accordance with applicable sections of the IRC. However, as a result of the Plan's funding policy, from time to time, the Trust may be subject to income taxes on unrelated business income. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income.

5. Related-Party and Party-in-Interest Transactions

As of December 31, 2024 and 2023, certain Plan investments were shares of funds managed by JP Morgan Chase. JP Morgan Chase is the custodian of the Plan's assets as defined by the Plan and, therefore, qualifies as a party-in-interest.
