Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tokai Carbon CB Ltd. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Tokai Carbon CB Ltd. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, formerly the Sid Richardson Carbon Ltd. 401(k) Plan, was adopted effective August 1, 2018 and is a defined contribution plan established by Tokai Carbon CB Ltd. (the Company or Employer), covering substantially all employees of the Company. The 401(k) Executive Committee of the Company is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

All employees of the Company are eligible to participate on the date employment begins. There is no age requirement to enter the Plan. Employees must perform one hour of service to be eligible. An eligible participant can enter the Plan on each business day of the year.

Contributions

Eligible participants can contribute on a pre-tax or after-tax Roth basis. If no election is made, eligible employees are automatically enrolled in the Plan using a deferral rate of 4% of eligible compensation. All new, eligible employees are notified in advance of automatic enrollment and provided the opportunity to elect out of this feature or to elect an alternate deferral rate.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Eligible employees are also allowed to make rollover contributions, either before or after they satisfy the Plan's eligibility requirement. However, rollover contributions will only be accepted from another qualified Plan or IRA.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions

Participants are allowed to adjust their contribution election at any time during the year. To do so, the participant must notify Bank of America, N.A. (the Trustee) via online account access.

The Company makes an employer safe-harbor matching contribution each payroll based on the participant's elected contribution up to 4% of eligible compensation.

At Plan year end, the Company also makes a profit-sharing contribution based on active eligible employees who have worked at least 500 hours during the plan year. The profit-sharing match is calculated at 10% of eligible wages for those participants defined above.

Notes Receivable from Participants

Effective November 1, 2023, participants are allowed to borrow from their account, subject to a minimum loan of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by, if any, the highest outstanding loan balance within the previous 12-month period, or 50% of the participant's vested account balance. Loans are secured by the balance in the participant account and bear a reasonable rate of interest in accordance with prevailing rates which is fixed for the term of the loan.

Principal and interest are paid ratably through payroll deductions over a period not to exceed five years from the date of the loan, unless used to acquire principal residence, in which case the repayment period may not exceed 15 years.

Investments

The Plan provides a variety of investment options from which participants may select. Participants direct how their funds are to be invested by notifying the Trustee via online account access.

Plan Administration

Under the Plan agreement, the Trustee is responsible for the custody of all trust assets and the record keeping for Plan members and trust financial matters. In accordance with the trust agreement, the Plan's assets are held and administered by the Trustee. The Plan Administrator has responsibility for appointing and removing the Trustee, establishing a funding policy and method, and amending or terminating the Plan.

Forfeited Accounts

The forfeiture account consisted of unclaimed checks that were forfeited, employer profit sharing matching unvested balances, and corrections to contributions determined during compliance testing. At December 31, 2024 and 2023, there was \$35,323 and \$34,897 in the forfeiture account, respectively. The Plan allows for amounts in the forfeiture account to be used in the following order: pay administrative expenses, reduce employer contributions, and allocated to participants. During the year ended December 31, 2024, \$582 forfeiture funds were used to pay administrative expenses and/or employer contributions.

Each participant's account is automatically fully vested in the participant's contributions and the Company's safe harbor matching contributions and allocations of investment earnings or losses.

Effective January 1, 2024, the Plan was amended for employer profit sharing contributions to be subject to the following vesting schedule below:

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of: (a) the Employer's company matching and profit-sharing contributions; (b) investment earnings or losses; and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance

Payment of Benefits

Upon termination of service, participants may elect to receive a lump-sum distribution equal to their vested account balance or a direct rollover to an eligible qualified plan specified by the participant.

In addition, the Plan permits active participants who are age 59½ and over to elect a distribution from their account. Active participants are also allowed to request receipt of a portion of their accounting balance as a hardship distribution upon providing appropriate documentation to the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for information related to the Plan's valuation methodologies.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Cash

The Plan's cash is held in noninterest-bearing accounts that are used to process participant activity, outside vendor transactions, and administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Plan are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. All costs and expenses in administering the Plan are paid by the Plan, unless paid by the Company. Expenses that are paid by the Company are excluded from the financial statements.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to certain risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Interest Bearing Cash

Interest bearing cash is valued at market rate of \$1 per share.

Registered Investment Companies

Investments in registered investment companies are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset values (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common Collective Trust

The fair value participation units held in the collective trust are based on the NAV reported by the fund manager as of the financial statement dates and recent transaction prices. The NAV, as provided by the trustee of the collective trust, is used as a practical expedient to estimate fair value. The investment objective of the common collective trust is to provide preservation of capital and provide relatively stable returns consistent with a low risk profile. The common collective trust provides for daily redemptions by the Plan at reported NAV per share, with advance notice requirement of 12 months. There are no unfunded commitments. The common collective trust is a direct filing entity with the Department of Labor.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America N.A., a qualified institution.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Bank of America, N.A. Participant loan and distribution processing fees are paid to Bank of American, N.A. by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan

operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discounting their contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, each of the participants would remain 100% vested in their accounts.

8. Tax Status and Plan Amendments

The Plan uses a pre-approved plan document sponsored by Merrill Lynch. Merrill Lynch received an opinion letter dated of June 30, 2020, that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan and the related trust is currently designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no IRS examinations for any tax periods in progress.

9. Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.
