## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of Plan

The following description of the Advantage Services Group LLC 401(k) Plan (the Plan) provides only general information. Effective January 1, 2024, the Plan was amended to change the name of the plan from Central Oregon Heating and Cooling, Inc. 401(k) Plan to the Advantage Services Group LLC 401(k) Plan. Further as a part of this amendment, the employees from Advantage Services Group LLC, Central Oregon Heating and Cooling, Inc., AirTech HVAC Inc., and Elkhorn Technical Resources, Inc. (collectively, the Company) became eligible to participate. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of the Company who are age 18 or older and have completed 1 hour of service. Employees become eligible on the first day of the calendar month following their completion of the above requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan's investments were held by Massachusetts Mutual Life Insurance Company (MassMutual). On December 31, 2020, Empower Retirement LLC acquired the retirement business of MassMutual. The Plan's fully benefit responsive investment contract was issued by MassMutual, therefore the financial information related to this contract was provided by Empower Trust Company, LLC (Empower) through a Power of Attorney granted to Empower by MassMutual.

#### Contributions

Contributions to the Plan include salary reduction contributions authorized by participants, rollovers from other qualified retirement plans, nonelective contributions made by the Company, safe harbor matching contributions made by the Company and discretionary profit sharing contributions made by the Company.

Participants may contribute up to 100% of their compensation, not to exceed the dollar limit set by law, to the Plan (\$23,000 in 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 in 2024). Participants have the option of deferring their compensation on a pre-tax or post-tax basis.

### Notes To Financial Statements *(Continued)*

Upon becoming eligible in the Plan, participants are eligible for safe harbor matching contributions equal to 100% of the first 4% of compensation contributed per pay period by participants.

The Company may make a nonelective contribution and a profit sharing contribution on behalf of each of its eligible employees at the discretion of the Plan Administrator. Participants must be employed on the last day of the Plan year to be eligible for the Company nonelective contribution and the profit sharing contribution. No nonelective contributions or profit sharing contributions were made in 2024.

#### **Participant Accounts**

Participant accounts are credited with participant's contributions, the Company's contributions, an allocation of Plan earnings (losses) and administrative expenses. The allocation of earnings (losses) is determined by the earnings (losses) of the participant's investment selection based on each participant's account balance and the investments selected by the participant.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct contributions in any of several investment options. Participants may change their investment options daily.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and their share of the Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's nonelective and profit sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service (as defined) and is determined as follows:

#### **Forfeited Accounts**

At December 31, 2023, the Plan had a balance of \$1,551 respectively, in forfeited nonvested accounts. At December 31, 2024, the Plan did not have a balance in the forfeited nonvested account. These amounts will be used to pay Plan expenses or reduce future Company contributions, and unused forfeiture balances will be reallocated to participants in the same manner as Company contributions. During the year ended December 31, 2024, \$1,551 of forfeiture funds were used to reduce Company contributions or pay Plan expenses.

#### **Payment Of Benefits**

Upon termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or have the payment made as a direct rollover to an individual retirement account or to another employer's tax-qualified plan in an amount equal to the vested value of his or her account.

#### **In-Service Distributions**

Active participants who reach age 59½ or experience a qualifying financial hardship may withdraw all or part of their vested account. Hardship withdrawals will be approved only if they conform to Plan provisions and established Internal Revenue Code (the IRC) safe harbor withdrawal provisions.

#### **Administrative Expenses**

Significant administrative expenses of the Plan may be paid directly by the Company, if sufficient forfeiture amounts are not available within the Plan. Administrative expenses paid by the Plan included recordkeeper fees, service fees and transaction fees.

#### **Plan Merger**

On January 1, 2024, the AirTech HVAC, Inc. 401(k) Plan was merged into the Plan. The merger was conducted and approved by the Plan's fiduciaries. As a result, net assets of \$185,826 were transferred into the Plan during 2024.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

Investments held by a defined contribution plan, other than fully benefit-responsive investments contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The net realized and unrealized investment gain or loss (net depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits, and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments held by a defined contribution plan and that are fully benefit-responsive are reported at contract value rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the General Account is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Under the terms of the contract, participant-initiated transactions for the purpose of receiving benefits allowed under the Plan, such as retirement, death, disability, hardship, loan, required minimum distribution or allowable in-service withdrawal, are completed at contract value without conditions, limits or restrictions. Benefits related to termination of employment receive the same treatment unless a termination is associated with a full or partial Plan termination, the insolvency of the Plan sponsor or aggregate terminations in any contract year exceeding 20% of the full contract value as determined on the first day of that contract year.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets of the portion of the General Account that is used to determine the crediting rate compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset at least annually and no more frequently than quarterly for some contracts. The crediting interest rate was 1.41% and 1.23% as of December 31, 2024 and 2023, respectively.

#### **Payment Of Benefits**

Benefits are recorded when paid.

### **3. Certified Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified by Empower.

### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

#### **Common/Collective Trust**

These are valued at the unit value or net asset value (the NAV) of shares held by the Plan at year end. The NAV, as provided by the Trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities, divided by the number of shares outstanding. All of the underlying investments held by the Plan may be redeemed daily. The common/collective trusts held by the Plan are not required to be reported in the fair value hierarchy. All of the common/collective trusts held by the Plan file an annual report on Form 5500 as a direct filing entity. The common/collective trust has no unfunded capital.

#### **Registered Investment Companies**

Assets are valued at the daily closing price as reported by the registered investment company. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded, and are classified as level 1 within the fair value hierarchy.

There have been no changes in the valuation methodology used at December 31, 2024 or 2023.

#### **5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and any unallocated assets of the Plan shall be allocated to participant accounts as defined by the Plan.

#### **6. Tax Status**

Empower received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Party In Interest Transactions**

Plan investments include a guaranteed investment contract managed by Empower as of December 31, 2024 and 2023. These transactions qualify as party in interest transactions allowable under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.
