Scope and Nature of the ERISA 103(a)(3)(C) Audit

We have performed audits of the financial statements of Brady Companies, LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Brady Companies, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan became effective September 1, 2001. The Plan is a defined contribution plan covering all employees of Brady Companies, LLC (the Plan Sponsor), hereinafter referred to as the “Company.” Brady Industries of Arizona, LLC, Brady Industries of California, Inc., Brady Industries of Utah, LLC, Brady Industries of New Mexico, LLC, Brady Industries of Idaho, LLC, Brady Industries of Texas, LLC, Brady Industries of Maryland, LLC, Brady Industries of Utah, LLC and Brady Companies, LLC are participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Participants who have completed one year of service, have attained age 2, and have completed 1,000 hours of services in a specified 12-month period may contribute to the Plan. Entry into the plan occurs on the. Automatic enrollment of 1% starts on the date that participant becomes eligible

Contributions

Each year, participants may contribute up to the maximum percentage allowable by law, of pretax annual compensation, as defined in the Plan. The Plan allows participants to contribute from 1% to 100% of their compensation in one percent increments or a flat dollar amount up to the maximum dollar limit for the year as permitted under §402(g) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company, at the discretion of the Board of Directors, can make a discretionary contribution that is a percentage of the participant’s compensation in accordance with the Plan provisions. For the year ended December 31, 2024, the Board of Directors elected to make a matching contribution of 50 percent not in excess of three percent.

Participant Accounts

Each participant’s account is credited with the participant’s salary reduction contribution, the participant’s rollover contributions, the Company’s matching contribution, an allocation of Plan losses and an allocation of Plan earnings. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance less any loans outstanding.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Vesting of Benefits

Participants are vested immediately in their contributions plus actual earnings thereon. Prior to January 1, 2006, participants were 100 percent vested in all Company contributions. Effective January 1, 2006, participants become vested in benefits provided by Company contributions, plus earnings thereon, based upon years of service after their eligibility date. A participant is vested 20 percent each year beginning with the first year of eligibility and hence is 100 percent vested at the end of six years of credited service. Forfeited balances of terminated participants will be used to offset future employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. When a participant takes a loan from the assets of the Plan, the loan still remains an asset (held by the custodian of the Plan) and is shown separately from the employee's vested balance on the employee statement. When loan repayments are made, the amount transfers from the participant's loan account into the plan investments using the current investment direction. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.50%. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Participants may request a distribution from their pre-tax deferrals while still employed with the Company if they have attained age 59 ½. If the participant has attained normal retirement age, as defined, and continues employment with the Company, Employer matching and profit-sharing contributions will also be available for distribution. There is no limit to the number of in-service distributions that may be requested by an employed participant once they reach normal retirement age.

On termination of service due to death, disability or retirement, a participant is entitled to distributions of their vested account. If the vested account balance is more than \$5,000 the participant may elect to receive a lump sum payment or partial payments. If the vested account balance is less than \$5,000 the participant may elect to roll-over this balance into another qualified plan or take a lump sum distribution.

Forfeitures

Forfeited amounts may be used to reduce employer contributions or pay administrative expenses. As of December 31, 2024, there were no forfeitures available for these uses. For the year ended December 31, 2024, the Plan applied \$22 of forfeited funds towards either of these specified uses.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, third-party administrators, and the Plan custodian. See Note 6 for discussion of fair value measurements. Notes receivable from participants are valued at cost, which approximates fair market value.

Purchases and sales of securities are recorded on a trade date basis and realized gains or losses on security transactions are recognized on the trade date. Interest and dividend income is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Upon termination of service whether due to death, disability, retirement, or other reasons, a participant can elect for the value of his or her vested account to be distributed in the form of various options, as specified in the Plan document. Benefits are recorded when an election is made.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – INFORMATION CERTIFIED BY ASSET CUSTODIAN (UNAUDITED)

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that was prepared by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and furnished to the plan administrator. The plan administrator has obtained certifications from Fidelity that such information is complete and accurate:

- The value of investments as indicated in the statements of net assets available for benefits and notes to financial statements, including notes receivable from participants.
- All information indicated in the statement of changes in net assets available for benefits, with the exception of contributions, benefit payments and administrative fees, if any.
- All information indicated in the supplemental schedule.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation method include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the unit value based on the net asset value of the underlying mutual funds, through attributed quoted market prices, as determined at year end.

Collective Investment Trust: For investments in collective investment trusts, fair value is based on the fair value of its underlying investments. These funds contain synthetic investment contracts comprised of both underlying investment and contractual components which have observable inputs, including quoted prices for similar assets in active or non-active markets.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by Principal Financial Group (subsidiary of Principal Life Insurance Company). Principal Life Insurance Company is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

NOTE 6 – PRIORITIES UPON TERMINATION

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 7 – TAX STATUS

The Plan is a non-standardized prototype plan and has received an opinion letter from the IRS dated June 2020, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related Trust is exempt from taxation. In accordance with Revenue Procedure 2002-6 and Announcement 2001-77, the Plan Sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code; therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is no longer subject to potential income tax examinations by tax authorities for years for which the statute of limitations has expired.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for Plan benefits.

NOTE 9 – TRANSFER OF PLAN ASSETS

The plan sponsor acquired Millennium through a stock purchase. The related retirement assets for Millennium were transferred into Principal on July 11, 2024. The amount transferred into the plan was \$1,816,306. The plan sponsor also acquired Central Janitors during 2024 and the amount transferred into the plan on July 10, 2024 was \$1,238,204. The total amount transferred was \$3,123,718. The funds were held under a transitional holding arrangement and remained under this arrangement until Principal received participant retirement reports, balance those reports with retirement funds received and prepared an allocation as directed by the Plan Sponsor.
