Independent Auditors' Report

To the Plan Participants and Plan Administrator
Blue Cross and Blue Shield Association Tax-Favored Savings Program:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Blue Cross and Blue Shield Association Tax-Favored Savings Program (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of the Program

The following description of the Blue Cross and Blue Shield Association Tax-Favored Savings Program (the Program) provides only general information. Participants should refer to the Tax-Favored Savings Program document (the Program document) and subsequent amendments for a more complete description of the Program's provisions.

General

The Program is a defined contribution program established on January 1, 1985. Prior to July 1, 2001, the Program was available to each full-time employee of the Blue Cross and Blue Shield Association (the Association or Program Sponsor) who had completed 90 days of service, or each part-time employee who had completed 1,000 hours of service in a 12-month period. Effective July 1, 2001, the Program became available to all employees with no minimum service requirement. The Program is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Program is administrated by the National Employee Benefits Committee (the Program Administrator or NEBC).

Contributions

Each year participants may contribute 1% to 50% of their eligible compensation to the Program on a pre-tax, after-tax Roth, and/or non-Roth after-tax basis, subject to Internal Revenue Service (IRS) limitations. Amounts contributed on an after-tax Roth basis are taxable to the participants at the time of contribution. Distributions of funds contributed on an after-tax Roth basis, including related investment earnings, are not taxable to the participant, provided they meet certain IRS requirements. In addition, participants who have attained age 50 before the end of the program year are eligible to make catch-up contributions. The Program provides for an automatic enrollment feature for new employees, with an automatic basic contribution rate set at 3% of the participant's eligible compensation. Automatically enrolled funds are set up to be invested in one of the State Street Target Retirement Securities Lending Series Funds - Class IV, based on the participants' age.

For each participant hired prior to January 1, 2007 and who remains employed, the Association contributes a matching contribution equal to 50% of the participant's contribution of up to 6% of the participant's compensation. As a result of the pension plan freeze as of December 31, 2021, the 401(k) program was amended effective January 1, 2022 to provide the same employer contribution benefits for all participants as described in the following paragraph.

For each participant hired or rehired subsequent to December 31, 2006, the Association provides an employer matching contribution equal to 100% of the first 5% of eligible compensation that the participant contributes, and an additional annual employer contribution of 2% of eligible compensation for such participants who are actively employed on the last day of the year. Effective January 1, 2022, these employer contributions are provided to all eligible participants regardless of hire date.

Each participant's contribution and the Association's matching contributions are subject to the Internal Revenue Code (the Code) nondiscrimination tests. Participant contributions in excess of the nondiscrimination percentages are not matched by the Association.

Vesting

All participants are 100% vested in the value of their own contributions to the Program, all matching contributions, and employer non-elective contributions, if applicable, including any associated earnings or losses on the contributions.

Notes to Financial Statements

Benefit Payments

On termination of service due to death, disability, discharge, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the vested interest in his or her account. Participants may also rollover their account balance to another plan. A participant with an account balance of more than \$7,000 who terminates employment may elect to receive his or her account balance in installment payments. Terminated participants who are receiving installment payments may elect, at any time, to change or cease distribution, to accelerate the remaining amount to be distributed in the form of a lump sum payment, or to recommence installment payments previously stopped.

Any participant who has attained age 59-½ may, while employed, withdraw any portion of the remaining amount in the participant's account. During employment, an employee may withdraw rollover contributions and after-tax contributions at any time. Withdrawals are also permitted for hardship reasons and for permanent disability.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Association's matching and non-elective contributions, and allocations of returns on participant-directed investments. Net earnings of each fund, including unrealized appreciation and depreciation of fund investments, are allocated to each participant based on the ratio of the participant's account value to total fund value at the end of the preceding day.

Notes Receivable from Participants

Participants may borrow against the balances of their individual accounts. The minimum amount a participant may borrow is \$1,000, and the maximum amount a participant may borrow is dependent on the size of the participant's vested Program account balance. The provision for participant loans allows a participant to borrow an amount or amounts which when added to the outstanding balance of all other loans to the Participant under the Program, does not exceed the lesser of (i) 50% of his or her vested Program account balance less the current outstanding loan balance or (ii) \$50,000, reduced by the highest outstanding loan balance over the last year.

Each loan bears a reasonable rate of interest as determined by NEBC and is accrued and allocated to participants' individual accounts. Effective February 2016, the interest rate for new loans is based on the Reuters News Agency Business News published prime rate on the last business day of the prior month, plus 1 percent. During program year 2024, interest rates for new loans issued ranged from 4.25% to 9.50%, and during program year 2023, interest rates for new loans issued ranged from 4.25% to 8.00%.

The period of repayment cannot exceed five years for a general purpose loan as classified at the time of issuance, or 30 years for a residential real estate loan.

Termination

Although it has not expressed any intent to do so, The Association reserves the right under the Program document to terminate the Program as of the end of a program year after not less than a 90-day prior notice, subject to the provisions of ERISA. In the event of Program termination, participants are 100% vested in their accounts and entitled to a distribution.

2. Significant Accounting Policies

Basis of Presentation

The Program's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Fair Value Measurements

The Program performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 *Fair Value Measurement*, which defines fair value, establishes a framework for measuring fair value in accordance with U.S. GAAP, and requires certain disclosures about fair value measurements.

ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (i.e. an exit price) in the most advantageous market for the asset or liability in an orderly transaction. Fair value measurement is based on a hierarchy of observable or unobservable inputs.

ASC 820 describes three levels of inputs that may be used to measure fair value.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Program has the ability to access.

Level 2: Inputs to the valuation methodology are:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability, or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions relating to the pricing of the asset or liability including assumptions regarding risk.

An asset's or a liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Participant Loans

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance plus unpaid accrued interest. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Program document. At December 31, 2024 and 2023, there were no loans in default for active employees.

Participant-Directed Investment Valuation

The Program has provided for the establishment of a trust fund for the purpose of holding and investing all contributions. Under the terms of the Trust Agreement, Fidelity Management Trust Company (the Trustee or Fidelity) maintains the records of Program participants.

Valuation techniques used by the Program are as follows:

- *Registered investment company funds:* Public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund minus its liabilities, divided by the number of shares outstanding. The NAV for registered investment company funds is considered a readily determinable fair value, and these funds have quoted prices in active markets, and therefore are classified within Level 1 of the fair value hierarchy.
- *Common/collective trusts:* Investment vehicles valued using the NAV provided by the administrator of the fund as a practical expedient for fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. These funds are not classified at a specified level within the valuation hierarchy, however they are presented in a manner that enables reconciliation of total investments in the fair value hierarchy to the investments presented at fair value on the Statements of Net Assets Available for Program Benefits.
- *Brokerage accounts:* Registered investment company funds (valued as described above) and money market funds that are valued at amortized cost which approximates fair value. These investments are classified within Level 1 of the valuation hierarchy.

The Galliard Stable Return Fund X (Formerly Wells Fargo Stable Value Fund X) is a common/collective trust investing primarily in fully benefit-responsive short-term and long-term conventional and synthetic investment contracts issued by insurance companies and other institutions that meet the high credit quality standards established by the Trustee. The Program may elect to divest its interest in the fund at any time. In the event of full divestiture by the Program, the value received may be less than the Program's reported contract value if written notice of intent to withdraw assets from the fund is provided less than a year in advance.

The methods described above may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. While the Program uses valuation methods that are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments may result in a different fair value measurement at the reporting date.

Investment Recognition

The Program presents the net appreciation or depreciation in fair value on its investments, which consists of realized gains and losses and unrealized appreciation and depreciation on those investments, in the Statements of Changes in Net Assets Available for Program Benefits. The net realized gain or loss on investments is the difference between the proceeds received and the cost of the investments sold, determined on an average cost basis. Unrealized appreciation and depreciation in fair value of investments is the difference between fair value and the cost of the investments. Purchases and sales of investments are reflected on a trade date basis. Dividends are recorded on the ex-dividend date.

Investment Options

A participant may direct contributions in 1% increments to available investment options. Participants may also re-direct existing funds amongst available investment options. Investment options include actively and passively managed funds selected by the investment fiduciary, and a self-directed brokerage option.

Payment of Benefits

Benefits are recorded when paid.

Forfeitures

The Association's use of forfeiture funds to reduce future employer contributions or program expenses is executed by Fidelity only after receiving a written request from the Program Sponsor. The accumulated forfeited balances at December 31, 2024 and 2023 were \$0 and \$2,184, respectively. During 2024 and 2023 there were forfeitures of \$26,114 and \$41,150, respectively, used to reduce employer contributions and program expenses.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Program Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for program benefits at the date of the financial statements. These estimates and assumptions also affect the changes in net assets available for program benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Expenses

The expenses of maintaining the program are paid by the Program, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment management fees related to the operation of the program's investment funds are charged to participant accounts at the fund level as part of the investment process. Loan origination fees will be charged up front when participants take a new loan. For loans existing prior to July 3, 2017, an administrative fee is deducted quarterly. For loans originated after July 2, 2017, there is no ongoing administrative fee. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Program evaluated subsequent events through September 19, 2025, the date the accompanying financial statements were available to be issued. No material subsequent events occurred that require recognition or disclosure within the financial statements.

The NEBC is the Program's investment fiduciary responsible for selecting and monitoring the performance of the core investment funds available to Program participants.

The Program provides investment options through its participation in common/collective trusts and registered investment company funds which hold combinations of stocks, fixed income securities, guaranteed investment contracts, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and may materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Program Benefits.

4. Information Certified by the Program's Trustee

5. Party-in-Interest Transactions

Fidelity investment funds are managed by an affiliate of Fidelity and non-Fidelity investment funds are managed by independent fund companies. As Fidelity is the Trustee of the Program, the investment transactions and notes receivable from participants qualify as party-in-interest transactions. Investment management fees, brokerage fees, and other fees related to investment funds of the Program are paid from the earnings of the Program's investments. A separate fixed fee is charged for recordkeeping services provided to participants such as investment communications, educational materials, and use of the telephone benefit service center.

Prior to June 30, 2021, the Program invested in certain funds (excluding BrokerageLink assets) that shared the cost of Fidelity recordkeeping fees based on a prescribed percentage. Cost share amounts were computed on a quarterly basis. All cost share amounts in excess of actual recordkeeping fees were deposited into a revenue share account maintained by the Trustee. At the direction of the Program, revenue credits can be used to reimburse the Program Sponsor for administrative fees or to make direct payments to Fidelity or third party vendors. The Program used \$0 and \$97,100 in revenue credits to make payments to Fidelity reducing employer contributions in 2024 and 2023, respectively. The Program used \$5,165 and \$96,015 in revenue credits to offset administrative fees in 2024 and 2023, respectively. As of December 31, 2024 and 2023, the Program's revenue account had a balance of \$0 and \$5,140, respectively.

6. Income Tax Status

The Program was designed to meet the requirements of Section 401(a) of the Code and be exempt from federal income taxes under Section 501(a) of the Code. The Program received a favorable tax determination letter from the IRS dated December 30, 2015, indicating that the Program is in compliance with the applicable requirements of Section 401(a) of the Code and is exempt from income taxes under Section 501(a) of the Code. The Program has been amended since receiving the determination letter, however the Program Administrator believes that the Program is currently designed and operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires the recognition of a tax liability or asset if the Program has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Program has analyzed the tax positions taken by the Program and has concluded that as of December 31, 2024 and 2023 there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure within the financial statements. The Program is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Program is no longer subject to income tax examinations for years prior to 2020.
