## **YKK BENEFIT PLAN NOTES TO FINANCIAL STATEMENTS**

### **1 – Description of the Plan**

The following description of the YKK Benefit Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

#### **General**

The Plan is a contributory employee welfare benefit plan which was established to provide certain life and disability benefits and for the payment or reimbursement of specified medical, dental, and prescription drug expenses incurred by eligible participants and their covered dependents, as defined. The Plan provides non-contributory welfare benefits to eligible participants and their covered dependents, as defined, including travel accident insurance, dependent scholarships, professional assessment and referral benefits, and other such select benefits. The Plan also provides non-contributory disease management, wellness, and related products and services to eligible participants and their covered dependents, as defined. Additionally, the Plan offers continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA).

All active full-time employees, as defined, who have met the service requirement for coverage, which is generally one month, are eligible to participate in the Plan. The following companies participate in the Plan: (1) YKK Corporation of America (YCA); (2) YKK (U.S.A.) Inc.; and (3) Tape Craft Corporation (Tape Craft) (collectively, the Company). Tape Craft employees and their covered dependents only receive prescription drug and certain life and disability benefits associated with the Plan. The cost of coverage for former employees participating in accordance with rights granted by COBRA is paid by the individual participant.

The YKK Benefit Plan Trust (the Trust), was established pursuant to Section 501(c)(9) of the Internal Revenue Code of 1986 (the Code). The Plan and the Trust are subject to certain provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Insured Benefits**

The Plan offers three health plans that participants can choose. The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company from the general assets of the Company.

**1 – Description of the Plan (continued)**

**Claims Administration**

The administration and payment of eligible claims are performed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of employees and covered dependents and are then reimbursed by either the Trust or the general assets of the Company. The Company compensates claims from administrators for services provided based on the number of active participants and other costs approved for payment. Despite the Plan's utilization of third-party claim processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM), which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

**Experience-rated Contracts**

Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year. They may result in a premium surplus or deficit. The Plan is not required to maintain a premium stabilization reserve with an insurance company.

**Stop Loss Coverage**

The Plan has entered into stop-loss insurance arrangements to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Contributions and Funding Policy**

Participant contributions to the Plan are determined annually by the Company based on coverage selections. All claims and other costs not funded by participant contributions are funded by contributions from the general assets of the Company or by the Trust.

**Plan Termination**

The Company expects to continue the Plan indefinitely, but reserves the right to suspend or terminate the Plan. However, no amendment or termination will be retroactive or will reduce payable Plan benefits before the later of the date of the amendment or the date the termination is adopted, or unless the law permits otherwise.

**Plan Termination (continued)**

If the Plan is terminated, the Company may use Plan assets to pay covered expenses and Plan expenses. Any remaining assets will be allocated according to the Board of Directors' resolution.

**2 – Summary of Significant Accounting Policies**

**Recent Accounting Pronouncements**

As of December 31, 2024, there were no new accounting pronouncements that had or were expected to have, including those not yet adopted, a significant impact on the financial statements or disclosures of the Plan.

The Plan assessed recent accounting pronouncements, noting none that would impact the financial statements or notes to the financial statements.

**Basis of Presentation**

The Plan's financial statements are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

**Payment of Benefits**

Premiums paid by the Company are recorded as premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits. Claims payments are recorded when paid by the third-party claims processor.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**2 – Summary of Significant Accounting Policies (continued)**

**Benefit Obligations**

The Plan's actuary estimates benefit obligations for health claims incurred but not yet paid in accordance with accepted actuarial principles. Actual claims incurred may differ from estimated claims.

**Administrative Expenses**

Pursuant to provisions of the Plan, expenses incurred in the administration of the Plan may, but need not, be paid by the Company. If the Company elects not to pay such expenses, these expenses are paid by the Plan.

**3 – Fair Value Measurements**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**3 – Fair Value Measurements (continued)**

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds*—These investments are public investment vehicles valued at quoted market prices in an active market, which represent the fair value of shares held by the Plan at year's end.

**4 – Information Certified by the Qualified Institution**

All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investment, and dividends and other income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Truist, the trustee of the Plan.

**5 – Income Tax Status**

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service dated May 1, 1989, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Code as a Voluntary Employee Beneficiary Association. However, as a result of the Plan’s funding policy, the Trust is subject to income taxes. Accordingly, for the year ended December 31, 2024, the Plan paid federal and state income taxes totaling approximately \$36,000 associated with unrelated business taxable income.

**5 – Income Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no such audits in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**6 – Reinsurance Policies**

YCA maintains reinsurance policies with National Union Fire Insurance Company of Pittsburgh (ICP) and YKK Insurance Company of America (ICA), an affiliate of YCA. The ICA policy covers instances in which medical health claims for an eligible participant exceed \$250,000. In addition to the \$250,000, the policy requires a \$250,000 aggregate deductible to be met before YCA is eligible to receive payment. Payments are only for amounts that exceed these thresholds. Individual participants' claims in excess of \$750,000 are only covered by ICP.

For the years ended December 31, 2024 and 2023, there were medical health claims incurred by the Plan in excess of the above stated deductibles. Accordingly, as of December 31, 2024 and 2023 the amount due from ICA to YCA for medical claims paid totaled \$118,729 and \$294,351, respectively. There were no individual participant claims in excess of \$750,000 for the year ended December 31, 2024.

**7 – Risks and Uncertainties**

The Plan invests in mutual funds. Investments in mutual funds are exposed to various risks such as market and credit risks. Due to the level of risk associated with mutual funds, it is at least reasonably possible that changes in the values of the Plan's investments in the mutual funds will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**8 – Subsequent Events**

The Plan has evaluated events subsequent to December 31, 2024 and through August 18, 2025, the date the financial statements were available to be issued, and determined that there were no events that require adjustments to these financial statements.
