Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Telapex, Inc. Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: Description of Plan

The following description of the Telapex, Inc. Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Telapex, Inc. and Subsidiaries (the Company) who have performed 30 days of service and are age 21 years or older. Participants become eligible in matching and discretionary contributions after one year of service, providing they worked at least 1,000 hours during the plan year. An employee becomes a participant of the Plan on the first day of the month coinciding with or next following date after completing 30 days of service. Active participation ceases upon termination of employment. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Members of senior management of the Company serve as the Plan Administrator and oversee the activities of the Plan. Empower Annuity Insurance Company (Empower), formerly Great-West Company, LLC (Great-West) is the Custodian of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions (net of any forfeitures of terminated participant's nonvested accounts) and plan earnings. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined by the agreement. Principal and interest are paid ratably through monthly payroll deductions.

Contributions

Employees may elect to contribute to the Plan not less than 1% nor more than 15% of their compensation. Unless employees make a contrary election, 2% of their compensation is automatically withheld and contributed to the Plan. The Plan allows both Pre-Tax and Roth employee and rollover contributions.

Each year, the Company contributes to the Plan an amount as determined by the sole discretion of the employer. Employer contributions shall be allocated, pursuant to the provisions of the Plan, to each participant's account in the proportion that such participant's eligible compensation bears to the total eligible compensation of all participants for the plan year. The Company elected to contribute profit sharing contributions of 2% of compensation for all eligible employees that were employed as of December 31, 2024 and 2023. Additionally for 2024 and 2023, the Company elected to match discretionary contributions made by employees up to 4% of their compensation. Contributions are subject to certain limitations.

Participant Investment Account Options

Upon enrollment in the Plan, a participant may direct contributions in any of several investment options.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in the remainder of their accounts 20% per year of service after one year and are fully vested after five years of service. There is no partial vesting during the first year of service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his account or installment payments. Participants may withdraw all or any part of their vested account balance after having attained age 59 1/2.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$224,227 and \$144,763, respectively. These accounts will be used to reduce future employer contributions. Employer contributions were reduced by \$209,723 and \$106,342 in 2024 and 2023, respectively, from forfeited nonvested accounts.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts, and the assets of the fund, after payment of expenses, shall be distributed to the participants.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Empower. This prototype plan document has been filed with the appropriate agency. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Code.

Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The quality and reliability of the information used to determine fair value is ranked via a three-level hierarchy. The ordering of the priority reflects the degree to which objective prices in external active markets are available to measure fair value. The levels are defined as follows:

- Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The valuation methodologies and inputs used for instruments measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits are described below. There have been no significant changes in the valuation techniques during 2024 or 2023.

- The Plan's investment securities consist of mutual funds and participant-directed brokerage accounts. Fair value is obtained from the quoted price on the active market on which the individual securities are traded placing them in Level 1 of the valuation hierarchy.
- The Plan holds no Level 2 or 3 investments.
- In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (NAV) or its equivalent are not classified in the fair value hierarchy but may be presented in the fair value table to permit reconciliation to the line items presented in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Income Recognition

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain administrative functions for the Plan are performed by officers or employees of the Company. No such officer or employee receive compensation from the Plan. Expenses of maintaining the Plan may be paid by the Company or the Plan at the Company's discretion.

Note 3: Certification of Plan Custodian

Under the terms of the Trust Agreement, Empower administers a trust fund on behalf of the Plan. The investments and changes therein of this trust fund have been reported to the Plan by Empower as having been determined through the use of fair values for all assets and liabilities of the trust fund.

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure. Accordingly, Empower, the Custodian of the Plan and a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Party-in-interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons. The Company provides certain administrative services at no cost to the Plan.

The Plan paid \$354,622 and \$201,473 of recordkeeping fees to Empower (formerly Great-West) during 2024 and 2023, respectively.
