INDEPENDENT AUDITOR'S REPORT

To the Retiree Committee of the
Budd E&A VEBA Plan

Opinion

We have audited the accompanying financial statements of the Budd E&A VEBA Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of changes in benefit obligations of the Plan as of December 31, 2024 and 2023, and the change in its net assets available for benefits and of changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the Budd E&A VEBA Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

General - The Plan was established in 2016 by a Voluntary Employee Benefits Association (VEBA) Committee consisting of five Retiree Committee members. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides medical, prescription drug, dental, and life insurance benefits for eligible participants. Medical, prescription drug and life insurance benefits under the Plan are fully-insured, while dental benefits under the Plan are self-funded. The Plan also provides Medicare Part B premium reimbursements.

Funding Policy - The Plan was initially funded with a \$70,000,000 contribution from ThyssenKrupp North America, Inc. (TKNA). This initial funding resulted from a settlement agreement between TKNA and the Section 1114 Committee of Executive and Administrative Retirees (1114 Committee), whereby TKNA agreed to pay \$70,000,000 into a trust to resolve claims by the 1114 Committee against The Budd Company (Budd) in its Chapter 11 bankruptcy. The Plan also receives funding from ongoing contributions made by Plan participants.

Eligibility - Former executive and administrative employees of Budd, who were retired and receiving post-retirement benefits from Budd as of March 31, 2014 and July 31, 2016, and their eligible dependents, participate in the Plan. The Plan is closed to new participants.

Termination - In the event the Plan is terminated, the Retiree Committee (the Committee) shall use any remaining funds to satisfy existing and arising claims for benefits under the terms of this Plan and to pay reasonable administrative expenses until such funds are exhausted.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, IBNR (incurred but not reported), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determine the Plan's valuation policies utilizing information provided by its investment advisers. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk - Financial instruments that potentially subject the Plan to concentrations of credit risk consist primarily of cash. The Plan currently keeps its cash accounts with one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 in a single financial institution. As of December 31, 2024, the Plan had no cash balances in excess of federally insured limits.

Administrative Expenses - Administrative expenses are paid by the Plan.

Other Plan Benefits - Plan obligations as of December 31, 2024 and 2023 for claims incurred but not reported, net of amounts currently payable, are estimated by the Plan's management based upon the historical experience of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Stop-Loss Insurance - Premiums for stop-loss insurance are included in the benefits paid to participants in the accompanying statements of changes in net assets available for benefits. During the years ended December 31, 2024 and 2023, the Plan paid \$-0- in stop-loss premiums and received \$401 in refunds from claims paid.

Reclassifications - Certain reclassifications may have been made to conform to current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits.

NOTE 3. POSTRETIREMENT BENEFITS

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to participants' service rendered to the valuation date, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for currently retired or terminated employees and their beneficiaries and dependents.

The actuarial present value of the expected postretirement benefit obligations is determined by an independent actuary and is that amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, withdrawal or retirement) between the valuation date and the expected date of payment. The actuarial present value of the expected postretirement benefit obligations is net of the actuarial present value of estimated future contributions, for postretirement benefits, expected to be received from participants based on the terms of the Plan document.

The following economic assumptions were used in valuing the liabilities and benefits under the plan.

Discount Rate: 5.50% at December 31, 2024 and 5.00% at December 31, 2023.

Mortality: Headcount-Weighted RP-2006 Healthy Annuitant Mortality Table, projected to 2024 using Scale MP-2021.

Retiree Contribution Increase Rate:	No annual increase in any required retiree contribution was assumed.
Administrative Expenses:	An administrative expense load of \$472 per participant increasing at 6.0% per year was added to projected incurred claim costs in developing the benefit obligations.
Per Capita Cost Development:	
Medicare Medical and Drugs:	Per capita costs were based on the premiums for the valuation year. For the Medicare plan, actuarial factors were applied to the premium to estimate individual retiree and spouse costs. They are no longer adjusted by age and sex.
Dental:	Per capita costs were based on actual paid claim experience furnished by the Plan Administrator for the period January 1, 2022 through December 31, 2024. Claims were separated by plan year, then adjusted as described above (except for the age and gender factors) to yield per capita expenses.
Administrative Expenses:	Administrative expenses were based on experience furnished by the Plan Administrator for the period January 1, 2022 through December 31, 2024. Expenses were separated by plan year, then adjusted as described above to yield per capita expenses. Per capita expenses for each plan year were then combined by taking a weighted average.
Per Capita Health Cost:	The annual per capita dental and pre-Medicare medical and prescription drug claims cost for plan year 2025 was estimated to be \$792 and \$29,057, respectively. These costs are net of deductibles and other benefit plan cost sharing provisions.

Using trend rates 1% higher than the assumed health care cost trend rates will increase the APBO to \$67,942,432 as of December 31, 2024, an increase of \$4,495,274 over the reported number.



NOTE 3. POSTRETIREMENT BENEFITS (CONTINUED)

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

NOTE 4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4. INVESTMENTS AND FAIR VALUE MEASUREMENTS (CONTINUED)

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Short-term investments: Valued at cost, which approximates fair value.

Mutual funds: Valued at the net asset value (NAV) of shares held by the fund at year end.

Limited partnerships: The fair values of limited partnerships recorded by the Plan are determined from financial statements received by the Plan from the limited partnerships or other entities in which the Plan has invested. Some of these financial statements are financial statements audited by independent accountants other than the Plan's independent auditors and some are unaudited financial statements. In addition, most of these investment vehicles operate as "fund of funds" which invest in limited partnerships and other nonmarketable investments. The entities in which the Plan invests prepare their financial statements stating their investments at fair value as determined in good faith by the general partner or by a third-party valuator based on the best information available, in the absence of readily ascertainable market values.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investment in the limited partnership category consists of Western Asset US Intermediate Plus. This investment seeks to generate attractive returns through long-term opportunistic investments in commercial mortgage-backed securities. These investments are subject to various restrictions on redemption and frequency.



NOTE 5. PLAN CONTINUATION

The Plan is designed and maintained by a five-member VEBA committee (the Committee) as set forth in the trust agreement for the Budd E&A VEBA (the Trust). It is the present intent of the Committee to continue the Plan for an indefinite period. Although it has not expressed any intention to do so, the Committee reserves the right at any time to terminate the Plan in whole or in part subject to applicable law. In the event of termination, the assets then remaining in the Plan shall continue to be used and applied for the payment of benefits incurred prior to termination, the payment of reasonable and necessary expenses incurred in connection with such termination, the payment of taxes, or as permitted by applicable law.

NOTE 6. TAX STATUS

The assets of the Plan are held in the Trust. By letter dated October 21, 2016, the Internal Revenue Service (IRS) determined the Trust was exempt from federal income tax under Internal Revenue Code Section 501(c)(9).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for this plan year.

NOTE 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As disclosed in Note 2, the Plan pays certain administrative, investment and professional fees to various service providers. In addition, Central Data Services (CDS) is recordkeeper for the Plan. These transactions are party-in-interest transactions under ERISA.

NOTE 8. RISKS AND SIGNIFICANT UNCERTAINTIES

The Plan invests in various investment securities (mutual funds). Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.



NOTE 9. SIGNIFICANT PLAN AMENDMENTS


