## Notes to Financial Statements

### December 31, 2024 and 2023

#### 1. Description of Plan

The following description of Mercedes-Benz Financial Services USA LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a noncontributory defined contribution plan established effective August 1, 2007, as restated January 1, 2015. The Plan covers all employees of Mercedes-Benz Financial Services USA LLC (the "Company"), who are employed by the Company as of the end of the Plan year and have 1,000 hours of service. Effective July 1, 2015, the Plan was amended to revise the definition of covered employee and participant provisions to generally freeze the Plan with respect to new entrants, subject to certain conditions as defined. The Plan requires a participant to be employed as of year end to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

##### Employer Contributions

There are no participant contributions or related Company matches under provisions of the Plan. The Company has established the Plan to supplement existing benefits that are afforded to eligible participants under other defined contribution plans sponsored by the Company. However, Company contributions are discretionary and are based on a percentage of the participant's compensation, as defined in the Plan document. The percentage is determined as of December 31 of the Plan year and is based upon the participant's age and other criterion defined in the Plan document. The employer contributions ranged from 2% to 13% for the year ended December 31, 2024.

##### Participant Accounts

Each participant's account is credited with the participant's respective Company contribution and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Vesting in the Company's contribution is based on years of continuous service. A participant is 100% vested after three years of credited service. A participant who was employed by affiliates of Daimler Chrysler AG on August 1, 2007 will be credited for prior service for purposes of vesting. Additionally, a participant becomes 100% vested if the participant becomes totally disabled, dies, reaches age 65 while employed by the Company, or terminates employment with the Company on or after attaining age 55.

##### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of a lump sum cash payment.

##### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$301 and \$290, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts.

#### 2. Summary of Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### December 31, 2024 and 2023

#### Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

#### Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through September 12, 2025, the date when the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments Measured at Net Asset Value:* Consisting of common-collective trusts at December 31, 2024, are valued NAV of units of a bank collective trust. NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's investments at fair value as of December 31, 2023, consist of interest in commingled employee benefit funds, which are measured using NAV as a practical expedient for fair value. Interests in commingled employee benefits funds are valued based on the NAV of the shares held by the Plan at year end, which is based on the unit prices quoted by the fund, representing the fair value of the underlying investments. The NAV is a quoted price in a market that is not active and is used as a practical expedient to approximate fair value.

**Fair Value of Investments that Calculate Net Asset Value**

There were no significant unfunded commitments or restrictions on redemptions related to the common-collective trusts at December 31, 2024 and interest in commingled employee benefit funds at December 31, 2023. Redemption of common-collective trusts and interest in commingled employee benefit funds can occur at any time and no notice period is required.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. Information Certified by Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Voya Institutional Trust Company, the current Trustee of the Plan, has certified the completeness and accuracy of all investments reported in the accompanying statement of net assets available for benefits, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the period from November 1, 2024 through December 31, 2024. Russell Investments Trust Company, the previous Trustee of the Plan, has certified the completeness and accuracy of all investments reported in the accompanying statement of net assets available for benefits as of December 31, 2023, and the related investment activity reported in the statement of changes in net assets available for benefits for the period from January 1, 2024 through October 31, 2024.

#### **5. Related-Party and Party-in-Interest Transactions**

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **7. Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated August 24, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, four investments represented a concentration of greater than 10% of the Plan's net assets available for benefits.
