NOTE 1      Description of plan

The following brief description of the Golden Technologies 401(k) Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution profit sharing plan covering employees of Golden Brothers, Inc. T/A Golden Technologies, Inc. (the "Company") who have attained age 21 and completed one year of service (a minimum of 1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The administrator of the Plan is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Participants in the Plan may elect to defer a portion of their pretax earnings by up to the maximum amount which will not cause the Plan to violate the provisions of maximum annual addition and allocation requirements of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for non-elective matching contributions by the Company equal to 50% of each dollar contributed by the participant up to 4% which amounts to a maximum of 2% of each participant's compensation.

The Plan also provides for a discretionary profit-sharing contribution to the Plan for all eligible participants. The Company elected not to make this contribution to the Plan in 2024.

Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account balance is maintained separately and is credited with the participant's contributions, including rollovers and company non-elective matching contributions, and allocations of the Company's profit-sharing contributions, if any, and Plan earnings, and charged with allocations of plan losses and certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants self-direct the investments in their own accounts.

#### Vesting

Participants are always 100% vested in their voluntary contributions and rollovers plus actual earnings thereon. Vesting for the Company contributions and earnings thereon is according to the following schedule:

#### Payment of Benefits

Withdrawals are allowed under the following circumstances:

(a) termination of employment, (b) retirement, (c) attainment of age 59 ½, (d) disability, (e) death, and (f) financial hardship. Distributions under the Plan are payable at the election of participants (or their beneficiaries in the case of death during active employment) in one lump-sum payment or in substantially equal installments to the value of the participant's vested interest in his or her account.

#### Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures are used in any permissible method including: restoring forfeitures, reducing Company contributions (or reallocating as Company contributions) or paying Plan expenses, as defined. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,542 and \$10,725, respectively. In 2024, employer contributions were not reduced by forfeited nonvested accounts.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Currently certain administrative fees, including custodial fees, are borne by the Plan. Professional fees for audit services and third-party administrator quarterly fees are borne by the Company. Investment related expenses are included in net appreciation of fair value of investments.

#### NOTE 2      Significant accounting policies

##### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefits

Benefits are recorded when paid.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, and custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

SECURE 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

**NOTE 3**      Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair market value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts* – Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based upon the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions. Transactions occur daily in and out of the accounts.

*Guaranteed accumulation fund* - Funds are also held in guaranteed accounts, which invest in investment grade corporate bonds, government bonds and mortgages. These investments are carried at approximate fair value, as reported by the custodian. With respect to the guaranteed accounts, the custodian establishes the rates on the first day of each calendar month on which is pays interest for the specified terms. The fair value of the guaranteed account is based on those rates. Guaranteed rates for the ten-year, five year and three-year guaranteed funds were 3.45%, 3.40% and 3.30% for 2024 and 2.85%, 2.95% and 3.05% for 2023. Interest was credited at rates ranging from 3.30% to 3.45% for 2024, with maturities ranging from 2025 through 2033. The crediting interest rate is based on a formula agreed upon with the issuer. The guaranteed interest rate is reviewed annually for resetting.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the year ended December 31, 2024, there were no transfers into or out of Level 3. There are no plan assets requiring the use of Level 3 inputs for the period presented.

**NOTE 4**     Tax status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 6 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 7 Net assets available for benefits

Net assets available for benefits at December 31, 2024 and 2023 include \$556,782 and \$583,323, respectively, allocated to accounts of participants who are no longer employed by the Company and their balances remain in the Plan at December 31, 2024 and 2023.

#### NOTE 8 Related party and party in interest transactions

Certain Plan investments consist of shares of pooled separate accounts and a guaranteed accumulation fund managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

John Hancock Life Insurance Company (U.S.A.), the custodian, provides certain administrative services to the Plan pursuant to a service agreement between the Company and the custodian. The custodian receives revenue from service providers for services the custodian provides to the investments. This revenue is used to offset certain amounts that would be owed to the custodian from the Plan for its administrative services to the Plan had the arrangements with the service providers not been in place.
