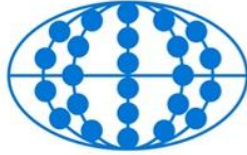

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Alpha EMS Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Alpha EMS Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE TO FINANCIAL STATEMENTS

NOTE A -DESCRIPTION OF PLAN

The following description of the Alpha EMS Corporation (**the Organization, Employer, Company**) 401(k) plan (**the Plan**) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was established as a defined contribution plan on April 1, 2011 and is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(k) of the Internal Revenue Code of 1986 (IRC). Substantially, all employees of the Organization are eligible to participate upon completing the Plan's eligibility requirements. The Plan is a Safe harbor 401(k) Plan and allows participants to save a portion of their eligible pay in the Plan. As a "Safe harbor" Plan, the Organization must include a mandatory contribution to satisfy certain nondiscrimination requirements under the IRC.

Plan Administration – The Organization is the administrator of the Plan. As administrator, the Organization has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Ascensus was appointed custodian for the Plan in current year and Newport Trust Company was custodian for the Plan this year and prior year before the change in appointment, and acted at the direction of the Plan's administrator.

Eligibility Requirements – Age 21 within the Plan year is required for employee Salary Deferral, Employer Profit Sharing Contributions, Employer Match Contributions and Safe Harbor Employer Match Contributions. Union members, non-resident aliens and part-time employees working under 1,000 hours a year are excluded from participation in the plan. There are no service period requirements for participation in the plan.

Employee Contributions – Participants may have Salary Deferral and/or Roth up to 96% of total annual compensation as defined in the plan. If participants are 50 or older before the end of the plan year, participants may make catch up contributions. Participants can change the amount of their payroll deduction and/or stop making contributions to the Plan any time.

Safe Harbor Employer Match Contribution – The Employer has chosen to make a Safe Harbor Employer Match contribution to all eligible employees in the amount of 100% of participants' salary deferrals up to 3% of their compensation, plus 50% of their salary deferrals in excess of 3% of participants' compensation, capped at 5% of their compensation. Salary deferrals in excess of 5% of their compensation will not be matched.

Employer Match Contribution – The Employer has the option to make a Matching Contribution with the amount determined annually. During the year ended December 31, 2024, the employer made a \$259,584 match contribution to the Plan.

Employer Profit Sharing Contribution – The Employer has the option to make a Profit-Sharing Contribution with the amount determined annually. During the year ended December 31, 2024, the employer made profit-sharing contributions to the Plan.

Contributions are subject to certain Internal Revenue Service limitations.

Vesting Schedule – Employee deferrals and Safe Harbor Match plus actual earning thereon are always 100% vested. Vesting in the Employer Profit Sharing portion of their accounts is based on 1 year 0%; 2

years 20%; 3 years 40%; 4 years 60%; 5 years 80%, 6 years 100%. Participants must work 1,000 hours in a plan year for their vesting to increase. Participants are always 100% vested if they are employed on or after their normal retirement age or if they die or become disabled.

Withdrawals – Participant may request an in-service distribution of their Salary Deferral Account in the event of financial hardship.

Distributions – Distributions of a rollover account are available at any time. At age 59 ½, participants may also request an in-service distribution from all sources for any reason.

At termination of employment, upon request from terminated participant, distribution is paid as soon as administratively possible following participant's termination.

All distributions are subject to a \$75.00 fee paid by the participant.

Rollovers – Allowed from most types of qualified retirement plans – 401(k), Defined Benefit Pension and IRA's.

Investment Options – Upon enrollment in the Plan, a participant may direct his or her contributions in percentage increments into a series of mutual funds offered by the Plan. Participants may change their investment options at any time.

Participant Accounts – Each participant's account is credited with the participant's contributions, Employer contributions, Plan earnings or losses, and rollovers from other qualified plans. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings account balances or specific participant transactions as defined. Certain fees are charged to the fund investments and are offset against the Plan investment income or loss as presented on the statement of changed in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to their Plan and their individual accounts.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Expenses

Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Forfeited Accounts

During the years ended December 31, 2024 and 2023, none of the non-vested participant account balances from prior years were forfeited.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from participants

Participant loans are not permitted in this plan.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisor and custodian. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus.

NOTE C- FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels as described by authoritative guidance:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Significant observable inputs other than quoted prices in active markets for which inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE D- PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to termination the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE E- TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision has been made for federal or state income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by various taxing jurisdictions. There are currently no audits for any tax period as of the date the audit report was ready to be issued.

NOTE F- RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments in mutual funds are managed by Ascensus, the Custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulation, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. The Plan paid \$1,885 of recordkeeping fees to custodian during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

NOTE G- RISKS, UNCERTAINTIES AND CONCENTRATIONS

The Plan invests in various investment options in any combination of mutual funds offered by the Plan. Investment securities are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024, approximately 28% and 23% of the Plan's investments were invested in the Fidelity Government Money Market and the Vanguard Wellesley Income Inv Fund respectively.
