### **Independent Auditors' Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of Carver Companies Profit Sharing/401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Carver Companies Profit Sharing/401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes To Financial Statements

### **Note 1: Description Of Plan**

The following description of Carver Companies Profit Sharing/401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Carver Companies Profit Sharing/401(k) Plan was established to provide retirement benefits for substantially all employees of Carver Construction, Inc. and its Affiliates, collectively referred to as "the Company." Eligible employees may become participants in the Plan following 90 days of eligible service and attainment of age 21, as defined in the Plan Agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) (see Note 9).

Contributions - Each year, participants may contribute up to 100% of annual compensation, subject to Internal Revenue Code limitations as defined by the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will make a safe harbor matching contribution equal to 100% of participant salary deferrals that do not exceed 3% plus 50% of participant salary deferrals between 3% and 5% of compensation. The Company also may make a discretionary profit sharing contribution as determined each year. For the years ended December 31, 2024 and 2023 the profit sharing contribution was calculated at two thirds of each contribution made up to 6% of eligible compensation.

Participants' accounts - Each participant's account is credited or charged, as applicable, with the participant's contribution and allocations of the Company's contribution, plan earnings (losses), payments, forfeitures, withdrawals, expenses, or other distributions made to or from such accounts during the period. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting - Participants are immediately vested in their contributions and any safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing portion of their accounts is based on years of continuous service. As defined by the Plan Document, a participant is 100% vested after six years of credited service.

Payment of benefits - On termination of service or separation from service, due to death, disability, or retirement, a participant or their beneficiary will be entitled to receive an amount equal to the value of the participants' vested interest in their account balance. Benefits will be paid in accordance with the terms of the Plan.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans must be adequately secured and made in accordance with the terms of the Plan. Principal and interest is paid ratably through weekly payroll deductions.

### **Note 1: Description Of Plan (Continued)**

Plan termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Forfeited accounts - At December 31, 2024 and 2023, the Plan had forfeitures from terminated, non-vested participant accounts of \$43,055 and \$77,296, respectively. These amounts can be used to pay for Plan expenses or reduce employer contributions. The Company used forfeitures to pay for Plan expenses and reduce employer contributions during the years ended December 31, 2024 and 2023 of \$285,934 and \$145,952, respectively.

Expense budget account - The expense budget account was established for the purpose of paying plan expenses, and is considered a plan holding included in the stable value investment option. The expense budget account amounted to \$-0- at December 31, 2024 and 2023. Plan expenses paid from the account during the years ended December 31, 2024 and 2023 amounted to \$-0- and \$7,204, respectively.

### **Note 2: Summary Of Significant Accounting Policies**

Investment valuation and income recognition - Accounting principles generally accepted in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 and Level 2 inputs are not available. The three levels of the fair value hierarchy in accordance with accounting principles generally accepted in the United States of America are described below:

Level 1: Unadjusted quoted prices in active markets for identical, unrestricted assets, or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability; and

Level 3: Significant unobservable prices or inputs (including the Plan's own assumptions in determining the fair value of investments) where there is little or no market activity for the asset or liability at the measurement date.

### **Note 2: Summary Of Significant Accounting Policies (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The accompanying financial statements are presented on the accrual-basis of accounting. Purchases and sales of securities are recorded on a trade-date basis with the gain or loss based upon the actual cost of the securities. Interest income is recorded on the accrual-basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has adopted a prototype plan which has an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on net assets available for benefits or changes in net assets available for benefits.

### **Note 3: Investments**

The statements of net assets available for benefits, the investment activities included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to the financial statements (other than the assignment of levels), were prepared in part or entirely from information certified by Reliance Trust Company, the Custodian of the Plan from January 1, 2023 through June 30, 2024, and Transamerica Trust Company, the Custodian of the plan from July 1, 2024 through December 31, 2024, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments and notes receivable from participants of \$41,324,827 and \$34,490,406 at December 31, 2024 and 2023, respectively, and related investment income of \$5,151,139 and \$5,012,789 for the years ended December 31, 2024 and 2023, respectively.

### **Note 4: Fair Value Measurements**

The following is a description of the valuation methodologies used for assets at fair value at December 31, 2024 and 2023:

*Mutual Funds:* Valued at quoted market prices.

*Stable Value Fund:* Valued at the NAV of units held by the Plan at the reporting date. The NAV is used as a practical expedient to estimate fair value. The Transamerica Stable Value Core Account seeks to provide maximum returns consistent with a guarantee of principal. Participant transactions may occur daily.

The preceding methods may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### **Note 5: Related Party Transactions**

Certain fees for administrative services may be paid by the Company. Certain plan investments were managed by Reliance Trust Company and are managed by Transamerica Trust Company as denoted on the supplementary Schedule Of Assets (Held At End Of Year). Reliance Trust Company and Transamerica Trust Company is the Custodian for the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

### **Note 6: Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

### **Note 7: Commitments And Contingencies**

The Plan follows the guidance for uncertainty in income taxes. As of December 31, 2024, the Plan believes that it has appropriate support for the income tax positions taken and to be taken on its returns based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

#### **Note 9: Partial Plan Termination**

Upon full or partial termination of a plan, affected participants become fully vested in their account at the termination date. Based on IRS rules, a partial termination generally occurs if approximately 20% or more of plan participants are terminated as a result of action taken by the plan sponsor. During the year ended December 31, 2024, the Company transferred 100% of their interest in an affiliate to a related company. Subsequent to the transfer of interest, the affiliate was sold. As a result of a reduction of Carver Companies Profit Sharing/401(k) Plan's workforce during the year ended December 31, 2024, the Plan experienced a partial plan termination, and all affected participants became fully vested in their account balances.
