INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator
Lifeway Mobility 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lifeway Mobility 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Lifeway Mobility 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Lifeway Mobility Holding, LLC, and its participating affiliates (collectively, the “Company”) who have completed at least one month of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective April 2022, the Company purchased Accessible Systems, Inc., which joined the plan in April 2023. Effective April 2023, the Plan was amended to provide credit for prior service to the following: Accessible Systems Kansas City, Accessible Systems Denver LLC, Accessible Systems LLC, Accessible Systems Colorado Springs, Accessible Systems Dallas, Accessible Systems Northern Colorado LLC, Accessible Systems Utah LLC, and Accessible Systems Wichita.

Contributions: Each year, participants may contribute 100% of eligible compensation, as defined in the Plan. Prior to January 1, 2023, employees were automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan, with the option to change or discontinue deferrals at any time. Effective January 1, 2023, the Plan was amended to eliminate automatic enrollment. Participants may direct their contributions as either pre-tax or Roth contributions. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, Participants may also contribute amounts representing distributions from other qualified plans.

The Company, at its discretion, may make matching contributions. For the year ended December 31, 2024, the Company made a matching contribution of 100% of each participant’s contributions, up to 3% of eligible compensation.

The Plan also contains a discretionary profit sharing provision as determined annually by the Company’s Board of Directors. For the year ended December 31, 2024, the Board of Directors did not elect to make a discretionary profit sharing contribution. All contributions are subject to certain limitations under the Plan and applicable law.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions, (b) Plan earnings, and (c) forfeitures of employer contributions, and is reduced by their withdrawals and allocations of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is limited to the vested balance of the participant’s account. Participants may direct the investment of their accounts among the investment options offered under the Plan.

Retirement, Death and Disability: Participants are entitled to 100% of their account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their deferral and rollover contributions, plus actual earnings thereon. Vesting in the Company’s contributions is based on years of continuous service. Participants become 100% vested in matching and discretionary profit-sharing contributions after five years of credited service.

Payment of Benefits: Upon termination of service, a participant is eligible to receive the value of their vested account balance. Benefit amounts under \$5,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may only receive their vested account balance as a single lump sum. In certain circumstances, participants may make hardship withdrawals, as defined in the Plan. In addition, active participants may elect to take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loans are secured by the participant's account balance and bear interest at rates commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Forfeitures: Forfeited non-vested matching and profit-sharing accounts may be used to offset future employer contributions or to pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested account balances totaled \$9,661 and \$1,049, respectively. During the year, forfeitures of non-vested accounts totaling \$94 were used to pay administrative expenses.

Plan Termination: Although the Company has not expressed any intent to do so, it reserves the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan, subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and contract administrator fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan and are reflected as a reduction of investment return within net appreciation in fair value of investments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value represents the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's realized and unrealized gains and losses on investments.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments that are exposed to risks such as interest rate, market, liquidity, and risks pertaining to global events. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 24, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 inputs) and gives the lowest priority to unobservable inputs (Level 3 inputs).

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per unit, with no advance notice requirement.

Money Market and Mutual Funds: The fair values of money market and mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

For the year ended December 31, 2024 and 2023, the majority of the Plan's collective trusts were invested in the MetLife Group Annuity Contract or short-term, high-quality fixed income investments.

NOTE 5 - TAX STATUS

Effective June 30, 2020, the Internal Revenue Service issued an opinion letter indicating that the prototype plan document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in compliance with the Internal Revenue Code and therefore, that the Plan remains qualified and the related trust remains tax-exempt.

NOTE 5 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a liability (or asset) for uncertain tax positions when it is more likely than not that the position will not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company; however, no such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds collective trust accounts managed by Fidelity, a service provider. In addition, the Plan pays fees to Fidelity for recordkeeping and administrative services. Accordingly, these transactions qualify as party-in-interest transactions under ERISA.
