### 1. Summary of Significant Plan Provisions

The following description of the Ageless Living Home Health, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Ageless Living Home Health, LLC (the “Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is administered by a committee and two trustees appointed by the Company’s board of directors. Empower Trust Company, LLC (the Custodian), holds the Plan assets, and maintains the records of the participant data.

Effective September 25, 2023, the Plan was amended for Secure and Cares Act for the following: allow distributions up to \$5,000 for qualified birth or adoption, increase the age on required minimum distributions to age 72, disaster or coronavirus related relief that allowed distributions up to \$100,000 and expanded loan provisions, and statutory compensation will be increased by qualified foster care payments.

- b. **Eligibility** – Employees, who are not a nonresident alien, under a collective bargaining agreement, reclassified employee or leased employee are eligible to participate in the Plan upon attaining age 21 and upon hire. Plan entry dates are immediate following the date the eligibility requirements are met.
- c. **Contributions** – Participants may contribute through pre-tax deferrals, as well as rollover contributions. Participants can defer up to the limits set forth by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service limitations

The Plan also provides for discretionary Employer matching contributions. There were no discretionary Employer matching contributions elected to be made by the committee for the year ended December 31, 2024.

Additional amounts may be contributed by the Company under the Plan’s non-elective contribution provisions at the discretion of the committee. During the year ended December 31, 2024, no non-elective contributions were made.

### 1. Summary of Significant Plan Provisions (cont.)

- d. **Participant accounts** – Each participant’s account is credited with the participant’s contributions, employer matching contributions, if any, and an allocation of employer non-elective contributions and Plan earnings. Participant accounts are reduced with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are fully vested in their own contributions, plus actual earnings thereon. Matching contributions and non-elective contributions shall be fully vested upon death, disability or upon reaching normal retirement age of 65. If participants terminate employment for any other reason, they are entitled to the portion of contributions made by the Employer according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than one year	0%
One, but less than two	20%
Two, but less than three	40%
Three, but less than four	60%
Four, but less than five	80%
Five years or more	100%

- f. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested account balance or \$50,000. Note terms cannot exceed five years unless the note is for the purchase of a primary residence. The note is secured by the participant’s vested account balance and bears interest at a rate of prime plus 2%. Participants are limited to two outstanding notes at any given time. Principal and interest are paid through payroll deductions.
- g. **Payment of benefits** – Upon retirement, termination of employment, or disability, a participant or beneficiary in the event of death, may elect to receive a payment of benefits in a lump sum amount equal to the value of the participant’s vested interest in his or her account. Additionally, a participant may receive an in-service withdrawal from any portion of their account upon the age 59 ½. Secure Act 2 increased the statutory limit from \$5,000 to \$7,000 that was adopted by the Plan effective January 1, 2024. If the participant’s account balance is equal to or less than \$7,000, the balance will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant’s consent before the participant’s normal retirement age will be rolled over to an individual retirement plan designated by the Plan administrator.

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

### 1. Summary of Significant Plan Provisions (cont.)

- h. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.

### 2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. Plan management determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

- d. **Contributions** – Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.
- e. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- f. **Payment of benefits** – Benefits are recorded when paid.
- g. **Administrative expenses** – The Plan allows certain administrative expenses to be paid from Plan assets.

- c. Interest and dividends from investments and interest on notes receivable from participants, as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d. All the investment information included in the footnotes and supplemental schedules of assets held as of December 31, 2024.

### 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* These investments are valued at quoted market prices on the last business day of the Plan year.

The collective trust is stated at fair value as determined by the issuer and is based on the fair market value of the underlying investments, which is valued at net asset value (NAV) of units of the underlying investments. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it determined to be probable that the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The collective trust does have an equity wash rule that requires participants to transfer the fund to a non-competing fund.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments. The Plan also made direct payments to service providers that are included in administrative expenses in the statement of changes in net assets available for benefits.

### 7. Tax Status

The Company adopted a Non-standardized Pre-Approved Profit-Sharing Plan with CODA (the "Prototype Plan") sponsored by Hyden Miron & Foster PLLC. The Internal Revenue Service has informed the Prototype Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Prototype Plan is designed in accordance with the applicable sections of the Internal Revenue Code. The Prototype Plan's opinion letter is being relied on by the Plan. The Plan has been amended since receiving the determination letter. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

### 9. Subsequent Events

Effective May 27, 2025, the trustees elected to terminate the Plan effective May 31, 2025, due to the sale of the Company on June 1, 2025.

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024, statement of net assets available for benefits and determined there were no other significant events to report through September 24, 2025, which is the date the Plan issued its financial statements.


