INDEPENDENT AUDITOR'S REPORT

To the Board of Directors
Minnie Hamilton Health Care Center 401(k) Plan
Grantsville, West Virginia

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Minnie Hamilton Health Care Center 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by John Hancock Life Insurance Company, an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1 – DESCRIPTION OF PLAN

Plan description – The following description of the Minnie Hamilton Health Care Center 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan document for more complete information.

General – The Plan was established January 1, 2009, for the benefit of the employees of Minnie Hamilton Health Care Center (“Plan Sponsor”), and amended and restated effective August 15, 2014, to adopt the Dyatech, LLC prototype 401(k) plan. On June 1, 2018, the plan was amended and restated as adopt the CCH, Inc. prototype 401 (k) plan. An eligible person becomes a participant as of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration – A member of the Plan Sponsor has been designated as the plan administrator and as such, is responsible for providing participants with information regarding rights and benefits under the Plan. The Plan Sponsor contracted John Hancock Life Insurance Company for investment custodial and participant record keeping services.

Contributions – Participants may elect to defer a portion of their compensation or make after-tax contributions as defined in the Plan document, limited to the maximum allowed under the Internal Revenue Code for such Plan year.

The Plan requires safe harbor matching contributions equal 100% of the amount of the eligible participant’s elective deferrals that do not exceed 3% of the participant’s compensation and 50% of the amount of the participant’s elective deferrals that exceed 3% of the participant’s compensation, but do not exceed 5% of the participant’s compensation.

The Plan allows rollovers from other qualified plans.

Participant Investment Options – Each Plan participant has the right to direct contributions and earnings of their account among alternative investment funds provided under the Plan. Participants should refer to the most recent annual report of each investment fund for information on risk factors, asset concentrations, use of derivative financial instruments and other financial data.

Participant Accounts – Each participant account is credited with the participant’s elective deferrals, participant rollover contributions and any employer contributions. In addition, each participant’s account is credited with their share of appreciation/depreciation in the value of investments and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting – Participants are immediately vested in deferral contributions, employee safe harbor matching contributions and actual earnings thereon which are credited to their respective account.

Payment of Benefits – Upon retirement (normal retirement age is 65), death, disability or other termination of employment, as defined in the Plan document, participants or their spouses and/or beneficiaries receive their account as a lump sum cash payment. The Plan allows for in service withdrawals of elective deferrals and employer contributions if the participant has attained age 59 ½. The Plan also allows for hardship distributions from employer and employee contributions. Further, upon termination of employment, the participant may elect to transfer his or her account balances to another qualified plan or individual retirement account. If the participant's account balance has never exceeded \$5,000, the entire vested balance will be paid in a lump sum. Minimum distributions for a participant must begin the latter of April 1 of the calendar year after a participant attains age 70 ½ or when the participant actually retires.

Forfeited Accounts – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Any forfeitures may be used to reduce the Plan Sponsor's contributions and pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$28,888 for both years. In 2024 and 2023, \$0 in forfeitures were used to reduce employer contributions.

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.25%. Principal and interest are paid ratably through payroll deductions.

2 – SIGNIFICANT ACCOUNTING POLICIES

The accounting and reporting policies of the Plan conform to accounting principles generally accepted in the United States of America and to general practices within the employee benefit plan industry. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. The principles and policies which significantly affect the determination of net assets and the changes in net assets are summarized below:

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan's investments in pooled separate accounts are stated at fair value measured using the net asset per share practical expedient. The Plan's investment in the fully benefit-responsive guaranteed investment contract is stated at contract value, which represents contributions made, less withdrawals and administrative expenses plus interest credited.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Participants should refer to the latest fund prospectus or annual report for additional information related to mutual fund fee assessments.

The Plan does not require collateral to secure investment instruments.

Payment of Benefits – Benefit payments are recorded upon distribution.

Subsequent Events – The Plan has evaluated subsequent events through the date of the Auditor's Report, which is the date the financial statements were available to be issued.

3 – TAX STATUS

The Plan had adopted the CCH, Inc Standardized 401(k) Profit Sharing Plan as of August 15, 2014. The Plan was restated June 1, 2018, when the Plan Sponsor contracted John Hancock Life Insurance Company. CCH, Inc. has received a determination letter dated March 31, 2014, that the standardized 401(k) profit sharing plan qualifies under Internal Revenue Code Section 401(a). The determination letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Plan management evaluates tax positions taken by the Plan to determine if any uncertain tax positions exist that comprise the Plan's tax-exempt status that could result in tax obligations requiring recognition or disclosure in the Plan's tax-exempt status that could result in tax obligations requiring recognition or disclosure in the Plan's financial statements. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, state or local tax authorities, for the years before 2019.

4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participant accounts will become fully vested and nonforfeitable.

5 – PARTIES-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. During the years ended December 31, 2024 and 2023, transactions with parties-in-interest primarily include administrative expenses of \$63,288 and \$53,521, respectively, related to participant account maintenance and custodial services.

Certain other administrative expenses for legal, auditing, and other professional services are paid directly by the Plan Sponsor and certain administrative functions are performed by officers or employees of the Plan Sponsor at no cost to the Plan.

6 – CERTIFIED PLAN ASSET INFORMATION

7 – FAIR VALUE MEASUREMENT

ASC Topic 820 "*Fair Value Measurements and Disclosure*" (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Valued at net asset value (NAV), which is used as a practical expedient for the determination of fair value. The use of net asset value as fair value is derived appropriate as there are no imported redemption restrictions, and the Plan does not have any contractual obligations to further invest in the account.
