### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Garnet Health Medical Center 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## NOTES TO FINANCIAL STATEMENTS

### 1. Plan Description:

The following description of the Garnet Health Medical Center 403(b) Retirement Savings Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Garnet Health Medical Center (the "Hospital"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2021, the Garnet Health Medical Center - Catskills 403(b) Retirement Savings Plan was merged into this Plan.

The Plan has implemented certain requirements of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

#### Contributions

Each year, participants may contribute up to 100% of annual compensation, not to exceed the Internal Revenue Service ("IRS") limit, as defined in the Plan agreement. The Plan provides for Hospital matching contributions for non-union employees and Security Police and Fire Professionals of America ("SPFPA") members of 4% of the participants' annual compensation, not to exceed the participants' deferrals. The Plan allows for service based contributions by the Hospital based on certain years of service up to a maximum of 5% of compensation. To be eligible for a service based contribution, an employee must be an active participant at any time during the Plan year and have been hired or rehired before January 1, 2014. The Plan allows for employer matching contributions of 4% for the Garnet Health Doctors and an employer contribution of 6% for RN and non-union eligible employees of Garnet Health Medical Center - Catskills. Garnet Health Doctors participants who are part of 1199 Union receive an additional contribution the following year based on the amount defined in the collective bargaining agreement. Contributions are subject to certain limitations.

#### Participant Accounts

Participant accounts are maintained for each Plan participant to reflect the participant's contributions and related matching and service based contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested accounts.

#### Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested account balance. Loan terms range from one to five years, with the exception of loans for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest based on rates for similar loans from commercial lending institutions. Principal and interest are paid through payroll deductions or by direct payment to Principal Trust Company ("Principal"), and Lincoln Life and Annuity of New York ("Lincoln"), custodians of the Plan.

#### Vesting

Participants are immediately vested in their contributions and the employer service based contributions (if eligible) plus actual earnings thereon. Participants are 100% vested in employer matching contributions after 3 years of credited service. Participants employed by the Garnet Health Doctors are immediately vested in any employer matching contributions plus actual earnings thereon. Participants employed by Garnet Health Medical Center - Catskills become 100% vested in employer contributions after three years of credited service.

#### Distributions

On termination of service due to death or retirement, a participant or beneficiary may elect to receive annual installments or a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the participant's vested interest in his or her account as a lump-sum distribution.

## 1. Plan Description (continued):

### Forfeitures

Forfeitures in the amount of \$161,632 and \$126,400 were used to reduce the Hospital matching and service based contributions during 2024 and 2023, respectively. The outstanding forfeiture balance as of December 31, 2024 and 2023 was \$0 and \$89,494, respectively.

### Administration

The Plan is administered by the Hospital, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), Lincoln Life and Annuity Company of New York ("Lincoln"), and Transamerica Financial Life Insurance Company, Inc. ("TFLIC") are the custodians of the Plan.

## 2. Summary of Significant Accounting Policies:

### Basis of Accounting

The Plan uses the accrual method of accounting which recognizes income when it is earned and expenses as they are incurred.

### Pervasiveness of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains or losses on those investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest is included in the balance. Delinquent loans are treated as distributions based upon the terms of the Plan document.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

All expenses of maintaining the Plan, to the extent that the Hospital does not pay such expenses, are paid by the Plan. Participant loan setup fees and distribution fees are deducted from the proceeds paid to the initiating participants.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's investments are not insured or protected by the Plan's custodians. Accordingly, the Plan is subject to the normal investment risks associated with money market funds, mutual funds, stocks, bonds and other similar types of investments.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### Tax Exempt Status

The Plan has adopted a volume submitter plan sponsored by Principal Life Insurance Company. The volume submitter plan provider has received an advisory letter from the IRS as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

### 2. Summary of Significant Accounting Policies (continued):

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is September 5, 2025, which is the date on which the financial statements were available to be issued.

### 3. Information Certified by Custodians:

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and the supplemental schedule, that was prepared by or derived from information provided by the custodians and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal, Lincoln, and TFLIC that information provided to the Plan Administrator by the custodians related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and the supplemental schedule.

### 4. Fair Value Measurements:

Accounting principles generally accepted in the United States of America establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### 4. Fair Value Measurements (continued):

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments Measured at Net Asset Value:* Valued at a daily calculated NAV. These investments are classified as annuity contracts for reporting purposes. (See Note 6.)

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of the future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Investment Contracts:**

The Plan has fully benefit-responsive group annuity contracts with Principal and TFLIC, the custodians. The custodians maintain the contributions in a general account backed by stable value contracts and fixed income contracts. The contracts guarantee principal and provide a stated rate of return backed by the custodians.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the backed stable value contracts. Contract value, as reported to the Plan by the custodians, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The methodology for calculating the interest crediting rate for Principal is defined in Article I, Section 2 of the contract under the term "Crediting Rate." Under the terms of the existing contract, the crediting rate shown for the Fixed Income Guaranteed Option is an effective annual rate and is guaranteed by Principal net of the fees for administrative services to the plan. The Crediting Rate as of December 31, 2024 and 2023 was 1.58% and 1.72%, respectively.

The crediting rate is determined by TFLIC, but may not be less than the minimum guaranteed rate. TFLIC establishes a crediting rate for new deposits received during a calendar quarter, which will be applicable to such assets through the end of the calendar year. For other existing Fixed Fund assets, the crediting rate is established by TFLIC on a calendar year basis. The Crediting Rate as of December 31, 2024 and 2023 was 3.50% and 3.50%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) premature terminations of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan terminations, (5) bankruptcies, (6) mergers and (7) early retirement incentives. No events are probable of occurring that might limit the ability of the Plan to transact at contract value and also limit the ability of the Plan to transact at contract value with participants. The Plan itself must allow participants reasonable access to their funds.

In addition, certain events and circumstances allow the issuer to terminate the fully benefit-responsive investment contracts with the Plan and settle at an amount different from contract value. Such events include the following: (1) if the Hospital wishes to terminate the Plan's interest, the amount paid out will be the value of the Plan's interest or (2) termination will occur on the date when both no current deposit arrangements have been made between participant and issuer and there are no Guaranteed Interest Funds with a value greater than zero.

### **6. Annuity Contract:**

The Plan has an annuity contract with Lincoln. The fixed income account provides a guaranteed interest rate for a specified period of time. The rate credited is the rate in effect on the day when each deposit is directed to the account. To simplify reporting to Plan participants, all rates credited during the 12-month 'deposit year' are averaged into a single composite rate. The fixed income account promises contract value for a benefit event (termination, death, disability or retirement); however, there is a possible market value adjustment when funds are withdrawn prior to their maturity. Thus, the fixed income account is not considered benefit responsive.

### **7. Related Party Transactions:**

Certain Plan investments are managed by Principal, Lincoln and TFLIC, the custodians of the Plan; therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the custodial and recordkeeping services amounted to \$66,706 and \$58,632 for the years ended December 31, 2024 and 2023, respectively.
