### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Fraser 403B Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Fraser 403B Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Description of Plan

The following brief description of the Fraser 403B Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

#### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established during January 2005. Fraser (the "Organization" or the "Employer"), a non-profit organization with headquarters in Richfield, Minnesota, which runs a school and programs for children and adults with autism and developmental disabilities, is the Plan Sponsor. Certain Plan administrative expenses and audit fees for the Plan are paid by the Organization.

#### **Eligibility**

Based on the amended plan provisions effective January 1, 2024, all employees of the Organization are eligible to make elective deferrals and receive discretionary match contribution upon employment.

#### **Contributions**

Participants may contribute up to 100% of their eligible compensation, as defined by the Plan, subject to Internal Revenue Code (IRC) limitations. Eligible employees may designate their salary deferrals as Roth deferrals.

The Organization, at its discretion, may make a discretionary match contribution to the Plan. For 2024 as well as 2023, the Organization made discretionary match contributions of up to 3.00% of employees salary deferral to the plan.

Participants age 50 or older are allowed to make catch-up contributions as set forth in the IRC.

Participants may roll over amounts representing distributions from other qualified plans into the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions, and the Organization's contributions and Plan earnings, as set forth in the Plan. Allocations are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant may direct employee and employer contributions and account balances to a variety of investments. All investments are participant directed and the participant may change their investment allocation at any time.

#### **Vesting**

Participants are immediately vested in their salary deferral contributions and earnings thereon. Participants are vested in employer contributions and earnings based on years of service as scheduled in the Plan document and become fully vested after completing one year of service in which the employee completed at least 1,000 hours of service.

#### **Forfeited Accounts**

Forfeitures of discretionary contributions are used to pay Plan expenses or reduce discretionary Employer contributions. Forfeited amounts that were used to reduce Employer contributions to the Plan during 2024 and 2023 totaled approximately \$9,000 and \$10,000, respectively. There are approximately \$13 of unallocated forfeitures at December 31, 2024. There were no unallocated forfeitures at December 31, 2023.

### 1. Description of Plan (Continued)

#### **Payment of Benefits**

On termination of employment for any reason, a participant or beneficiary may elect to roll their vested account balances into another retirement plan or receive a lump-sum distribution. If the vested balance is \$1,000 or less, the participant will receive a lump-sum distribution. If the participant's vested benefit is between \$1,000 and \$5,000, the participant is subject to a mandatory distribution through a lump-sum payment or direct rollover to an IRA. If the participant's vested benefit is greater than \$5,000, the participant must consent to any distribution from their account.

In-service distributions are allowed under the Plan upon attainment of age 59 1/2.

Hardship distributions are allowed under the Plan.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared under accounting principles generally accepted in the United States of America.

#### **Accounting Estimates**

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates; the effects of any changes could be material.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for the fixed income guaranteed option, which is reported at contract value. See Note 3 for disclosure of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Gains and losses on disposition of investments and unrealized gains and losses on investments held during the year are referred to collectively as net appreciation in fair value of investments.

#### **Fair Value of Financial Instruments**

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 Inputs are inputs other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

## 2. Summary of Significant Accounting Policies (Continued)

### Fair Value of Financial Instruments (Continued)

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies - mutual funds are valued at the net asset value (quoted prices) of shares held by the Plan at year end.

### Administrative Expenses

Plan administration expenses may be paid by the Organization or the Plan. If the Organization does not pay the Plan related expenses, the expenses are allocated to participant accounts directly for activity fees, such as distribution fees, or proportionally based on the values of accounts or as an equal dollar amount based on the number of participants for general administrative fees.

### Payment of Benefits

Benefit payments are recorded when paid.

### Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through September 24, 2025, the date which the financial statements were available to be issued.

### 4. Guaranteed Interest Contracts

The Plan provides a fixed income guaranteed option issued by Principal Trust Company that simulates the performance of a guaranteed investment contract. The Custodian maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest that is guaranteed to the Plan.

The contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### 5. Certified Investments

At December 31, 2024, the Plan's investments were held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the "Custodian"). The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i - Schedule of Assets (Held at Year End) as of December 31, 2024.

At the direction of the Plan Administrator, the Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **6. Plan Termination**

Although the Organization has not expressed any intent to do so, it has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

### **7. Tax Status**

The Plan has adopted the Principal Life Insurance Company Volume Submitter Plan. The Principal Life Insurance Company Volume Submitter Plan has obtained an Internal Revenue Service opinion letter dated March 31, 2017, in which the Internal Revenue Service stated the plan document is acceptable under section 403(b) of the Internal Revenue Code for use by eligible employers. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

### **9. Party-In-Interest Transactions**

Certain investments of the Plan are managed by the record keeper; therefore these are party-in-interest transactions. Certain fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.
