### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Aeronet, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. #### **Note 1 – Plan Description**

The following description of the Aeronet, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Aeronet, Inc. (the “Company” or “Employer”). The Plan commenced effective January 1, 1997, and was amended and restated to comply with the latest rules and regulations effective August 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

##### ***Plan Custodian and Trustee***

Ascensus Trust Company (“Ascensus,” “Trustee,” or “Custodian”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Retirement plan recordkeeping and administrative services are provided by The Vanguard Group, Inc. (“VGI”). VGI has entered into an agreement with Ascensus, LLC to provide certain Plan recordkeeping and administrative services on VGI’s behalf. Ascensus also serves as the Plan’s Trustee.

##### ***Eligibility and Plan Entrance Date***

Except for union employees and nonresident aliens, employees are eligible to participate in the Plan after completing three months of service and reaching the age of 18. Eligible employees are permitted to enter the Plan on the first day of each month after which the employee has satisfied the eligibility requirements.

##### ***Participant Contributions***

Participants may elect to contribute, on a pre-tax or Roth basis, up to 100% of their annual eligible compensation as defined by the Plan, up to the maximum amount allowed for deferral annually under the IRC, which was \$23,000 for 2024. Participants who reach the age of 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually under the IRC, which was \$7,500 for 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

##### ***Employer Contributions***

The Plan provides for a discretionary Employer matching contribution. The match will be a discretionary percentage of a participant's compensation, or a discretionary dollar amount determined by the Employer on a uniform basis for all participants. No discretionary matching contributions were made in 2024. For the year ended December 31, 2024, the Company made a qualified non-elective contribution to the Plan in the amount of \$7,083.

#### Note 1 – Plan Description (continued)

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Participant-Directed Investments*

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may direct the allocation of their account balances to one or more of these options. The investment options vary in types of investments, rates of return, and investment risk.

##### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in employer contributions, plus any income or loss thereon, is based upon years of service according to the following schedule:

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may have two outstanding loans at a time. The loans must be repaid over a period no longer than five years. Notes receivable from participants are secured by the balance in the participant's account and bear interest at 1% above Prime, as defined. Principal and interest of the loans are paid ratably through payroll deductions at least quarterly.

##### *Payment of Benefits*

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant receives a lump sum payment of the vested portion of their account balance. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

#### **Note 2 – Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

##### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions in accordance with the terms of the Plan agreement.

##### ***Payment of Benefits***

Benefit payments are recorded when paid.

##### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred by, or attributable to, a specific participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

The Plan receives revenue sharing credits from investments in Vanguard Investor share class mutual funds based on invested balances. This revenue is used to offset certain amounts owed to the Custodian for its administrative services to the Plan. If the revenue received by the Plan from the mutual fund service provider exceeds the amount owed under the agreement, the Custodian remits the excess to the Plan's trust on a monthly basis. Such amounts may be applied to pay Plan administrative expenses. At December 31, 2024 and 2023, the Plan suspense account totaled \$18,940 and \$17,650 respectively. The Plan or Plan Sponsor may make a payment to the Custodian for administrative expenses not covered by revenue sharing.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the valuation hierarchy.

**Stable Value Common Trust Fund** – The Plan’s investment in the Putnam Fiduciary Trust Company Stable Value Common Collective Trust Fund is primarily comprised of fully benefit responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value; however, the practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. There are no significant restrictions on participant redemptions; however, the Plan must provide forty-five days’ notice prior to termination of the collective trust participation agreement.

#### **Note 5 – Related Party and Party-in-Interest Transactions**

Plan investments are managed by the Trustee; as such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. There have been no known prohibited transactions with parties-in-interest. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all remaining assets in affected participants' accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided for by ERISA.

#### **Note 7 – Tax Status**

The Plan operates under an adoption agreement in connection with a non-standardized preapproved profit-sharing plan sponsored by Ascensus, LLC. This prototype plan document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the prototype plan constitutes a qualified plan under Section 401 of the IRC, and that the related trust was tax exempt as of the financial statement date.

Although the Plan has not filed individually with the IRS regarding the Plan's qualified tax status, the Plan Administrator believes the Plan is designed and currently being operated in compliance with applicable requirements of the IRC and, therefore, believes the Plan is qualified, and that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
