Independent Auditor's Report

Note 1: Description of the Plan

The following description of the Midwest Concrete Materials 401(k) Plan (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Midwest Concrete Materials, Inc. (the Company). As of July 1, 2023 newly eligible employees can begin deferring contributions on the first day of the Plan quarter after becoming eligible. Employees are eligible for company matching contributions at that same time. Employees are eligible for any discretionary contributions after six months of employment. Employees will be auto enrolled at 6% of plan compensation.

Age 18 must be attained to be eligible for any type of employee or employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred or after-tax basis. Beginning July 1, 2023, employees will be auto enrolled at 6% of plan compensation. Participants who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds to Plan participants. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer Contributions

The Company may make a matching contribution equal to a uniform percentage of the employee's salary deferral, which percentage is determined annually at the discretion of the Company's Board of Directors. During 2024 and from July 6, 2023, the Company matched employee contributions equal to 50% of contributions up to 4% of compensation. Additionally, the company matched 3% for participants contributing 5% of compensation, and matched 4% of contributions for participants contributing 6% of compensation. From January 1, 2023 through July 5, 2023, the Company matched 50% of employee contributions up to 6% of compensation.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company has elected not to provide a discretionary contribution for 2024 or 2023. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their own compensation deferral contributions, rollover contributions plus earnings. The Plan provides vesting in the employer's matching contributions, company profit-sharing contributions, and any earnings attributable to these contributions at 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service and 100% after six years of service. An employee who becomes disabled, dies, or reaches age 65 will become 100% vested in the employer's contributions.

Participant Loans

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%. Generally, the loan term may not exceed five years. However, if the loan is for the purchase of a principal residence, the Plan may permit a longer repayment term. The Plan subscribes to the MyPlanLoan, where participants pay back Plan loans with outside funds versus payroll deductions. For the years ending December 31, 2024 and 2023, interest rates on outstanding loans ranged from 3.25% to 8.50%.

Payment of Benefits

Distributions are made upon death, disability, retirement, or termination of employment. In-service distributions are permitted upon attaining age 62. The participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions are made in a lump sum, substantially equal payments or a partial withdrawal to the participant and designated beneficiaries. Mandatory distributions will be made following severance from employment when the participant's account balance is \$5,000 or less.

Forfeitures

Forfeitures represent the non-vested portion of participant account balances upon termination. Participants forfeit the non-vested portion of employer contributions made on their behalf upon the earlier of the date they withdraw from the Plan or upon plan-specified number of breaks in service. Forfeitures during 2024 and 2023 were \$29,469 and \$24,904, respectively. These amounts will be used to restore forfeitures, to reduce Company contributions, or pay Plan expenses. For the years ended December 31, 2024 and 2023, Company contributions were reduced by \$29,452 and \$24,955, respectively.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20 and \$4, respectively.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants accounts are charged directly to the participants' account. Other expenses are included in administrative expenses. Investment related expenses are included in the administrative expenses reported by the Plan.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Investment Valuation and Income Recognition

The Plan's investments are presented as determined and certified by Hand Benefits & Trust (the Custodian) as of the Plan's year end. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Loans

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions upon a distributable event, as defined in the Plan document.

At December 31, 2024 and 2023, there were \$96,456 and \$121,138 of loans in default included in net assets available for benefits, respectively.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds

Valued at the net asset value (NAV) per \$1 share. The fund's portfolio is comprised of short-term, or less than one year, securities representing high-quality, liquid debt and monetary instruments. Investors can purchase shares of money market funds through mutual funds, brokerage firms and banks.

Note 4: Related Party and Party-in-Interest Transactions

The Company absorbs the cost of audit fees related to the Plan, some administrative fees and the cost of fidelity bonds. As the Plan does not reimburse the Company for the cost of such services they are not included in these financial statements.

Certain plan investments are managed by the Custodian for which they are paid fees. Investment related expenses are included in the administrative expenses reported by the Plan. These transactions qualify as exempt party-in-interest transactions.

The Company provides administrative services on behalf of the Plan. Additional party-in-interest transactions include audit fees paid to Varney & Associates, CPAs, LLC and investment fees paid to The Trust Company. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6: Tax Status

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
