### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TIAA-CREF Retirement Plan for the Faculty and Staff of The Montgomery Academy DC Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**Note 1 - Plan Description**

The following description of the TIAA-CREF Retirement Plan for the Faculty and Staff of The Montgomery Academy (the Sponsor) DC Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a Section 403(b) defined contribution plan covering substantially all employees of the Sponsor. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The universal availability rule applies to Section 403(b) plan which means the Sponsor must permit all employees to defer salary except for (1) employees who will contribute \$200 annually or less, (2) those employees who participate in a 401(k) or 457 plan or in another 403(b) plans, (3) nonresident aliens, and (4) employees who normally work less than 20 hours per week.

Employer contributions - Each year, the Sponsor will contribute to the Plan a 7.5% matching contribution provided an employee's deferral equals or exceeds 2.5% of compensation. Employees must be 18 years old and have completed two years of service to become eligible for matching contributions. A year of service is equal to 1,000 hours of service during the Plan year.

Employee contributions - Each year, participants may elect up to 100% of their compensation, as defined by the Plan, subject to certain limitations under the Internal Revenue Code. Compensation shall not include overtime, bonuses, supplemental other income, fringe benefits, post severance pay, and contributions made toward health premiums. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants with 15 years of service are eligible for the Section 403(b) 15-year rule contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts - Each participant's account is credited with the participant's contributions, the employer's matching contributions and allocations of the Plan earnings. Earning allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions and employer matching contributions, plus the actual earnings thereon.

Payment of benefits - On termination of employment, age 59½, normal retirement (age 65), death, or disability, a participant or their beneficiary may elect to receive the value of the vested interest in their account. For balances under \$5,000, a lump-sum distribution will be made. For balances greater than \$5,000, the participant may elect to roll over their vested interest into a qualified plan or receive a lump-sum distribution, partial payments, installment payments, or purchase an annuity contract.

In-service withdrawals are allowed for financial hardships.

Forfeited accounts - There are no forfeited accounts since the Plan provides for immediate vesting.

Plan loans - Plan loans are issued directly from funds owned by TIAA-CREF and not directly from a participant's account. Adequate security is required, and a portion of the participant's account is reserved, or held in collateral, to cover 110% of the outstanding loan in case of default. Repayments are made directly to TIAA-CREF by the participant. Plan loans are not shown in the statements of net assets available for benefits or in the statements of changes in net assets available for benefits. At December 31, 2024 and 2023, there were \$35,796 and \$33,996 in Plan loans, respectively.

**Note 2 - Summary of Significant Accounting Policies**

Basis of accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment valuation and income recognition - The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included with Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies - Consists of mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - The TIAA Real Estate Account is an insurance company separate account of TIAA investing mainly in real estate and real estate related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate related investments. Real estate holdings are valued primarily using external appraisals. Unit values are calculated each day and are posted at tiaa-cref.org and the valuation is considered to be a readily determinable fair value. The fund is registered as a direct filing entity.

Nonbenefit-responsive guaranteed investment contract - A portion of the TIAA Traditional Annuity was determined to be nonbenefit-responsive due to liquidity restrictions. See Note 5 for additional information. The investment is valued at fair market by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. The Plan determines its valuation policies utilizing information provided by the Custodian. The Plan has determined that contract value approximates fair value as provided by TIAA.

**Note 5 - Guaranteed Investment Contracts**

The Plan holds a portfolio of investment contracts with TIAA. The investment contracts are comprised of traditional investment contracts as shown in the following table:

The TIAA Traditional Annuity and TIAA Stable Value are fixed rate guaranteed annuity contracts offered by TIAA-CREF for the Plan. Contributions to these investment options purchase a contractual or guaranteed amount of future benefits for the participant. The contracts guarantee principal and a minimum interest rate and provide the opportunity for additional amounts in excess of the guaranteed rate. The guarantees and returns of the TIAA Traditional Annuity and TIAA Stable Value are backed by TIAA's claims paying ability. The TIAA Traditional Annuity and TIAA Stable Value investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity dates.

TIAA Traditional Annuity

The TIAA Traditional Annuity is a portfolio of unallocated fixed rate guaranteed annuity contract. The investment is a traditional investment contract.

Retirement Annuity (RA) contracts and Retirement Choice (RC) contracts under the TIAA Traditional Annuity have liquidity restrictions and are, therefore, nonbenefit-responsive. Transfers from RA contracts must be spread over a period of 10 annual installments, or five annual installments for withdrawals after termination of employment. Participant withdrawals and transfers from RC contracts must be taken in 84 monthly installments; however, a lump-sum distribution is available in the 120-day period following termination of employment, subject to a 2.50% surrender charge. Institutional withdrawals from RC contracts are allowed over a period of five years with 90-day advance notice from the institution. The Plan's investments in the RA and RC contracts are stated at contract value which approximates fair value. The Supplemental Retirement Annuity (SRA) and Group Supplemental Retirement Annuity (GSRA) contracts under the TIAA Traditional Annuity have no liquidity restrictions and are fully benefit-responsive. The Plan's investments in the SRA and GSRA contracts are stated at contract value since they are fully benefit-responsive. The contract guarantees principal and a minimum interest rate, plus the opportunity for additional amounts in excess of the guaranteed rate. These additional amounts, when declared, remain in effect for the "declaration year," which begins each March 1. For 2024 and 2023, the guaranteed annual interest rate was 3.00% for all contracts except RC contracts, in which case the guaranteed rate was between 1.00% and 3.00%.

TIAA Stable Value

The TIAA Stable Value is a fixed rate group annuity contract issued by TIAA and is a benefit-responsive contract. Contributions are deposited into a nonunitized separate account. TIAA Stable Value is immediately liquid to a participant for withdrawals and transfers and does not have withdrawal restrictions with the exception that immediate transfers cannot be made to competing investment options pursuant to the contract's "equity wash" provisions. In addition, transfers into TIAA Stable Value may not be made for 30 days following a transfer out.

The TIAA Stable Value guarantees principal and a minimum interest rate, plus the opportunity for additional amounts in excess of the guaranteed rate. These additional amounts, when declared by the TIAA Board of Trustees, remain in effect from January 1 through June 30 and from July 1 through December 31. Although the liability to provide contract guarantees and accumulations is backed by the assets in the separate account, any amount to be credited above the minimum guaranteed rate is determined by TIAA and are not guaranteed for periods other than the periods for which they are declared. Contract holders and plan participants do not participate in, and do not receive the earnings of, the assets in the separate account. For 2024 and 2023, the guaranteed annual interest rate was between 1.00% and 3.00%.

**Contract Value Measurement**

As described in Note 2, because the SRA and GSRA contracts under the TIAA Traditional Annuity and the TIAA Stable Value are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**Note 7 - Tax Status**

Effective June 28, 2013, the Internal Revenue Service established a plan to approve prototype and volume submitter 403(b) plan documents in accordance with applicable sections of the Internal Revenue Code. The Plan was approved on March 31, 2017. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - Related Party Transactions**

Plan investments are shares of mutual funds managed by TIAA-CREF. TIAA-CREF is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment services are included in the net appreciation in fair value of investments.

**Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10 - Subsequent Events**

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2024 have been incorporated in these financial statements.
