We have audited the financial statements of Northstar Aerospace (USA) Voluntary Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) for the year ended December 31, 2024, and have issued our report thereon dated September 23, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Fidelity Management Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. We are aware of no uncorrected misstatements that are material to the Plan's financial statements.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated September 23, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

Northstar Aerospace (USA) Voluntary Savings Plan (the "Plan") is a defined contribution plan that was established to provide benefits to eligible employees, as defined in the Plan, of Heligear Acquisition Co DBA Northstar Aerospace Chicago (the "Company"). Sponsorship of the Plan transferred to the Company on March 31, 2000 pursuant to an asset purchase agreement between the Company and Boeing Precision Gear, Inc.

The plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

THIS DESCRIPTION OF THE PLAN PROVIDES ONLY GENERAL INFORMATION. PARTICIPANTS SHOULD REFER TO THE PLAN DOCUMENT AND ANY AMENDMENTS FOR A MORE COMPLETE DESCRIPTION OF THE PLAN'S PROVISIONS.

A. Eligibility

Employees, other than leased employees, are eligible to participate in the Plan after a minimum of one month of service. Plan entry is the first day of the month coincident with or following attainment of eligibility.

B. Vesting

Participants are immediately vested in their salary deferrals, rollover contributions and related earnings. Participants with Company matching contribution balances accrued prior to August 1, 2006 are 100% vested.

Effective June 26, 2019, participants who merged into this Plan on June 1, 2019 from the Northstar Aerospace (USA), Inc. Retirement Savings Plan (the "Phoenix Plan"), and have a hire date prior to June 1, 2019, are vested in their profit share and employer match balances 25% upon hire and 25% more each year to a total of 100% after 3 years. Participants who merged into this Plan from the Phoenix Plan on June 1, 2019 and have frozen money purchase plan assets originally from the D-Velcro Manufacturing Money Purchase Pension Plan are 100% vested in the frozen purchase plan assets. Participants who merged into this Plan from the Phoenix Plan on June 1, 2019 and have balances in a prior safe harbor match are 100% vested in those assets.

All other participants are vested 20% per year in the employer's contributions allocated to his or her account, and is fully vested after five years of credited service. Participants also become 100% vested at retirement or termination from the Company, on active duty in the U.S. armed forces, or upon total disability.

C. Participant Contributions

Participants may elect to defer up to 100% of their eligible pre-tax compensation, as defined in the Plan, up to the amount allowable under the Code. Participants who elect to defer a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Roth and catch-up contributions are permitted. Contributions withheld are invested in accordance with the participant's direction.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

C. Participant Contributions (Continued)

Participants are allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are invested in accordance with the participant's direction and the Plan's provisions.

D. Employer Contributions

The Company is allowed to make discretionary matching contributions and discretionary nonelective contributions, as defined in the Plan.

The Company's matching contribution is 100% of the participant's contribution (other than catch-up contributions), over 1.5%, up to 6%, of eligible compensation. The Company's nonelective contribution is 1.5% of eligible compensation, regardless of participant deferrals to the Plan.

E. Payment of Benefits

Upon termination, the participant or beneficiary will receive benefits in a lump-sum amount equal to the value of the vested interest in his or her account. Upon termination, participants may elect to defer receipt of payment. Participants who have reached age 65 prior to retirement may have the option of receiving benefits in equal monthly installments over five or 10 years. An employed participant who reaches age 70½ and remains employed as of April 1 following the year he or she reaches 70½ may elect to receive payment or, if no election is made, payment is deferred until termination of service. Early withdrawals are permitted, but limited to certain types of immediate and heavy financial need, in accordance with Code regulations. Benefits are recorded when paid.

F. Notes Receivable from Participants

Participants are permitted to borrow the lesser of 50% of their vested account balance or \$50,000, subject to a minimum of \$1,000. A participant may have two loans outstanding at any time. All loans bear interest at a reasonable rate of interest as determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. Loans are repaid through regular payroll deductions over a period of up to five years for personal loans and ten years for loans used to finance the purchase of a principal residence.

G. Administrative Expenses

Most administrative expenses of the Plan are paid by the Company.

H. Forfeitures

Forfeitures result from non-vested Company contributions of terminated employees. Forfeiture reserves of \$36,476 and \$40,482 at December 31, 2024 and 2023, respectively, are available to offset Company contributions and pay administrative expenses, in accordance with the Plan agreement. In 2024, \$79,515 of forfeitures were added to the Plan. \$86,703 was used to offset Company contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

B. Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments of the Plan are held by Fidelity Management Trust Company and invested based solely upon instructions received from participants.

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds and are valued at their quoted market prices.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - INCOME TAX STATUS

The Plan has adopted the Fidelity Management Trust Company Volume Submitter Defined Contribution Plan that has received a letter of opinion from the Internal Revenue Service stating that the form of the Plan qualifies under the applicable sections of the Code. Although the Plan has been amended since receiving the letter of opinion, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, the Plan's tax-exempt status has not been affected and no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA and the provision set forth in the Plan. In the event of Plan termination, participants would become 100% vested in their accounts and the net assets of the Plan would be distributed based upon participants' account balances at that time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 6 - RELATED PARTY TRANSACTIONS

Fidelity Management Trust Company and its affiliates provide investment options offered under the Plan. Transactions in these funds, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8 - COMMON/COLLECTIVE TRUST

The Plan maintains a fully benefit-responsive contract with Fidelity Management Trust Company ("Fidelity") through the Managed Income Portfolio ("Common/Collective Trust"). Contributions to the Common/Collective Trust are maintained in a general account and are credited for interest and charged for participant withdrawals and administrative expenses. Fidelity is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Common/Collective Trust meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The crediting rate is based on a formula established by Fidelity but may not be less than 1% percent. The crediting rate is reviewed on a yearly basis for resetting. Crediting rates in 2024 ranged from 1.97% to 2.41%.

The Plan's ability to receive amounts due is dependent on Fidelity's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Common/Collective Trust. The plan administrator does not believe any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 9 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 23, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
