1. Plan Description

The following brief description of the Anders Minkler Huber & Helm LLP 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Anders Minkler Huber & Helm, LLP (the Company) and related participating employers.

Employees are eligible to make salary deferral contributions after attaining 21 years of age. Eligible employees become participants on the first day of the month following the date eligibility requirements are satisfied. Prior to January 1, 2024, the Company made discretionary matching contributions and discretionary non-elective contributions if the participant was employed on the last day of the Plan year and attained 21 years of age. Effective January 1, 2024, the Plan is a "Safe Harbor 401(k) Plan" whereby the Company is required to make safe harbor matching contributions and may make additional discretionary matching contributions and discretionary non-elective contributions after the participant attains 21 years of age. Participants must be employed on the last day of the Plan year to receive the Company's discretionary non-elective contributions. Employees are also eligible to receive the Company's discretionary non-elective contributions if they have completed one year of service, are at least 21 years of age and have completed 1,000 hours of service during the Plan year.

Contributions

Each year, participants may contribute up to 100% of pre-tax or Roth after-tax annual compensation in connection with the 401(k) provisions of the Plan, up to the maximum dollar limits allowable by law. Participants may also contribute rollover amounts representing distributions from other qualified plans. Effective January 1, 2024, the Company makes safe harbor matching contributions. The Company's safe harbor matching contributions are made in an amount equal to 100% of the participant's elective deferral up to 3% of eligible compensation, plus 50% of the next 2% of eligible compensation. Prior to January 1, 2024, the Company's matching contributions were discretionary. Effective January 1, 2024, if an additional discretionary matching contribution is made, the total amount of the discretionary match may not exceed 4% of total eligible compensation. The Company may also make discretionary non-elective contributions. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's safe harbor matching contributions and discretionary matching contributions and b) the Company's discretionary non-elective contributions and c) Plan earnings or losses. The Company's safe harbor matching contributions and discretionary contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary non-elective contributions are allocated on the basis of the participant's eligible compensation for the Plan year. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Alerus Financial, N.A.

Notes Receivable from Participants

The Plan does not allow new participant loans. Effective January 1, 2022, the Plan was amended to permit former participants of Summit CPA Savings Plan to rollover outstanding plan loans into the Plan. The notes are secured by the balance in the participant's account and bear interest at rates of 4.25%-6.50% as of December 31, 2024 and 2023. Loans must be repaid through payroll deductions within five years.

Vesting

Participants are vested immediately in their contributions and, effective January 1, 2024, the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary non-elective contributions credited to participants' accounts are based on years of service. A participant is 20% vested after the first two years of credited service with vesting increasing 20% per year until a participant is fully vested after six years of credited service.

Payment of Benefits

Upon retirement, termination, disability, or death, the participant or beneficiary may elect to receive either a lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan also allows in-service distributions up to the vested amount in the distributing account for participants who have reached age 59 ½. The Plan also allows hardship distributions as determined in the Plan agreement. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Company's discretionary matching contributions and non-elective contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to

reduce the Company's safe harbor matching contributions or discretionary matching contribution or non-elective contribution or used to pay plan expenses. As of December 31, 2024 and 2023, forfeited, non-vested amounts totaled \$70,589 and \$45,299, respectively. For financial statement purposes \$0 and \$49,204 have been used to reduce the calculated employer contribution receivable at December 31, 2024 and 2023, respectively, as those were the amounts used when the receivable was deposited after year-end.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Expenses

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distribution payments are charged directly to the participants' account and are included in administrative expenses. Investment-related expenses are paid by the Plan and included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 2, 2025, noting no items requiring disclosure.

3. Information Certified by Alerus Financial

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Alerus Financial, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.
