### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bauer Equipment America Inc 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Bauer Equipment America Inc 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Bauer Equipment America Inc 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Bauer Equipment America Inc 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting, which is a basis of other than accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at the end of year) as of December 31, 2024 and 2023 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### NOTE (1) DESCRIPTION OF PLAN

The following description of the Bauer Equipment America Inc 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions:

- A. General - The Plan was formed and adopted by Bauer Equipment America, Inc. (the Company), effective January 1, 2008. The Plan is a defined contribution plan covering all full-time employees of the Company who have at least two months of service. The Plan is a salary reduction plan or 401(k) plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions - Each year, participants may contribute no less than 1% and up to 87% (in whole percentages) of pretax and Roth eligible earnings, as defined in the Plan. The company matched 100% of such elective contributions up to 3% of employee earnings and 50% of the employee's earnings to the extent an employee's elective contributions are in excess of 3% up to 5% of the employee's earnings. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may make a profit-sharing contribution to the Plan each year at its discretion. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers an investment contract with Ascensus Trust Company (Ascensus or Trustee) who holds and maintains the assets of the Plan with investment options in registered investment companies.

Eligible earnings are defined as W-2 wages exclusive of commissions.

- C. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) administrative expense. Allocations are based on participant earnings applicable to the investment options chosen by each participant or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.
- D. Vesting - Participants are immediately 100% vested in their contributions and rollover contributions made by individual participants plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is ratably vested over three years of credited service.
- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the respective participant's account and bear interest at a rate of prime plus 2%, as published in the Wall Street Journal on the 14<sup>th</sup> day of the month that is in effect the month in which the loan becomes effective. Principal and interest is paid ratably through payroll deductions, over a period generally not extending beyond five years from the date of the loan. However, if the use of the loan is to acquire a principal residence, it may be repaid within a period of no more than 30 years.

#### NOTE (1) DESCRIPTION OF PLAN (Continued)

- F. Payments of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, or in the form of a life or joint and survivor annuity, or have the balance paid as a direct rollover to another Individual Retirement Account or to another Employer's tax qualified plan. For termination of service for other reasons and for balances less than \$5,000, vested amounts are cashed out at the sponsor's discretion. The Company has elected to keep such balances in the Plan and not automatically disburse them. Hardship withdrawals are permitted from participant deferrals (excluding earnings), rollovers, vested matching contributions, and non-elective contributions.
- G. Forfeited Accounts - Forfeitures represent the portion of non-vested benefits remaining from employees who have withdrawn from the Plan. Forfeitures shall be used to reduce future Company contributions. In 2024 and 2023, employer contributions were reduced by \$0 and \$0, respectively, from forfeited non-vested accounts.

#### NOTE (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. Basis of Accounting - The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). This basis of accounting differs from U.S. GAAP primarily because certain revenue and related assets have been recorded when received rather than when earned and certain expenses and related liabilities have been recognized when paid rather than when the obligations were incurred. The modified cash basis is an accounting method that combines elements of the two major accounting methods, the cash method and the accrual method. The cash method recognizes income when it is received and expenses when they are paid for, whereas the accrual method recognizes income when it is earned (for example, when the terms of a contract are fulfilled) and expenses when they are incurred.

The Plan modified its cash basis financial statements to accrue and record for the following accounts: Notes receivable from participants and Liabilities. All other transactions are recognized as revenue or expense when received or paid in cash, respectively.

- B. Use of Estimates - The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. Investment Valuation and Income Recognition - Investments are reported at fair value as determined by the Trustee, using market quotations and other available information. Securities are valued at the last reported sales price on the last business day of the Plan's fiscal year. Net appreciation or depreciation of investments is reported in the Statement of Changes in Net Assets Available for Benefits and consists of the realized gains or losses and the unrealized appreciation or depreciation of these investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

- D. Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Therefore, no allowance for doubtful accounts is recorded.
- E. Contributions - Employee contributions are recorded in the period during which the Company makes payroll deductions from participant earnings.
- F. Payment of Benefits - Benefits are recorded when paid.
- G. Plan Expenses - A participant with a loan is directly charged a processing fee upon origination of the loan. Other administrative costs of the Plan charged by Ascensus are generally paid by the Company. Transactional charges are paid by the Plan.
- H. Concentrations of Credit Risk - The Plan's investments potentially subject the Plan to concentrations of credit risk. The Plan has not experienced any credit losses associated with these instruments.

#### NOTE (4) FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the net asset value of shares held by the Plan at year end.

Money Market Funds - Valued based on quoted market prices in active markets at year end.

Common/collective trusts - Valued based on the values of the underlying investments at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE (5) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan Sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. Ascensus is considered a party-in-interest, as defined by ERISA, since they provide services to the Plan as investment custodian. All compensation to Ascensus is exempt from the prohibited transaction rules of ERISA pursuant to ERISA Section 408 because the compensation is reasonable and customary for the services rendered. The indirect compensation paid to Ascensus is based on percentages of average daily assets managed.

Ascensus, the record keeper for the Plan, is considered parties-in-interest to the Plan because they are the record keeper and sponsor of the Plan. For the years ended December 31, 2024 and 2023, the Plan paid direct compensation of \$43,097 and \$36,310, respectively, for services rendered to the Plan and indirect compensation from the Plan, which is exempt from the prohibited transaction rules of ERISA, pursuant to ERISA Section 408, because the compensation is reasonable and customary for the services rendered. The indirect compensation paid to ADP-Broker Dealer is based on percentages of average daily assets managed.

#### NOTE (6) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### NOTE (7) TAX STATUS

The IRS has determined and informed the Company by a letter dated March 31, 2008 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

NOTE (8) PLAN AMENDMENTS

Effective November 1, 2021 the Company ceased matching contributions for commissions and added a Roth option for contributing to the Plan.

Effective March 15, 2024, the Company removed Bauer Manufacturing LLC from the Plan.

Effective January 1, 2025 the Company will make safe harbor contributions, and continue to match 100% of employee elective contributions up to 3% of employee earnings and 50% of the employee's earnings to the extent an employee's elective contributions are in excess of 3% up to 5% of the employee's earnings. Safe harbor contributions are immediately 100% vested.

NOTE (9) RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
