Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Kardex Remstar Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

The following description of the Kardex Remstar Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established in April 1987 and is a defined contribution 401(k) plan covering all employees of Kardex Remstar, LLC (the Company) and participating employers, Kardex Handling Solutions, LLC, Kardex Solutions LLC and Kardex U.S. Manufacturing, LLC. There is no age requirement to participate in the Plan. Participants are eligible to enter the Plan upon the first day of the month coinciding with or following 30 days of employment at the Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Effective June 1, 2025, the Plan's trustee was changed from Lincoln National Life Insurance Company to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. All Plan assets were transferred accordingly.

Contributions

A participant may elect to contribute pre-tax dollars or post-tax Roth dollars up to the Internal Revenue Service maximum allowable amount. Participants may also contribute amounts representing rollovers from other qualified plans.

Effective June 1, 2025, the Plan was amended to provide an automatic contribution arrangement for eligible participants. Under this arrangement, participants who have not affirmatively elected a salary deferral contribution will be automatically enrolled at a 1% deferral rate. This automatic contribution will increase by 1% each plan year, up to a maximum of 3%. Participants retain the right to opt out or modify their deferral rate at any time.

The Plan provides for discretionary matching and nonelective contributions by the Company. In 2024 and 2023, the Company made a safe harbor matching contribution equal to 100% of salary deferrals up to 3% of compensation, plus 50% of salary deferrals up to 5% of compensation. There were no nonelective contributions made by the Company in 2024 or 2023.

Participants may elect to have their contributions invested in various managed funds which have different investment objectives. Those funds include a group annuity contract and pooled separate accounts.

1. Description of the Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, any Company contributions and allocations of Plan earnings or losses and administrative expenses of each fund based on the participant's relative account balance. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Plan Forfeitures

Participants are 100% vested in their voluntary contributions, discretionary matching and safe harbor matching contributions. Nonelective Company contributions are vested on a 6-year graded schedule at a rate of 20% starting with the second year of service. Employees with a hire date of January 1, 2018 are 100% vested in all contribution types.

At December 31, 2024 and 2023, forfeited nonvested accounts included in net assets available for benefits were not material. Forfeitures may be used to pay administrative expenses or to reduce future Company contributions. For the years ended December 31, 2024 and 2023, the amount of forfeitures used was not material.

Distributions

Distributions may be made from the vested portion of the participant's account upon death, disability (as defined in the Plan), retirement or termination of employment. Benefits will be paid to the participant in a lump-sum, or through partial withdrawals or by transfer to another qualifying plan.

Participants are permitted to take in-service distributions upon attaining the age of 59½. Additionally, participants are permitted to take hardship withdrawals from their account provided they meet certain criteria.

Notes Receivable From Participants

Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000, with a minimum loan amount of \$1,000. Participants may have only one loan outstanding at any time and loan terms range from 1 to 5 years. Loans for the purpose of purchasing the participant's principal residence may not exceed 10 years. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with the prevailing interest rate on similar loans. Principal and interest is paid ratably through payroll deductions.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, to the extent they are not paid by the Company. Certain fees incurred by the Plan for investment management and certain administrative services are paid through revenue sharing rather than direct payment.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their balances.

2. Summary of Significant Accounting Policies

Basis of Presentation

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments in pooled separate accounts are stated at fair value based upon the net asset value reported by the underlying funds. The group annuity contract is reported at contract value, as determined by the insurance company, as it is considered fully benefit-responsive (see note 4).

Purchases and sales of securities are reported on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions are recorded in the period in which payroll deductions are made. Company discretionary matching and nonelective contributions are recorded in the period to which the service relates.

Benefit Payments

Benefit payments are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Subsequent Events

For purposes of recognition and disclosure in these financial statements, management of the Plan has evaluated subsequent events through September 23, 2025, which is the date these financial statements were available to be issued.

3. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, for the non-standardized pre-approved profit sharing plan stating that the Plan is acceptable under Section 401 of the Internal Revenue Code (the Code). In the opinion of the Plan Administrator, the Plan has been operated in accordance with the applicable sections of the Code upon which the opinion letter was based and remains qualified under the Code and applicable regulations. While the Plan has been amended since the receipt of the opinion letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code. Therefore, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. **Information Certified by the Trustee**

The Plan's investments, including interest and dividends, net appreciation in fair value of investments and investment transactions, and notes receivable from participants, interest associated with the notes receivable and notes receivable transactions were certified by Lincoln National Life Insurance Company, the trustee, as of and for the years ended December 31, 2024 and 2023. The Plan Administrator has determined that the trustee meets the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan's Administrator and as permitted by CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to generally accepted auditing procedures by the Plan's independent public accountants.

As described in note 2, the Plan's investment in the group annuity contract (a stable value option) is reported at contract value, as determined by the respective insurance company. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The group annuity contract is a general account product with an insurance company. As such, there are not any specific securities in the general account that back the liabilities of this insurance product. The group annuity contract pays interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the contract. Interest credited to the Plan under the contract totaled \$58,503 and \$41,709 in 2024 and 2023, respectively. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Certain events limit the ability of the Plan to transact at contract value. Such events include (1) certain amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

5. **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC 820), has established a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

5. **Fair Value Measurements (Continued)**

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based upon net asset value as determined by the trustees using the fair value of the underlying investments held by the fund, less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards Update (ASU) 2015-07, pooled separate account investments measured at fair value using the net asset value per share practical expedient have not been classified in the fair value hierarchy at December 31, 2024 and 2023.

There are no restrictions on the sale or transfer of investments in pooled separate accounts and there are no unfunded commitments at December 31, 2024 and 2023.

6. **Related Party and Party-in-Interest Transactions**

Lincoln National Life Insurance Company manages the Plan's investments and provides recordkeeping and trust services to the Plan, therefore, transactions involving the Plan's investments qualify as party-in-interest. Contract charges paid by the Plan to such parties-in-interest, investment advisors and other related entities for the years ended December 31, 2024 and 2023 were \$77,430 and \$61,389, respectively.

Additionally, participant notes receivable represent party-in-interest transactions.



