Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kyle Mathison Orchards, Inc. 401(k) Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kyle Mathison Orchards, Inc. 401(k) Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Kyle Mathison Orchards, Inc. 401(k) Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Kyle Mathison Orchards, Inc, and its affiliates (the Company), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing one year of service in which at least 1,000 hours are worked. Participants must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year, to be eligible to receive any employer profit-sharing contributions.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer safe harbor and profit-sharing contributions – The Company matches 100% of employee contributions, up to 3% of eligible compensation deferred to the Plan, plus 50% of each employee's contributions in excess of 3% but not in excess of 5% of the employee's compensation. The Company may elect to make profit-sharing contributions to the Plan; however, no profit sharing contributions were made for the year ended December 31, 2024.

Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions and Company matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting – Participants are vested immediately in their contributions and safe harbor employer contributions, plus actual earnings thereon. Vesting in the Company’s profit-sharing contributions portion of their accounts is based on years of continuous service. Participants vest in the Company’s profit-sharing contributions based on the following schedule:

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan agreement, Plan loans will bear a reasonable rate of interest at one percent above the prime rate of interest as reported by the Federal Open Market Committee as of the date the loan documents are prepared. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.00% to 9.50%, with various maturities through July 2029.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installment payments in monthly, quarterly, semi-annual, annual, or other installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant. If a participant’s account does not exceed \$5,000, the Plan will distribute the vested portion of the participant’s account in a lump sum as soon as administratively practicable following termination.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan and can be used to pay the Plan’s administrative expenses or reduce Employer contributions. As of December 31, 2024, there were no forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's custodian, John Hancock Life Insurance Company (U.S.A.) (John Hancock), certifies the fair value of all investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation or depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 28, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments consist of units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The PSAs invest mainly in securities of large-capitalization companies, non-U.S. equity securities, small companies, and growth funds. The PSAs seek long-term capital appreciation without undue risk to principal. There are no redemption restrictions or unfunded commitments associated with the PSAs held by the Plan.

The Plan has investments in the following PSAs with investment objectives as follows:

- JH Multi-Index LS Conservative Fund seeks a high level of current income with some consideration given to growth of capital. The fund normally invests approximately 80% of its assets in underlying funds that invest primarily in fixed-income securities and approximately 20% in underlying funds that invest primarily in equity securities.
- JH Multi-Index LS Moderate Fund seeks a balance between a high level of current income and growth of capital, with a greater emphasis on income. The fund normally invests approximately 60% of its assets in underlying funds that invest in fixed-income securities and approximately 40% in underlying funds that invest in equity securities.
- JH Multi-Index LS Balanced Fund seeks a balance between a high level of current income and growth of capital, with a greater emphasis on growth of capital. The fund normally invests 40% of its assets in underlying funds that invest in fixed-income securities and 60% of its assets in underlying funds that invest in equity securities.
- JH Multi-Index LS Growth Fund seeks long-term growth of capital. Current income is also a consideration. The fund normally invests approximately 20% of its assets in underlying funds that invest primarily in fixed-income securities and approximately 80% of its assets in underlying funds that invest primarily in equity securities.
- JH Multi-Index LS Aggressive Fund seeks long-term growth of capital. The fund operates as a fund of funds and normally invests approximately 100% of its assets in underlying funds that invest primarily in equity securities. Underlying funds may be affiliated or unaffiliated and may include exchange-traded funds (ETFs). The fund may invest in various passively managed underlying funds that, as a group, hold a wide range of equity-type securities.
- Money Market Fund seeks maximum current income that is consistent with maintaining liquidity and preserving capital. Under normal market conditions, the fund invests at least 99.5% of its total assets in cash, U.S. government securities, and/or repurchase agreements that are fully collateralized by U.S. government securities or cash.
- Science & Technology Fund invests at least 80% of its net assets (plus any borrowings for investment purposes) in the common stocks of companies expected to benefit from the development, and/or use of science and/or technology. It employs a multi-manager approach with two subadvisors, each of which employs its own investment approach and independently manages its portion of the fund. The fund may invest up to 10% of its total assets in hybrid instruments.

- Invesco Global Fund seeks capital appreciation. The fund invests mainly in common stock of U.S. and foreign companies. The fund can invest without limit in foreign securities and can invest in any country, including countries with developing or emerging markets.
- Vanguard Strategic Equity Fund seeks long-term capital appreciation. The fund invests in small and mid-capitalization domestic equity securities based on the relative potential of the securities.
- Invesco Developing Markets Fund seeks aggressive capital appreciation in common stocks in emerging and developing markets throughout the world.
- Fidelity Advisor Total Bond Fund seeks a high level of current income. The fund normally invests at least 80% of its assets in debt securities of all types and repurchase agreements for those securities. The fund may invest up to 20% of its assets in high yield and emerging market debt securities.
- The 500 Index Fund seeks to approximate the aggregate total return of a broad-based U.S. domestic equity market index. The fund invests at least 80% of its net assets at the time of investment in (a) the common stocks that are included in the S&P 500 Index and (b) securities (which may or may not be included in the S&P 500 Index) that the subadvisor believes as a group will behave in a manner similar to the index. The subadvisor may determine that the fund's investments in certain instruments, such as index futures, total return swaps, and ETFs have similar economic characteristics as securities that are in the S&P 500 Index.
- Janus Henderson Global Equity Income Fund seeks to achieve a high level of current income and steady growth of capital. The fund invests in a portfolio of income producing equity securities.
- Real Estate Securities Fund seeks to achieve a combination of long-term capital appreciation and current income. To pursue this goal, the fund invests, under normal market conditions, at least 80% of its net assets in equity securities of real estate investment trusts (REITs) and real estate companies.
- T. Rowe Price Equity Fund seeks a high level of dividend income and long-term capital growth primarily through investments in stocks. The fund invests at least 80% of its net assets in common stocks, with an emphasis on large-capitalization stocks that have a strong track record of paying dividends or that are believed to be undervalued.
- Vanguard Mid-Cap Value ETF Fund seeks to track the performance of a benchmark index that measures the investment return of mid-capitalization value stocks. The fund employs an indexing investment approach designed to track the performance of the CRSP US Mid Cap Value Index by investing all of its assets in the stocks that make up the Index.
- The Vanguard Total World Stock ETF is an exchange-traded fund that seeks to track the performance of the FTSE Global All Cap Index. It provides broad exposure to both U.S. and international stocks, including large-, mid-, and small-cap companies across developed and emerging markets worldwide. The fund offers investors a diversified, single investment option for global equity market exposure.

- The Vanguard High Dividend Yield Index Fund seeks to track the performance of the FTSE High Dividend Yield Index. It focuses on U.S. companies that pay higher-than-average dividends, aiming to provide investors with a steady income stream along with potential for capital appreciation. The fund primarily invests in large- and mid-cap stocks with strong dividend yields.
- The WisdomTree MidCap Dividend ETF (DON) focuses on U.S. mid-cap companies with a history of paying dividends, aiming to provide income and growth by tracking a dividend-weighted index of mid-sized firms.
- Undiscovered Managers Behavioral A invests in smaller or lesser-known companies, often managed by emerging or "undiscovered" investment managers. The fund typically focuses on behavioral finance principles to identify investment opportunities, aiming for long-term growth.
- JPMorgan Large Cap Growth A invests primarily in large-cap U.S. companies with strong growth potential. The fund aims to achieve long-term capital appreciation by focusing on companies expected to grow earnings faster than the overall market.
- Dreyfus Small Cap Stock Fund invests in small-cap U.S. companies, aiming for long-term capital growth by focusing on firms with strong growth potential in the small-cap segment.
- The Aberdeen Emerging Markets ex-China Fund B invests in emerging market countries excluding China, aiming for long-term capital growth by focusing on companies in diverse developing economies outside of China.
- The Vanguard Explorer Fund invests primarily in small- and mid-cap U.S. companies with growth potential, aiming for long-term capital appreciation.

Note 4 – Tax Status

The Plan document is a non-standardized, preapproved profit-sharing defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC) and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

Note 6 – Certified Investment Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A) (John Hancock), the custodian of the Plan, has certified to the completeness and accuracy of the following:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 7 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are shares of pooled separate accounts managed by John Hancock. John Hancock is the custodian of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Benefits2 Administrators LLC (formerly AmeriBen) serves as third-party administrator for the Plan providing Plan accounting and recordkeeping, and preparation of annual Form 5500 tax filing in accordance with the terms and conditions of the Plan document and retirement Plan services agreement. Fees paid by the Plan for third-party administration services qualify as party-in-interest transactions.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 9 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for the years ended December 31, 2024 and 2023 or change in net assets for the year ending December 31, 2024.

Note 10 – Delinquent Participant Contributions
