Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BJ's Wholesale Club, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BJ's Wholesale Club, Inc. 401(k) Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of BJ's Wholesale Club, Inc. 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements



NOTE 1 DESCRIPTION OF PLAN

The following brief description of the BJ's Wholesale Club, Inc. 401(k) Savings Plan, formerly known as BJ's Wholesale Club, Inc. 401(k) Savings Plan for Salaried Employees (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a tax deferred employees' savings plan as defined by Section 401(k) of the Internal Revenue Code (IRC), covering substantially all eligible salaried and hourly employees of BJ's Wholesale Club, Inc., and its participating subsidiaries (the Company) who elect to participate.

Contributions

Employees who are at least 18 years of age and have completed one month of service are entitled to make employee pre-tax and Roth contributions to the Plan from 1% to 50% of their annual compensation (as defined by the Plan). Participants whose employee contributions are limited by statutory requirements may make additional catch-up contributions starting in the calendar year during which they reach age 50. The Plan also accepts rollover contributions.

The Company makes matching contributions equal to 50% of the first 6% of compensation deposited into the Plan as employee contributions. The Company's matching contribution is credited as of the end of each calendar quarter to participants employed on the last day of the calendar quarter or who have retired, died, or become disabled during the quarter.

For certain employees of perishable distribution centers, the Company makes matching contributions equal to 100% of the first 6% of compensation deposited in the Plan as employee contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Company contributions and allocations of Plan earnings. Each participant's account is credited/charged with allocations of Plan gains, losses, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' own contributions and rollover contributions, and the earnings on those amounts, are 100% vested at all times. Company matching contributions credited to participants' accounts, and the earnings on those amounts, vest according to the following schedule:

Vesting service is credited based on a participant's employment with the Company.

Regardless of years of service, a participant's Company contributions become 100% vested upon reaching age 65 while working for the Company or upon a participant's death or disability while employed.

Notes Receivable from Participants

Participants may take out a loan from the Plan. Participants may borrow a minimum of \$1 up to a maximum equal to the lesser of \$50 or 50% of their vested account balance reduced by the highest outstanding loan balance during the preceding 12 months. Only one loan may be outstanding at a time. The interest rate on loans to participants is set at the prime rate plus 1% on the borrowing date. Interest rates on loans outstanding ranged from 4.25% to 9.50% at December 31, 2024 and 2023, respectively. Loans must be repaid within a period not exceeding five years from the date the loan was made, with the exception of loans taken for the purchase of primary residence, which must be repaid within a period not exceeding 10 years.

Forfeited Accounts

The nonvested portion of Company contributions is forfeited by participants who separate from employment with the Company. If participants return to work for the Company within five years, amounts previously forfeited will be re-credited to their accounts. At December 31, 2024 and 2023, there were \$323 and \$380 of forfeited amounts available for use, respectively. Forfeited amounts, used to reduce Company contributions, were \$532 for the year ended December 31, 2024. Forfeited amounts, used to reduce administrative fees, were \$47 for the year ended December 31, 2024. There were no previously forfeited amounts that were re-credited to a participant's account.

Payment of Benefits

Participants are permitted to withdraw funds from their vested account balances upon attaining age 59½, retirement, termination, or for financial hardships. Withdrawals are subject to taxation.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets available for benefits at the date of the financial statements and the changes in assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments were held in a master trust through December 31, 2022. Effective January 1, 2023, the BJ's Wholesale Club, Inc. 401(k) Savings Plan Master Trust was terminated. The assets were transferred to the Plan on December 31, 2022. Plan investments are stated at fair value except for the New York Life Anchor Account which is described in the following paragraph. Investments in mutual funds are valued at the last reported net asset value or quoted market price on the last business day of the period. Investments in collective trusts are valued at the net asset value of the units held of the collective trusts. The net asset value is used as a practical expedient to estimate fair value. Net appreciation (depreciation) in fair value of investments (see Note 4) consists of realized gains and losses on investments sold and unrealized gains and losses on investments held. Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The New York Life Anchor Account is a stable value account made available to participating plans through a group annuity contract. It is an investment contract that is considered fully benefit responsive, meaning it provides for a stated return on principal invested over a specified period and permits withdrawals at contract value for benefit payments, loans or transfers to other investment options offered by the Plan. The investment contract is benefit responsive and is reflected in the statements of net assets available for benefits at contract value. Contract value is the relevant measurement attributable to benefit-responsive investment contracts because it is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document for Form 5500 reporting purposes. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Employee and Employer Contributions

Employee contributions include salary reduction amounts, which are recorded in the period during which they are deducted from participants' compensation, and employee rollover contributions, which are recorded when they are received by the Plan.

Employer contributions are recorded as of the end of the calendar quarter in which they are earned.

Payment of Benefits

Benefits paid to employees are recorded when paid.

Administrative Expenses

Administrative expenses in the statement of changes in net assets available for benefits consist of fees associated with the issuance of notes receivable from participants and fees for custodian, recordkeeping, advisory and audit services. BJ's Wholesale Club, Inc., bears all other Plan administrative expenses.

Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earning activity and thus are not separately identifiable as a Plan expense.

Risk and Uncertainties

The Plan provides for various investment options in any combination of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through September 15, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, Fidelity Management Trust Company has certified that the following data included in the financial statements and supplemental schedule are complete and accurate:

- Net investment income including interest income on notes receivable as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Investments in collective trusts provide for daily liquidity and have no unfunded commitments, no redemption features, or other restrictions.

NOTE 5 GUARANTEED INVESTMENT CONTRACTS

The Plan has entered into benefit-responsive guaranteed investment contracts with New York Life Insurance Co. (NYLIC). NYLIC maintains the contributions in a stable value account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. NYLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by NYLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract is a traditional investment contract. The contract value of the Plan's investment contract at December 31, 2024 and 2023, was \$32,727 and \$33,587, respectively.

The average yield was 3.35% and 3.01% for 2024 and 2023, respectively. The crediting interest rate was 4.00% and 3.66% at December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, and is accrued daily and credited monthly. The interest crediting rate may be reset not more frequently than daily and not less frequently than quarterly, but may not be less than 0%. The interest crediting rate reflects the book yield on the separate account, adjusted to reflect amortization of any realized gains or losses.

Certain events limit the ability of the Plan to transact at contract value with NYLIC. Such events include the following: 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 6 INCOME TAX STATUS

The Plan is intended to constitute a tax-qualified plan under Section 401(a) of the IRC and as such would be exempt from federal income taxes under provisions of IRC Section 401(a). The Plan obtained an opinion letter in which the IRS stated that the Plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and ERISA. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is not currently under audit with respect to any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are issued or managed by Fidelity Management Trust Company, the trustee of the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

NOTE 8 PLAN TERMINATION

The Company intends to continue the Plan indefinitely but reserves the right to amend or discontinue it, subject to the requirements set forth in ERISA. In the event that the Plan was terminated, all participants would immediately become fully vested in Company contributions credited to their accounts. The assets of the Plan would be allocated among its participants in the order provided for in ERISA.
