The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1 – Description of the Plan**

The following description of The Landings Club, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution pension plan established on January 1, 1998. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all employees of The Landings Club, Inc. (the “Club”) who satisfy certain age and length-of-service requirements. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute a portion of their pre-tax and post-tax compensation, as defined in the Plan document, subject to certain limitations set under the Internal Revenue Code. After-tax Roth contributions may be made to this Plan. Effective January 1, 2021, the Plan was amended/restated and effectively became a Safe Harbor Plan. The Club matches the first 3% of eligible participants’ contributions at 100% and the next 2% of eligible participants’ contributions are matched at 50%.

Participants may also contribute rollover amounts representing distributions from other eligible retirement plans.

Investment options

Each participant may direct the investment of his/her account into certain available investment options offered by the Plan. The assets of the Plan are allocated to the applicable funds at the direction of the participant.

Participant accounts

Each participant’s account is credited with the (a) participant’s contributions, (b) allocations of the Club’s contributions and (c) Plan earnings, net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Effective January 1, 2014, participants are 100% vested in the Club’s Safe Harbor contributions. Prior to January 1, 2014, vesting in the Club’s contribution portion of their accounts was based on years of continuous service. The Club’s contributions were fully vested after three years of credited service.

Participant and Plan loans

Under the terms of the Plan, participants are not permitted to borrow from their accounts.

Forfeitures

As of December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$31,834 and \$23,588, respectively. Forfeitures of non-vested contributions may be used to reduce future Club contributions and/or pay administrative expenses of the Plan as determined by the Plan. For the year ended December 31, 2024, forfeitures totaling \$14,719 were used to reduce employer contributions.

Payment of benefits

On termination of service due to death, disability, retirement, or separation from service, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or periodic payments as further outlined in the Plan document. If a participant terminates employment and the participant's account is less than \$5,000, the Plan Administrator may authorize the benefit payment without the participant's consent. In addition, participants may receive in-service distributions and hardship withdrawals under the provisions of the Plan document and the Internal Revenue Code. Rollover account balances may be withdrawn at any time, provided the rollover contributions have been properly segregated. Minimum required distributions for participants also apply per Internal Revenue Service regulations.

**Note 2 – Summary of significant accounting policies**

Basis of accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except for benefits which are recorded when paid.

Investment valuations and income recognition

The Plan's investments are stated at fair value.

Realized and unrealized gains and losses from the investments in each account are credited to or charged against each account. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Fair value measurements

The Plan reports its investments under the Financial Accounting Standards fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under this standard are as follows:

Level 1 – Unadjusted quoted prices in active markets for identical assets.

Level 2 – Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Registered investment companies (mutual funds)

The Plan’s investments in mutual funds are stated at fair value based on the quoted market prices of the underlying securities within each fund. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price.

Common/collective trust

The value of the common/collective trust is determined at the close of each business day based on the fair value of the respective investments. The value of each account is expressed in “units”. The “unit value” is the dollar value of one unit and is determined at the close of each business day by dividing the total fair value of each account by the total number of units in the account. The value of each participant’s account on any date is determined by multiplying the number of units held by the “unit value” at the close of the business day.

Contributions

Contributions from participants are recorded as they are withheld from the participants’ wages. Contributions from the Club are recorded in the period in which the related participant contributions are earned.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Administrative expenses

Certain general administrative expenses of the Plan are paid by the Club and are not reflected in the accompanying financial statements. Certain other administrative fees and Custodian fees are paid by the Plan and are included in the accompanying financial statements. Investment and related expenses are included in net appreciation of fair value of investments.

Certain administrative functions are performed by officers or employees of the Club. No such officer or employee receives compensation from the Plan.

Risks and uncertainties

The Plan’s investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. The Plan’s investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with mutual funds, common/collective trusts and similar types of investments.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through August 21, 2025, which is the date the financial statements were available to be issued.

**Note 3 – Information certified by the Plan’s Custodian**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Empower Trust Company, LLC, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the supplemental schedule, Schedule H - Part IV - Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note 4 – Plan termination**

Although it has not expressed any intent to do so, the Club has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 5 – Party-in-interest transactions**

Empower Trust Company, LLC is the Custodian as defined by the Plan, and therefore, transactions with the Custodian qualify as party-in-interest. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Club. These transactions also qualify as party-in-interest transactions.

**Note 6 – Tax status**

The Plan obtained a determination letter, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the “Code”). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan was qualified and was tax-exempt as of the financial statement date. Accordingly, the accompanying financial statements do not include a provision for income tax.
