Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Market Street Bancshares, Inc. Employee Stock Ownership Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Plan Description

The following description of the Plan is provided for financial reporting purposes only. Participants of the Plan should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1993, amended and restated April 1, 2024, and is an employee stock ownership plan ("ESOP") designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code ("IRC") as amended, covering all eligible employees of Market Street Bancshares, Inc. (the "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan is administered by the Plan Sponsor.

At December 31, 2024 and 2023, all Plan Sponsor common stock ("Company Stock") is allocated to participants' accounts in accordance with applicable regulations under the IRC.

Eligibility

Employees may become participants following 1,000 hours of service and attaining 18 years of age. Plan entry dates are January 1, April 1, July 1, and October 1. Effective April 2024, employees may become participants following 500 hours of service and attaining 18 years of age. Plan entry dates are the first day of the month following eligibility.

Contributions

Participants may contribute up to 80 percent of pretax, and effective April 1, 2024 aftertax, annual eligible compensation, as defined in the plan document, not to exceed certain dollar limits established by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for a discretionary employer matching contribution with an amount equal to 40 percent of the amount contributed by each participant, up to a maximum of 10 percent of eligible compensation. These contributions may be suspended or discontinued at any time. Participants must be actively employed at the end of the Plan year to receive the employer matching contributions.

The Plan Sponsor may also make an annual discretionary contribution to the Plan. Contributions are allocated to eligible participants' accounts based upon the ratio of the participants' compensation to the total compensation of eligible participants. Employees who have at least 1,000 hours of service and are actively employed on the last working day of a Plan year are generally eligible for an allocation of Plan Sponsor contributions for such year. There were no discretionary contributions for the years ending December 31, 2024 and 2023.

The Plan Sponsor may also make an annual discretionary contribution to each non-highly compensated participant of the Plan. Contributions are allocated to eligible participants' accounts based upon the ratio of the participants' compensation to the total compensation of eligible participants. Employees who have at least 1,000 hours of service and are actively employed on the last working day of a Plan year are generally eligible for an allocation of Plan Sponsor contributions for such year. There were no discretionary contributions for the years ending December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Plan Sponsor's contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant's account is also credited on the last day of each Plan year with an allocation of shares of Company Stock and forfeitures of terminated participants' nonvested accounts. Allocations are based on a participant's compensation, relative to total compensation for all participants. Only those participants who are eligible employees of the Plan Sponsor as of the last day of the Plan year will receive an allocation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance to the total Plan balance at year-end.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company Stock into investments that are more diversified. Participants who are at least 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. A participant who meets these requirements may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In their final participation year, the diversification percentage changes to 50 percent. Participants who elect to diversify may choose to receive a cash distribution or have amounts subject to diversification invested in at least three or more investment funds designated by the Plan Sponsor. The election to diversify is made within 90 days subsequent to year-end based upon the shares of Company Stock in the participant's account at year-end.

Vesting and Forfeitures

Participants are vested immediately in their contributions and the Plan Sponsor discretionary contribution to non-highly compensated employees plus actual earnings thereon. Vesting in the Plan Sponsor's matching and discretionary contribution portion of their account plus earnings is based on years of service, as defined in the plan document, in accordance with the following schedule:

The nonvested balance is forfeited upon termination of service. Participants become fully vested upon death, termination of the Plan, normal retirement age, or total disability.

There were no forfeited nonvested accounts at December 31, 2024 and 2023. These accounts will be used to pay administrative expenses and reduce future employer contributions. For the years ended December 31, 2024 and 2023, \$25,161 and \$15,370, respectively, of administrative expenses and employer contributions were paid from forfeited nonvested accounts.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Participants may borrow from their accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, reduced by the highest outstanding loan balance from the Plan during the prior 12 month period. The loans are secured by the balance in the participant's account and bear interest rates that range from 4.25 to 9.50 percent, which is based on interest rates charged for similar types of loans by other lenders. The loan repayment period is dictated by the plan document based on the original use of the funds. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Prior to separation from service with the Plan Sponsor, a participant may request a distribution of rollover contributions. In the event of a financial hardship, certain participant funds, as defined in the plan document, may be requested for distribution.

Upon attainment of normal retirement age, total disability, or death, the amount credited to a participant's account is payable in a lump sum or installments. Upon termination of employment for reasons other than retirement, total disability, or death, the participant's account balance will be distributed in a manner based on the value of the account. If a separated participant's account does not exceed \$5,000, the benefit will be distributed in a lump sum within a reasonable time after termination of employment. If the participant's account balance exceeds \$5,000, the participant may elect to receive the benefit in a lump sum or installments in accordance with the plan document.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares of Company Stock allocated to his or her account and is notified by the trustees prior to the time that such rights are to be exercised. The trustees are permitted to vote any allocated share for which instructions have not been given by a participant. The trustees are required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the Company Stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is the right to demand that the Plan Sponsor buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock as of the most recent valuation date. The Plan Sponsor can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to convert the stock to cash.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared in accordance with the provisions of the Financial Accounting Standards Board ("FASB"), Accounting Standards Codification (the "FASB ASC"), which is the source of authoritative, non-governmental accounting principles generally accepted in the United States of America ("GAAP"). All references to authoritative accounting guidance contained in our disclosures are based on the general accounting topics within the FASB ASC.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The Plan follows guidance issued by the FASB on fair value measurements, which establishes a framework for measuring fair value, clarifies the definition of fair value within that framework, and expands disclosures about the use of fair value measurements. This guidance applies whenever fair value is the applicable measurement. The three general valuation techniques used to measure fair value are the market approach, cost approach, and income approach.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits the payment of Plan expenses from Plan assets. If the Plan Sponsor does not pay these expenses from its own assets, then the expenses paid using Plan assets will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

3. Information Certified by the Custodian

Other than the fair value and related activity of the Company Stock, information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by Principal Trust Company ("Principal"), the custodian of the Plan.

4. Fair Value Measurements

The framework for measuring fair value establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into Levels 1, 2, and 3. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical instruments in active markets.
Level 2	Inputs to the valuation methodology to include quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the instrument, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The instruments' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for instruments measured at fair value.

Level 1 investments consist of a money market fund and publicly traded mutual funds. The money market fund is derived from quoted prices in active markets for identical assets. Mutual funds are valued at daily closing prices of the funds at year-end.

Level 3 investments consist of Company Stock that is not actively traded and significant other observable inputs are not available. The fair value of the Company Stock is determined by an annual independent appraisal as of December 31. The appraisal is based on the market approach consistent with prior years. The appraisal took into account historical and projected cash flow and net earnings, book value, and applicable discounts and premiums. Plan management accumulates the data for the appraiser from the audited consolidated financial statements of Market Street Bancshares, LLC. The appraiser prepares a preliminary report which Plan management and the trustees review in detail, discuss, and approve.

Investments also consist of collective trust funds that are composed primarily of separate accounts and mutual funds. The collective trust funds are valued at the net asset value ("NAV") of shares of a bank collective trust held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund. Participant transactions (issuances and redemptions) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Sponsor Dividends

The Plan Sponsor paid dividends to the ESOP of \$21.60 per share, or \$306,517 during the year ended December 31, 2024 and \$19.66 per share, or \$277,630 during the year ended December 31, 2023.

6. Related Party and Party-in-Interest Transactions

At December 31, 2024 and 2023, certain Plan investments consist of investments with Principal and Company Stock held by the trust. Principal provides trustee, reporting, and related services to the Plan and, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. Plan Sponsor contributions are held by the trust and managed by the trustees, which invest cash received, interest, and dividend income and make distributions to participants.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. During 2024 and 2023, the Plan Sponsor paid certain administrative and other operating expenses of the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the Plan Sponsor contribution portion of their account.

8. Tax Status of Plan

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated February 20, 2018, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since the date of the determination letter. The Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

In accordance with GAAP, the Plan Sponsor is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021. The Plan is also subject to routine audits by the Department of Labor, generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.

9. Risks and Uncertainties

The Plan investments consist of various investment securities including Company Stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investments and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
