To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Torcon, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules ("DOL") and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan:

The following description of the Torcon, Inc. (the “Company” and “Plan Sponsor”) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Retirement Plan Agreement for a more complete description of the Plan’s provisions.

The Plan consists of the following two segments:

1) **A defined contribution profit sharing plan** which covers all full-time employees of the Company who have completed six months of service and have attained the age of 21, except for those employees that are included in collective bargaining agreements.

a) **Contributions** - Each year, the Company may elect to contribute out of net profits and/or accumulated earnings, an amount determined by the Board of Directors of the Company. All contributions to the Plan are invested at the direction of the Plan participants in any of the investment options offered by the Plan. There were discretionary contributions for the years ended December 31, 2024 and 2023 in the amount of \$1,106,017 and \$1,070,844, respectively. Discretionary contributions for the years ending December 31, 2024 and 2023 are net of forfeitures totaling \$61,392 and \$37,187, respectively.

b) **Participant Accounts** - Each participant’s account is credited with (a) the Company’s contribution, if any, (b) participant’s Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

c) **Vesting** - Vesting in the Company’s contribution portion of their accounts plus earnings thereon is based on years of continuous service and is as follows:

<u>Years of Services</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

d) **Payment of Benefits** - Upon termination of service or retirement, a participant may elect (with consent of spouse) to receive either a lump-sum amount equal to the value of their account, or qualified joint and survivor annuity payments. If death occurs prior to retirement, the participant’s account is paid to the designated beneficiaries.

2) **A voluntary contributory savings program** which is subject to the provisions of the Internal Revenue Code (IRC). All full-time employees that have attained the age of 21 are eligible to participate immediately upon hire, except for those employees included in collective bargaining agreements.

NOTES TO FINANCIAL STATEMENTS

- a) **Contributions** - Eligible participants may elect to contribute from 1% to 80% of their compensation to the Plan, subject to the IRC limitations for 401(k) plans and as adjusted for defined contribution plan amounts contributed on the participant's behalf. All contributions to the Plan are invested at the direction of the Plan participants in any of the investment options offered by the Plan. The Company did not match any employee contributions in 2024 and 2023.
- b) **Automatic Enrollment** - All employees meeting the eligibility and service requirement noted above, are automatically enrolled in the Plan effective January 1, 2017. Employees are deemed to have elected a pre-tax contribution of 4% of their Plan compensation in the absence of an affirmative election to the contrary, with an annual 1% contribution increase until the Plan's maximum automatic deferral percentage of 8% is reached. Employees have the right at any time to elect not to make any salary deferral contributions to the Plan, or to elect to have such contributions made at a different percentage from the Plan's default automatic deferral percentage.
- c) **Participant Accounts** - Each participant's account is credited with the participant's voluntary contribution and allocation of (a) the Company's matching contribution, if any, (b) participant's Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d) **Vesting** - All of the participants' contributions made to the Plan are fully vested at all times and are not subject to forfeiture for any reason. Participants are vested in employer matching contributions and the investment earnings thereon, based on years of service as follows:

<u>Years of Services</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

- e) **Payment of Benefits** - Upon termination of service or retirement, a participant may elect (with consent of spouse) to receive either a lump-sum amount equal to the value of their account, or qualified joint and survivor annuity payments. If death occurs prior to retirement, the participant's account is paid to the designated beneficiaries.

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan's assets were held by State Street Bank and Trust Company from January 1, 2023 through December 31, 2023, and are held by State Street Bank and Trust Company and Transamerica Life Insurance Company (the "Trustees") as of December 31, 2024 and from January 1, 2024 through December 31, 2024. The Trustees are responsible for the custody and management of the Plan's assets.

Insurance Premiums - Life insurance may be purchased on the life of a participant. The amount of life insurance that may be purchased is limited to what the law permits. Any life insurance purchased will be used to provide a death benefit for the participant's beneficiaries. Amounts paid for premiums and included in benefits paid to participants was \$976 for the 2024 and 2023 Plan years.

NOTES TO FINANCIAL STATEMENTS

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Investment contracts held by defined contribution plans are required to be reported at fair value, except for fully benefit-responsive investment contracts which are recorded at contract value. Contract value is the relevant measure for the portion of the assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Common Collective Trust - The Plan invests in investment contracts through its common collective trusts (the "CCT"). The CCT's fair value is a relevant measurement attribute.

The CCT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective the fund invests primarily in insurance contracts and corporate and government agency bonds. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a one-year redemption notice period which may be waived by the trustee. There are no unfunded commitments at December 31, 2023. The Plan did not hold any CCTs as of December 31, 2024.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and Uncertainties - Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Contributions - Participant contributions are made through voluntary payroll deductions elected by each participant with each pay period.

Forfeitures - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are used to reduce expenses or the Company's contributions to the Plan. Forfeited non-vested accounts totaled \$72,847 and \$29,358, at December 31, 2024 and 2023, respectively. Forfeitures incurred were \$79,541 and \$28,679 for 2024 and 2023, respectively. Forfeitures totaling \$61,392 and \$37,187 were utilized by reducing Plan employer contributions funded subsequent to each of the plan years ending December 31, 2024 and 2023, respectively.

Payment of Benefits - Benefits are recorded when paid.

Hardship Withdrawals - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, burial or funeral expenses for a deceased parent, spouse, child, and repair of damage to principal residence that qualifies for the casualty loss deduction in accordance with Internal Revenue Service (IRS) rules and regulations.

Concentration of Investment Risk - The Plan's investment in three and four funds comprises approximately 47% and 57% of total investments at December 31, 2024 and 2023, respectively.

Subsequent Events - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through September 16, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Certified Investment Information:

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustees, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements FASB ASC 820, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual Funds*: Valued at the closing price in the active market in which the fund is traded.

- *Common Collective Trust:* Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the Trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

Note 5 - Group Annuity Contract with Insurance Company:

The Plan invests in a fully benefit-responsive group annuity contract with Transamerica Life Insurance Company (“Transamerica”) at December 31, 2024 which maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The contract permits either party to suspend the agreement under certain conditions.

As described in Note 2, because the contract is fully-benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value is the relevant measure for the fully-benefit responsive group annuity contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represent contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The average yield based on interest credited to participants was 5.00% for 2024. The contract value of the group annuity contract was \$9,368,996 at December 31, 2024. The Plan did not have a group annuity contract as of December 31, 2023. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with the group annuity contract is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan’s failure to qualify under Section 401(a) of the IRC or the failure of the Trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan’s prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events that allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan’s investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

Note 6 - Tax Status:

The Plan was written on an IRS non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' contributions remain fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 8 - Parties-In-Interest:

The Trustees of the Plan's assets holds the Plan's investments, which include various mutual funds. No fees were paid to the Trustees by the Plan for the year ended December 31, 2024 and 2023. The Plan Sponsor and Merrill Lynch Wealth Management ("Merrill") have a service based pricing agreement in which the investment related revenue received by Merrill from the Plan's mutual funds will be applied towards Merrill's fees and any excess will be remitted to the Plan and used to pay Plan administrative expenses and/or allocate amounts to Plan participants. During 2024 and 2023, the investment related revenue paid to Merrill by the Plan's mutual funds and applied to Merrill's fees were \$110,000 and is recorded in net appreciation on the statements of changes in net assets available for benefits.

During 2024 and 2023, the Plan incurred fees of \$93,084 and \$151,045, respectively, from the excess related revenue derived from the service-based pricing agreement with Merrill. During December 31, 2024 and 2023, the investment related revenue applied to fees and netted in net appreciation on the statements of changes in net assets available for benefits was \$203,084 and \$261,045, respectively.

Transamerica Retirement Solutions ("TRS") is the recordkeeper and provides administrative services to the Plan and, therefore, these transactions qualify as a party-in-interest. The fees paid by the Plan to TRS were \$8,826 and \$6,669 for the years ended December 31, 2024 and 2023, respectively.

Note 9 - Notes Receivable from Participants:

Participants may borrow between the minimum of \$1,000 up to the lesser of \$50,000 or 50% of their respective vested account balances and may only have one loan outstanding at a given time. The loans are secured by the balance in the participants' account and bear interest at the prevailing prime rate plus 1% on the origination date of the loan. Principal and interest is generally repayable through payroll deductions within five years, unless the loan provides funding for the purchase of the participant's principal residence in which case it is payable over twenty years.
