The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

A. Description of Plan:

The following description of the Digestive Health Clinic, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** - The Digestive Health Clinic, LLC 401(k) Profit Sharing Plan (the "Plan") is a defined contribution retirement plan sponsored by Digestive Health Clinic, LLC (the "Company/Plan Sponsor"). In addition to the Plan Sponsor, this Plan is also maintained by the following Participating Employers:

The Plan was originally effective on August 1, 1980, and was most recently restated effective January 1, 2022, to comply with current regulatory requirements and reflect updates to plan provisions. The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code (IRC) and includes both a 401(k) salary deferral feature and a profit-sharing component. The Plan operates on a calendar-year basis, with the plan year ending on December 31, 2024. Participation in the Plan is available to employees who have attained age 21 and completed six months of service, as defined in Section 2.03(a)(I) of the Plan and Administrative Appendix §4-3. Compensation for plan purposes is defined in accordance with IRC Section 415. Eligible participants may contribute to the Plan through elective deferrals. The Plan also provides for employer matching and discretionary profit-sharing contributions.

2. **Contributions** - The Digestive Health Clinic, LLC 401(k) Profit Sharing Plan (the "Plan") allows for both employee and employer contributions, as outlined in the Plan document. Eligible participants may contribute pre-tax and Roth elective deferrals through payroll deductions. Roth deferrals are permitted under the Plan and are subject to the same eligibility and contribution limits as traditional deferrals under applicable IRS regulations. The Employer is authorized to make discretionary matching and profit-sharing contributions. The amount of these contributions, if any, is determined solely at the discretion of the Employer on an annual basis. Matching contributions, if made, are allocated as a uniform percentage of eligible employee deferrals, subject to limits determined by the Employer and applied uniformly across all eligible participants. Matching contributions are determined on a payroll-period basis, with true-up provisions addressed in accordance with Administrative Appendix §6B-5. The Plan is not intended to be a Safe Harbor 401(k) Plan, and no special contributions are permitted under its provisions. Employer profit sharing contributions are also discretionary and allocated based on employee group classification, as defined in the Plan. All contributions are subject to a six-year graded vesting schedule. Participants reach normal retirement age under the Plan at age 50, at which point they become fully vested in their account balances regardless of years of service. All contributions are based on Code §415 compensation and administered in compliance with the Internal Revenue Code and ERISA requirements.
3. **Participant Accounts** – Participants may elect to contribute to the Plan as a reduction of their wages. Each Participant's account is credited with an allocation of the Company's contributions and Plan earnings. Allocations are based on Participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. **Vesting** – Participants in the Digestive Health Clinic, LLC 401(k) Profit Sharing Plan (the “Plan”) vest in employer contributions according to a six-year graded vesting schedule. Under this schedule, a participant’s vested percentage increases based on years of vesting service, reaching 100% after six years of eligible service. For purposes of vesting, service completed prior to an employee’s 18th birthday is excluded and does not count toward the calculation of vesting service. Participants become fully vested in their employer contributions upon reaching the Plan’s normal retirement age, or if their employment terminates due to death or becoming disabled, as defined under the Plan. Employee contributions, including elective deferrals and Roth deferrals, are always fully vested and nonforfeitable.
5. **Payment of Benefits** – Upon termination of service, death, disability, or retirement, the participant may receive the value of the vested interest in his or her account in the form of a lump sum distribution or installment payments. The Plan allows for distribution in-service if a participant reaches age 59½. If a participant terminates employment and the participant’s account balance does not exceed \$7,000, the Plan administrator will authorize the benefit payment without the participant’s consent.
6. **Forfeited Accounts** – Under the provisions of the Digestive Health Clinic, LLC 401(k) Profit Sharing Plan (the Plan), non-vested portions of employer contributions are forfeited when a participant terminates employment and is not entitled to a full vesting in their account. Forfeited amounts are held in a separate forfeiture account and may be used, at the discretion of the Employer, for any of the following purposes: (i) to pay reasonable and allowable administrative expenses of the Plan; (ii) to reduce future employer contributions; (iii) to be added to or reallocated among other employer contributions; or (iv) to offset employer contributions while also being added back into overall employer contribution allocations, in accordance with Plan provisions. The treatment of forfeitures is carried out in compliance with applicable IRS and ERISA regulations, and the specific application of forfeited funds is determined annually by the Employer.

Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$79,244 and \$25,564, respectively. In 2024, the employer contribution receivable was reduced by \$79,244 from forfeited nonvested accounts.

B. Summary of Significant Accounting Policies:

The following are the significant accounting policies followed by the Plan:

1. **Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.
2. **Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

4. **Payments of Benefits** – Benefits are recorded when paid.
5. **Related Party Transactions** – Certain administrative expenses are paid by the Plan sponsor.
6. **Contributions** – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year which the employee contributions are withheld from compensation.

7. **Expenses** –The Plan’s expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, that are paid by the Plan, are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.
8. **Subsequent Events** – The Plan has performed an evaluation of subsequent events through September 11, 2025, which is the date the financial statements were available to be issued.

C. Plan Termination:

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

D. Tax Status of Plan:

The Plan uses a pre-approved Plan document sponsored by Pinnacle Pension Services, Inc., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received an opinion letter from the IRS; however, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirement of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

E. Information prepared and certified by Custodian:

The following information included in the accompanying financial statements and the information used to complete the supplemental schedule, Schedule H, Line 4i, Form 5500, was obtained from data that was prepared or derived from, and certified to be complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodian as of and for the year ended December 31, 2024:

F. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

G. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuities: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

H. Reconciliation of Financial Statements to Form 5500:

There were no reconciling items between the financial statements and the amounts reflected in form 5500 as of December 31, 2024 and 2023.

I. Concentration of Credit Risk:

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash and short-term investments and marketable securities. The amount of exposure to any one specific investment has been limited by investing in mutual funds that use a diverse investment portfolio to limit risk.

J. SECURE 2.0:

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Many of the provisions have different effective dates, with some changes impacting 2023, 2024, 2025 and beyond. Plan documents are required to be formally amended for mandatory and any nonmandatory provisions adopted on or before the last day of the 2025 plan year. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
