Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the SYB Construction Co., Inc. 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

SYB Construction Co., Inc. 401(k) Plan and Trust was established on October 1, 1997. The Plan is a defined contribution plan covering all employees of SYB Construction Company, Inc. (the "Company") and related employers, B & B Erosion Control, LLC and Performance Paver Systems, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as well as all applicable provisions of the federal income tax laws.

The Plan is under the administration of a trustee and a plan administrator who are appointed by the Company. Ascensus Trust Company ("Trustee") is the trustee and custodian of the Plan and Ascensus, LLC. ("Ascensus"), Trustee's parent company, serves as the third-party administrator and recordkeeper for the Plan. The Plan has an investment advisory agreement with ISC Advisors, Inc. ("Investment Advisor") to provide discretionary investment advice to the Plan about asset classes and investment alternatives available for the Plan in accordance with the Plan's investment policies and objectives. The Plan has the final decision-making authority regarding the initial selection, retention, removal and addition of investment options.

Eligibility and Enrollment

On the date of hire, an employee is immediately eligible to participate in the Plan. There are no age or service requirements that must be satisfied by the employee.

Contributions

Participants may make tax-deferred contributions and Roth contributions to the Plan. Contributions are subject to certain regulatory limitations of the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company made safe harbor matching contributions based on the amount the participant contributed during the year. The Company matches 100% of the first 3% of compensation subject to tax-deferred and Roth contributions and 50% of the next 4% to 5% of compensation.

The Company can make discretionary profit-sharing contributions but is not required to do so. The Company did not make any discretionary profit-sharing contributions to the Plan in 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings (losses), and charged with an allocation of any administrative expenses not paid by the Company. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct the contributions made to the Plan to any one or more of the investment funds provided by the custodian of the Plan's assets. A participant may at any time change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching contribution and earnings thereon are 100% vested and nonforfeitable at all times.

Vesting in the Company's discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service under the 401(k) provisions of the Plan, and the participant is 100% vested after six years of credited service.

Payment of Benefits

On termination of service, a participant has the option of receiving a distribution equal to the value of his or her vested account as specified in the Plan. If a terminated participant has a balance of \$1,000 or greater in the Plan, the terminated participant may defer distribution of his or her vested account.

Forfeited Accounts

As of December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$12 and \$0, respectively. The forfeited nonvested accounts are used to pay administrative expenses of the Plan or to reduce future company contributions. During 2024, the Plan used forfeited nonvested accounts of \$51 to reduce administrative expenses of the Plan.

Participant Loans

The Plan allows participants to borrow from their vested account balances. The minimum amount of any loan is \$1,000. The loan cannot exceed the lower of \$50,000 or 50% of their vested account balance. The loan, in the form of promissory note, is secured by the balances in the participant's account, and bear interest at the prime rate as specified in the Wall Street Journal. Only one loan may be outstanding at any one time. Principal and interest on notes receivable from participants are repaid through payroll deductions over a term not to exceed five years.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America. Accordingly, contributions and investment income (loss) are recognized when earned rather than when received, and administrative expenses are recognized when incurred rather than when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of investment income and expenses during the reporting period. Actual results could differ from those estimates.

Contributions

Participant contributions and related Company safe harbor matching contributions are accrued in the period in which the participant contributions are deducted from the participants' pay. Rollover contributions are recorded when received.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income is recorded when earned. Realized gains and losses on investments are based on the specific identification method. Unrealized gains and losses are recorded for the change in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus accrued but unpaid interest. A delinquent participant loan is reclassified as a distribution based on the terms of the Plan document. The Plan recognizes interest income from the notes receivable as earned.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - FAIR VALUE MEASUREMENTS OF INVESTMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting standard establishes a fair value hierarchy that prioritizes the inputs and valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, the

Plan used Level 1 inputs only. Level 1 assets include investments in mutual funds that are based on the closing price reported in active markets where the individual securities are traded. Level 2 and level 3 inputs have not been used. The categorization of an investment within the hierarchy is based on the pricing transparency of the investment and does not necessarily correspond to the Plan's perceived risk of that investment.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 5 - FEDERAL INCOME TAX STATUS

The Plan is a Non-Standardized Pre-Approved Profit Sharing Plan ("Non-Standardized Plan") and was submitted by Ascensus to the Internal Revenue Service ("IRS") for a determination as to whether the Non-Standardized Plan meets the qualification requirements under Internal Revenue Code (IRC) Section 401. The IRS issued an opinion letter dated June 30, 2020, stating that the Non-Standardized Plan is acceptable for use by employers for the benefit of their employees under IRC Section 401. The Plan and the related non-standard adoption agreement have been amended and restated since receiving the opinion letter. However, Ascensus and the plan administrator believe that the Plan is designed and is being operated within the terms of the Non-Standardized Plan and the related non-standard adoption agreement and is in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by the IRS. The Company and plan management believe the Plan is no longer subject to income tax examinations for years prior to 2021. The Plan has evaluated all current and prior year tax positions and has determined there are no uncertain tax positions that require recognition and disclosure in the financial statements.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various mutual funds. Investments in mutual funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in the values of securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company may, but is not required to, pay all of the Plan fees and administrative expenses. Those fees or expenses not paid by the Company are paid from the Plan's funds. For the year ended December 31, 2024, certain participants of the Plan paid loan and distribution processing fees of \$2,711 to the Trustee.

It is the philosophy of the Company to absorb certain expenses such as audit fees and other administrative functions so as not to decrease the Plan assets. Any fee or expense paid, directly or indirectly, by the Company is not considered a contribution to the Plan, provided the fee or the expense relates to the ordinary and necessary administration of the Plan. For the year ended December 31, 2024, the Company paid various Plan administration expenses of \$39,412 on behalf of the Plan.

Officers and employees of the Company performed certain administrative functions for the Plan during 2024 and 2023. However, the officers or employees did not receive any compensation from the Plan.

NOTE 8 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

For the years ended December 31, 2024 and 2023, the Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the audit did not extend to the information certified by Ascensus Trust Company, the trustee of the Plan, for the years ended December 31, 2024 and 2023, except for obtaining and reading the certification and comparing the certified investment information with the related information included in the accompanying financial statements and supplemental schedule. The following information was obtained from data that has been prepared and certified to as complete and accurate by Ascensus Trust Company, trustee of the Plan, as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

NOTE 9 - SUBSEQUENT EVENTS

The Plan evaluates events occurring subsequent to the end of the Plan year to determine whether they require recognition, disclosure or both in the financial statements. Events that provide additional evidence about conditions that existed at the balance sheet date are recognized in the financial statements during the current period presented. Nonrecognized subsequent events are events that provide evidence about conditions that arose after the balance sheet date but are not recognized in the financial statements. Both types of subsequent events require disclosure in the financial statements if nondisclosure of such events causes the financial statements to be misleading. The Plan has evaluated subsequent events through August 21, 2025. The financial statements were available for distribution on August 21, 2025.

As of March 15, 2025, the Company amended the distribution provisions of the Plan to increase the distribution cashout level for terminated participants with account balances from \$1,000 to \$5,000 and elected to process distributions under the automated processing and rollover services provided by Ascensus.
