## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
Gardner Business Media, Inc. Employees' Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Gardner Business Media, Inc. Employees' Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gardner Business Media, Inc. Employees' Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Gardner Business Media, Inc. Employees' Savings Plan and to meet our other ethical

responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Basis of Accounting***

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Gardner Business Media, Inc. ## Notes to Financial Statements

### Note 1. Description of Plan

The following description of Gardner Business Media, Inc. Employees' Savings Plan provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

**General.** The Gardner Business Media, Inc. Employees' Savings Plan was established January 1, 1985. The Plan is a defined contribution plan covering employees of the Company who have one month of service, as defined, and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Each year, participants may contribute up to 75 percent of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan provides for the automatic enrollment of eligible participants at a deferral rate of 6% of eligible compensation, unless the participant affirmatively elects otherwise. Participants are allowed to designate all or a portion of their contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty mutual funds as investment options for participants. Profit sharing and matching contribution amounts may be contributed at the discretion of the Board of Directors of Gardner Business Media, Inc. Contributions are subject to certain IRS limitations.

**Participant Accounts.** Each participant's account is credited with the participant's contribution, the Company's matching contribution and allocation of the Company's discretionary profit sharing contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are immediately vested in their salary reduction contributions and Company matching contribution plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service or upon attainment of retirement age.

**Payment of Benefits.** The Plan provides benefits to participants for normal retirement, for disability retirement, for death before retirement, and for severance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The benefits, at the election of the recipient, may be paid in installments for a period not to exceed the life expectancy of the participant or the joint life expectancy of the participant and his beneficiary, or in a lump sum. The Plan also allows for in-service distributions to those participants who have reached age 59½.

**Notes Receivable from Participants.** Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years or a reasonable term in excess of five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate 1% over the prime rate. Interest rates range from 4.25 percent to 9.50 percent. Principal and interest are paid ratably through payroll deductions.

**Forfeited Accounts.** Participant account forfeitures are used to reduce employer contributions. During the Plan year ended December 31, 2024, \$0 of forfeitures were used to reduce the employer contribution. At December 31, 2024, there was \$1 of forfeitures available to pay future employer contributions.

### **Note 2. Summary of Significant Accounting Policies**

#### **Basis of Accounting:**

The financial statements of the Plan are presented on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Contributions are recorded as received. Distributions and expenses are recorded when paid. Purchases and sales of securities are recorded on a trade-date basis.

#### **Investment Valuation and Income Recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered investment companies are valued at the quoted market prices, which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Dividends and interest received by the Plan are reinvested into the respective funds. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### **Use of Estimates:**

The preparation of financial statements requires management to make certain estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Payment of Benefits:**

Benefits are recorded when paid.

#### **Administrative Expenses:**

Most administrative expenses, including trustee, recordkeeping, and investment advisory fees, are allocated to participants. The Company provides certain services at no cost to the Plan, including, but not limited to, the annual audit fee. Plan loan initiation fees and other expenses related to certain transactions and services are charged directly to participants who incur them rather than to the Plan as a whole.

#### **Subsequent Events:**

The Plan has evaluated the impact of events that have occurred subsequent to December 31, 2024, through September 22, 2025, the financial statement date, for purposes of recognition and disclosure in the financial statements.

#### **Risk and Uncertainties:**

The Plan invests in various securities and mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the financial statements.

### Note 4. Fair Value Measurements

FASB ASC 820 establishes a framework for measuring fair value. This framework provides a fair value hierarchy based upon the observability of inputs used in valuation techniques. Observable inputs (highest level) reflect market data obtained from independent sources, which unobservable inputs (lowest level) reflect internally-development market assumptions. In accordance with this guidance, fair value measurements are categorized under the following three levels:

- Level 1 – Quoted prices in active markets for identical assets or liabilities.
- Level 2 – Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable.
- Level 3 – Unobservable inputs that are not corroborated by market data; model-derived valuations in which one or more significant inputs are unobservable.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that trade in active markets and produce a daily net asset value (NAV).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Tax Status**

The Plan's operating document is derived from a volume submitter plan provided by the Plan's administrator, Fidelity Management Trust Company. In a letter dated June 30, 2020, the Internal Revenue Service has issued a favorable opinion of the volume submitter plan with regard to its acceptability under section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Board of Directors of Gardner Business Media, Inc. may terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, each participant's account becomes fully vested and is to be distributed in accordance with the provisions of the Plan.

### **Note 7. Related Party and Party-In-Interest Transactions**

#### **Administration of Plan Assets:**

Officers and/or employees of the Company perform certain administrative functions. No such officer or employee receives compensation from the Plan, nor does the Company allocate any costs to the Plan.

#### **Plan Investments:**

The Plan engages in certain transactions involving Fidelity Management Trust Company (Fidelity), the Trustee, which is a party-in-interest under the provisions of ERISA. These transactions involve investment of Plan monies in money market and mutual funds managed by Fidelity. These transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan engages in certain transactions involving UBS Financial Services, the investment advisor, which is a party-in-interest under the provisions of ERISA. These transactions involve compensating UBS for plan investment advisory services and are permitted under the provisions of the plan and under ERISA.
