Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the accompanying financial statements of C&K Industrial Services, Inc. 401(k) Plan Employee Benefit Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the C&K Industrial Services, Inc. 401(k) Plan (the "Plan") established July 1, 1995, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan allows related companies (related through common ownership of its shareholders or members) to adopt its provisions. Other related companies who have adopted the provisions of the Plan are Karas Enterprises, Inc., JWD Properties and Ecopro Solutions, C&K Southern Services, Inc, and Recyclable LLC.

General

The Plan is a participant-directed defined contribution plan covering all full-time employees of C&K Industrial Services, Inc. (the "Plan Sponsor") and the other related companies listed above who have adopted the provisions of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

An employee may elect to defer a minimum of 1% of pre-tax annual compensation as defined by the Plan with a maximum established by Internal Revenue Service ("IRS") of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. An additional \$7,500 may be deferred by participants age 50 or greater for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan Sponsor, at its discretion, may elect to contribute to the Plan under a deferral matching formula and under annual profit-sharing provisions. For the years ended December 31, 2024 and 2023, the Plan Sponsor matched 50% of the first 5% of employee elective deferrals. The Plan Sponsor did not elect to make an annual discretionary contribution for the years ended December 31, 2024 and 2023.

Participant Accounts

The allocation of a participant's contributions to the investment funds is selected by the participant and may be changed daily. Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Notes bear interest at the prime interest rate in effect as of the first day of the month that the loan was requested per year.

Principal and interest payments are made through payroll withholding according to each note's term per the promissory note. Note terms range from one to five years, or up to thirty years for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Accounts of terminated participants with balances under \$5,000 will automatically be rolled over to an IRA.

In the event of financial hardship, participants may apply to receive a distribution from their fund accounts, subject to IRS mandated rules for hardship withdrawals.

Forfeitures

Forfeitures of \$8,654 and \$2,634 were deposited in the uninvested cash balances of the Plan during the years ended December 31, 2024, respectively, which may be used to restore participant forfeitures, pay Plan expenses, or reduce future employer contributions. The Plan elected to apply these forfeitures to reduce matching contributions for both years.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed. Participants can have no more than five outstanding loans at one time and are able to take out no more than two loans in one calendar year.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value at December 31, 2024 and 2023.

The Plan entered into a stable value fund ("Fund") with the Custodian. The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments. The Fund seeks to achieve this objective by investment in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The net asset value ("NAV") of the Fund represents fair value since this is the value at which the Plan transacts with the Fund. NAV of the Fund, as reported to the Plan by the Custodian, represents contributions made under the underlying investment contracts, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Fund at NAV.

Investment income consists of interest income. The net appreciation (depreciation) in the fair value of investments consists of realized gains or losses and any unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported based on historical cost.

Fair Value of Financial Instruments

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect these estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is as least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

The Plan pays expenses incurred in the administration of the Plan, unless otherwise paid by the Plan Sponsor.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan files the United States Federal Form 5500 annually.

Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, which was prepared by John Hancock Life Insurance Company (U.S.A.) The Plan Administrator obtained a certification from the Custodian as of and for the years ended December 31, 2024 and 2023 that such information is complete and accurate.

NOTE 4 - INVESTMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Pooled separate accounts: Valued at the accumulation unit value of shares held by the Plan at year end.
- Collective investment trust: Valued at the net asset value of the underlying investment contracts as a practical expedient, which represents the value at which the Plan transacts.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments in the collective investment trust may be redeemed on a daily basis and have a daily redemption notice period. There are no unfunded commitments related to this collective investment trust.

NOTE 5 - TAX STATUS

The Plan Sponsor adopted a Prototype Non-Standardized Profit-Sharing Plan ("Prototype Plan") on October 25, 2012. The Prototype Plan obtained its latest determination letter on March 31, 2014, in which the IRS stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Prototype Plan has been amended; however, the Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate insurance company accounts managed by the Custodian and, therefore, these transactions are party-in-interest transactions. Fees paid by the Plan for the investment management and administrative services amounted to \$51,734 and \$59,226 for the years ended December 31, 2024 and 2023, respectively. There are also indirect fees deducted directly from investment earnings of the Plan.
